

TIPS VENDOR AGREEMENT

TIPS RFP 230105 Technology Solutions, Products, and Services

The following Vendor Agreement (“Agreement”) creates a legal agreement between The Interlocal Purchasing System (“TIPS”), a government purchasing cooperative and Department of Texas Region 8 Education Service Center and (INSERT ENTITY NAME):

(ENTER ENTITY NAME)

its owners, agents, subsidiaries, and affiliates (together, “Vendor”) (individually, “Party”, and collectively the “Parties”) and this agreement shall exclusively govern the contractual relationship (“Agreement”) between the Parties.

TIPS, a governmental entity and a national purchasing cooperative seeks to provide a valuable and necessary solution to public entities and qualifying non-profits by performing the public procurement solicitation process and awarding compliant contracts to qualified vendors. Then, where the law of a customer’s jurisdiction allows, instead of public entities and qualifying non-profits expending time, money, and resources on the extensive public procurement process, the use of TIPS allows public entities to quickly select and purchase their preferred products or services from qualified, competitively evaluated vendors through cooperative purchasing.

1. **Purpose.** The purpose of this Agreement is to identify the terms and conditions of the relationship between TIPS and Vendor. Public entities and qualifying non-profits that properly join or utilize TIPS (“TIPS Members”) may elect to “piggyback” off of TIPS’ procurements and agreements where the laws of their jurisdiction allow. TIPS Members are not contractual parties to this Agreement although terms and conditions of this Agreement may ensure benefits to TIPS Members.
2. **Authority.** The Parties agree that the signatories below are individual authorized to enter into this Agreement on behalf of their entity and that they are acting under due and proper authority under applicable law.
3. **Definitions.**
 - a. **TIPS Pricing:** The specific pricing, discounts, and other pricing terms and incentives which Vendor submitted and TIPS approved for each respective TIPS Contract awarded to Vendor and all permissible, subsequent pricing updates submitted by Vendor and accepted by TIPS, if any.
 - b. **Authorized Reseller:** A reseller or dealer authorized and added by a Vendor through their online TIPS Vendor Portal to make TIPS sales according to the terms and conditions herein.
4. **Entire Agreement.** This Agreement resulted from TIPS posting a “TIPS Solicitation” (RFP, RCSP, RFQ, or other) and Vendor submitting a proposal in response to that posted TIPS Solicitation for evaluation and award. The Parties agree that this Agreement consists of the provisions set forth herein and: (1) The TIPS solicitation document resulting in this Agreement; (2) Any addenda or clarifications issued in relation to the TIPS solicitation; (3) All solicitation information provided to Vendor by TIPS through the TIPS eBid System; (3) Vendor’s entire proposal response to the TIPS solicitation including all accepted required attachments, acknowledged notices and certifications, accepted negotiated terms, pricing, accepted responses to questions, and accepted written clarifications of Vendor’s proposal, and; any properly included attachments to this Agreement. All documentation and information listed is hereby incorporated by reference as if set forth herein verbatim. In the event of conflict between the terms herein and one of the incorporated documents the terms and conditions herein shall control.
5. **Vendor’s Specific Warranties, Terms, and License Agreements.** Because TIPS serves public entities and non-profits throughout the nation all of which are subject to specific laws and policies of their jurisdiction, as a matter of standard practice, TIPS does not typically accept a Vendor’s specific “Sale Terms” (warranties, license agreements, master agreements, terms and conditions, etc.) on behalf of all TIPS Members. TIPS may permit Vendor to attach those to this Agreement to display to interested customers what terms may apply to their Supplemental Agreement with Vendor (if submitted by Vendor for that purpose). However, unless this term of the Agreement is negotiated and modified to state otherwise, those specific Sale Terms are not accepted by TIPS on behalf of all TIPS Members and each Member may choose whether to accept, negotiate, or reject those specific Sale Terms, which must be reflected in a separate agreement between Vendor and the Member in order to be effective.

- 6. Vendor Identity and Contact Information.** It is Vendor's sole responsibility to ensure that all identifying vendor information (name, EIN, d/b/a's, etc.) and contact information is updated and current at all times within the TIPS eBid System and the TIPS Vendor Portal. It is Vendor's sole responsibility to confirm that all e-correspondence issued from tips-usa.com, ionwave.net, and tipsconstruction.com to Vendor's contacts are received and are not blocked by firewall or other technology security. Failure to permit receipt of correspondence from these domains and failure to keep vendor identity and contact information current at all times during the life of the contract may cause loss of TIPS Sales, accumulating TIPS fees, missed rebid opportunities, lapse of TIPS Contract(s), and unnecessary collection or legal actions against Vendor. It is no defense to any of the foregoing or any breach of this Agreement that Vendor was not receiving TIPS' electronic communications issued by TIPS to Vendor's listed contacts.
- 7. Initiation of TIPS Sales.** When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Once verified, Vendor must include the TIPS Contract Number on all purchase communications and sales documents exchanged with the TIPS Member.
- 8. TIPS Sales and Supplemental Agreements.** The terms of the specific TIPS order, including but not limited to: shipping, freight, insurance, delivery, fees, bonding, cost, delivery expectations and location, returns, refunds, terms, conditions, cancellations, order assistance, etc., shall be controlled by the purchase agreement (Purchase Order, Contract, Invoice, etc.) (hereinafter "Supplemental Agreement") entered into between the TIPS Member Customer and Vendor only. TIPS is not a party to any Supplemental Agreement. All Supplemental Agreements shall include Vendor's Name, as known to TIPS, and TIPS Contract Name and Number. Vendor accepts and understands that TIPS is not a legal party to TIPS Sales and Vendor is solely responsible for identifying fraud, mistakes, unacceptable terms, or misrepresentations for the specific order prior to accepting. Vendor agrees that any order issued from a customer to Vendor, even when processed through TIPS, constitutes a legal contract between the customer and Vendor only. When Vendor accepts or fulfills an order, even when processed through TIPS, Vendor is representing that Vendor has carefully reviewed the order for legality, authenticity, and accuracy and TIPS shall not be liable or responsible for the same. In the event of a conflict between the terms of this TIPS Vendor Agreement and those contained in any Supplemental Agreement, the provisions set forth herein shall control unless otherwise agreed to and authorized by the Parties in writing within the Supplemental Agreement.
- 9. Right of Refusal.** Vendor has the right not to sell to a TIPS Member under the awarded agreement at Vendor's discretion unless otherwise required by law.
- 10. Reporting TIPS Sales.** Vendor must report all TIPS Sales to TIPS. If a TIPS sale is initiated by Vendor receiving a TIPS Member's purchase order from TIPS directly, Vendor may consider that specific TIPS Sale reported. Otherwise, with the exception of TIPS Automated Vendors, who have signed an exclusive agreement with TIPS regarding reporting, all TIPS Sales must be reported to TIPS by either: (1) Emailing the purchase order or similar purchase document (with Vendor's Name, as known to TIPS, and the TIPS Contract Name and Number included) to TIPS at tipspo@tips-usa.com with "Confirmation Only" in the subject line of the email within three business days of Vendor's acceptance of the order, or; (2) Within 3 business days of the order being accepted by Vendor, Vendor must login to the TIPS Vendor Portal and successfully self-report all necessary sale information within the Vendor Portal and confirm that it shows up accurately on your current Vendor Portal statement. No other method of reporting is acceptable unless agreed to by the Parties in writing. Failure to report all sales pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion. Please refer to the TIPS [Accounting FAQ's](#) for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com.
- 11. TIPS Administration Fees.** The collection of administrative fees by TIPS, a government entity, for performance of these procurement services is required pursuant to Texas Government Code Section 791.011 et. seq. The administration fee ("TIPS Administration Fee") is the amount legally owed by Vendor to TIPS for TIPS Sales made by Vendor. The TIPS Administration Fee amount is typically a set percentage of the amount paid by the TIPS Member for each TIPS Sale, less shipping cost, bond cost, and taxes if applicable and identifiable, which is legally due to TIPS, but the exact TIPS Administration Fee for this Contract is published in the corresponding solicitation and is incorporated herein by reference. TIPS Administration Fees are due to TIPS immediately upon Vendor's receipt of payment, including partial payment, for a TIPS Sale. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. Upon receipt of payment for a TIPS Sale, including partial payment (which renders TIPS Administration Fees immediately due), Vendor shall issue to TIPS the corresponding TIPS Administration Fee payment as soon as possible but not later than thirty-one calendar days following Vendor's receipt of payment. Vendor shall pay TIPS via check unless otherwise agreed to by the Parties in writing. Vendor shall include clear documentation with the issued payment dictating to which sale(s) the amount should be applied. Vendor may create a payment report within their TIPS Vendor Portal which is the preferred documentation dictating to which TIPS Sale(s) the amount should be applied. Failure to pay all TIPS Administration Fees pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion as well as the initiation of collection and legal actions by TIPS against Vendor to the extent permitted by law. Any overpayment of participation fees to TIPS by Vendor will be refunded to the Vendor

within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date that TIPS received the payment will render the overpayment non-refundable. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect TIPS Administration Fees due to TIPS pursuant to this Agreement.

- 12. Term of the Agreement.** This Agreement with TIPS is for approximately five years with a one-year, consecutive option for renewal as described herein. Renewal options are not automatic and shall only be effective if offered by TIPS at its sole discretion. If TIPS offers a renewal option, the Vendor will be notified via email issued to Vendor's then-listed Primary Contact. The renewal option shall be deemed accepted by Vendor unless Vendor notifies TIPS of its objection to the renewal option in writing and confirms receipt by TIPS.

Actual Effective Date: Agreement is effective upon signature by authorized representatives of both Parties. The Effective Date does not affect the "Term Calculation Start Date."

Term Calculation Start Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, Vendor shall calculate the foregoing term as starting on the last day of the month that "Award Notifications" are anticipated as published in the Solicitation, regardless of the actual Effective Date.

Example of Term Calculation Start Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 in this example.

Contract Expiration Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, the term expiration date shall be five-years from the Term Calculation Start Date.

Example of Contract Expiration Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 and the Contract Expiration Date of the resulting initial "five-year" term, (which is subject to an extension(s)) will be May 31, 2028 in this example.

Option(s) for Renewal: Any option(s) for renewal shall begin on the Contract Expiration Date, or the date of the expiration of the prior renewal term where applicable, and continue for the duration specified for the renewal option herein.

Example of Option(s) for Renewal: In this example, if TIPS offers a one-year renewal and the Contract Expiration Date is May 31, 2028, then the one-year renewal is effective from May 31, 2028 to May 31, 2029.

TIPS may offer to extend Vendor Agreements to the fullest extent the TIPS Solicitation resulting in this Agreement permits.

- 13. TIPS Pricing.** Vendor agrees and understands that for each TIPS Contract that it holds, Vendor submitted, agreed to, and received TIPS' approval for specific pricing, discounts, and other pricing terms and incentives which make up Vendor's TIPS Pricing for that TIPS Contract ("TIPS Pricing"). Vendor confirms that Vendor will not add the TIPS Administration Fee as a charge or line-item in a TIPS Sale. Vendor hereby certifies that Vendor shall only offer goods and services through this TIPS Contract if those goods and services are included in or added to Vendor's TIPS Pricing and approved by TIPS. TIPS reserves the right to review Vendor's pricing update requests as specifically as line-item by line-item to determine compliance. However, Vendor contractually agrees that all submitted pricing updates shall be within the original terms of the Vendor's TIPS Pricing (scope, proposed discounts, price increase limitations, and other pricing terms and incentives originally proposed by Vendor) such that TIPS may accept Vendors price increase requests as submitted without additional vetting at TIPS discretion. Any pricing quoted by Vendor to a TIPS Member or on a TIPS Quote shall never exceed Vendor's TIPS Pricing for any good or service offered through TIPS. Vendor certifies by signing this agreement that Vendor's TIPS Pricing for all goods and services included in Vendor's TIPS Pricing shall either be equal to or less than Vendor's current pricing for that good or service for any other customer. TIPS Pricing price increases and modifications, if permitted, will be honored according to the terms of the solicitation and Vendor's proposal, incorporated herein by reference.

- 14. Indemnification of TIPS.** VENDOR AGREES TO INDEMNIFY, HOLD HARMLESS, AND DEFEND TIPS, TIPS MEMBERS, TIPS OFFICERS, TIPS EMPLOYEES, TIPS DIRECTORS, AND TIPS TRUSTEES (THE "TIPS INDEMNITEES") FROM AND AGAINST ALL CLAIMS AND SUITS BY THIRD-PARTIES FOR DAMAGES, INJURIES TO PERSONS (INCLUDING DEATH), PROPERTY DAMAGES, LOSSES, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES, ARISING OUT OF OR RELATING TO VENDOR'S PERFORMANCE UNDER THIS AGREEMENT (INCLUDING THE PERFORMANCE OF VENDOR'S OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES), REGARDLESS OF THE NATURE OF THE CAUSE OF ACTION,

INCLUDING WITHOUT LIMITATION CAUSES OF ACTION BASED UPON COMMON, CONSTITUTIONAL, OR STATUTORY LAW OR BASED IN WHOLE OR IN PART UPON ALLEGATIONS OF NEGLIGENT OR INTENTIONAL ACTS OR OMISSIONS ON THE PART OF VENDOR, ITS OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED TO BY TIPS. APART FROM THIS INDEMNIFICATION PROVISION REQUIRING INDEMNIFICATION OF THE TIPS INDEMNITEES' ATTORNEY'S FEES AS SET FORTH ABOVE, RECOVERY OF ATTORNEYS' FEES BY THE PREVAILING PARTY IS AUTHORIZED ONLY IF AUTHORIZED BY TEX. EDUC. CODE § 44.032(F).

- 15. Indemnification and Assumption of Risk – Vendor Data.** VENDOR AGREES THAT IT IS VOLUNTARILY PROVIDING DATA (INCLUDING BUT NOT LIMITED TO: VENDOR INFORMATION, VENDOR DOCUMENTATION, VENDOR'S PROPOSALS, VENDOR PRICING SUBMITTED OR PROVIDED TO TIPS, TIPS CONTRACT DOCUMENTS, TIPS CORRESPONDENCE, VENDOR LOGOS AND IMAGES, VENDOR'S CONTACT INFORMATION, VENDOR'S BROCHURES AND COMMERCIAL INFORMATION, VENDOR'S FINANCIAL INFORMATION, VENDOR'S CERTIFICATIONS, AND ANY OTHER VENDOR INFORMATION OR DOCUMENTATION, INCLUDING WITHOUT LIMITATION SOFTWARE AND SOURCE CODE UTILIZED BY VENDOR, SUBMITTED TO TIPS BY VENDOR AND ITS AGENTS) ("VENDOR DATA") TO TIPS. FOR THE SAKE OF CLARITY, AND WITHOUT LIMITING THE BREADTH OF THE INDEMNITY OBLIGATIONS IN SECTION 13 ABOVE, VENDOR AGREES TO PROTECT, INDEMNIFY, AND HOLD THE TIPS INDEMNITEES HARMLESS FROM AND AGAINST ANY AND ALL LOSSES, CLAIMS, ACTIONS, DEMANDS, ALLEGATIONS, SUITS, JUDGMENTS, COSTS, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES AND ALL OTHER LIABILITY OF ANY NATURE WHATSOEVER ARISING OUT OF OR RELATING TO: (I) ANY UNAUTHORIZED, NEGLIGENT OR WRONGFUL USE OF, OR CYBER DATA BREACH INCIDENT AND VIRUSES OR OTHER CORRUPTING AGENTS INVOLVING, VENDOR'S DATA, PRICING, AND INFORMATION, COMPUTERS, OR OTHER HARDWARE OR SOFTWARE SYSTEMS, AND; (II) ALLEGATIONS OR CLAIMS THAT ANY VENDOR DATA INFRINGES ON THE INTELLECTUAL PROPERTY RIGHTS OF A THIRD-PARTY OR VENDOR.
- 16. Procedures Related to Indemnification.** In the event that an indemnity obligation arises, Vendor shall pay all amounts set forth in Section 13 and 14 above (including any settlements) and – if it has accepted its indemnity obligation without qualification – control the legal defense to such claim or cause of action, including without limitation attorney selection, strategy, discovery, trial, appeal, and settlement, and TIPS shall, at Vendor's cost and expense (with respect to reasonable out of pocket costs and expenses incurred by TIPS which shall be reimbursed to TIPS by Vendor), provide all commercially reasonable assistance requested by Vendor. In controlling any defense, Vendor shall ensure that all assertions of governmental immunity and all applicable pleas and defenses shall be promptly asserted.
- 17. Indemnity for Underlying Sales and Supplemental Agreements.** Vendor shall be solely responsible for any customer claims or any disputes arising out of TIPS Sales or any Supplemental Agreement as if sold in the open-market. The Parties agree that TIPS shall not be liable for any claims arising out of Vendor's TIPS Sales or Supplemental Agreements, including but not limited to: allegations of product defect or insufficiency, allegations of service defect or insufficiency, allegations regarding delivery defect or insufficiency, allegations of fraud or misrepresentation, allegations regarding pricing or amounts owed for TIPS sales, and/or allegations regarding payment, over-payment, under-payment, or non-payment for TIPS Sales. Payment/Drafting, overpayment/over-drafting, under-payment/under-drafting, or non-payment for TIPS Sales between customer and Vendor and inspections, rejections, or acceptance of such purchases shall be the exclusive respective obligations of Vendor/Customer, and disputes shall be handled in accordance with the terms of the underlying Supplemental Agreement(s) entered into between Vendor and Customer. Vendor acknowledges that TIPS is not a dealer, subcontractor, agent, or reseller of Vendor's goods and services and shall not be responsible for any claims arising out of alleged insufficiencies or defects in Vendor's goods and services, should any arise.
- 18. Confidentiality of Vendor Data.** Vendor understands and agrees that by signing this Agreement, all Vendor Data is hereby released to TIPS, TIPS Members, and TIPS third-party administrators to effectuate Vendor's TIPS Contract except as provided for herein. The Parties agree that Vendor Data is accessible by all TIPS Members as if submitted directly to that TIPS Member Customer for purchase consideration. If Vendor otherwise considers any portion of Vendor's Data to be confidential and not subject to public disclosure pursuant to Chapter 552 Texas Gov't Code (the "Public Information Act") or other law(s) and orders, Vendor must have identified the claimed confidential materials through proper execution of the Confidentiality Claim Form which is required to be submitted as part of Vendor's proposal resulting in this Agreement and incorporated by reference. The Confidentiality Claim Form included in Vendor's proposal and incorporated herein by reference is the sole indicator of whether Vendor considers any Vendor Data confidential in the event TIPS receives a Public Information Request. If TIPS receives a request, any responsive documentation not deemed confidential by you in this manner will be automatically released. For Vendor Data deemed confidential by you in this manner, TIPS will follow procedures of controlling statute(s) regarding any claim of confidentiality and shall not be liable for any release of information required by law, including Attorney General determination and opinion. In the event that TIPS receives a written request for information pursuant to the Public Information Act that affects Vendor's interest in any information or data furnished to TIPS by Vendor, and TIPS requests an opinion from the Attorney General, Vendor may, at its own option and expense, prepare comments and submit information directly to the Attorney General stating why the requested information is exempt from disclosure pursuant to the requirements of the

Public Information Act. Vendor is solely responsible for submitting the memorandum brief and information to the Attorney General within the time period prescribed by the Public Information Act. Notwithstanding any other information provided in this solicitation or Vendor designation of certain Vendor Data as confidential or proprietary, Vendor's acceptance of this TIPS Vendor Agreement constitutes Vendor's consent to the disclosure of Vendor's Data, including any information deemed confidential or proprietary, to TIPS Members or as ordered by a Court or government agency, including without limitation the Texas Attorney General. Vendor agrees that TIPS shall not be responsible or liable for any use or distribution of information or documentation by TIPS Members or as required by law.

19. Vendor's Authorized Resellers. TIPS recognizes that many vendors operate in the open market through the use of resellers or dealers. For that reason, TIPS permits Vendor to authorize Authorized Resellers within its Vendor Portal and make TIPS Sales through the Authorized Reseller(s). Once authorized by Vendor in the Vendor Portal, the Authorized Reseller(s) may make TIPS sales to TIPS Members. However, all purchase documents must include: (1) Authorized Reseller's Name; (2) Vendor's Name, as known to TIPS, and; (3) Vendor's TIPS Contract Name and Number under which it is making the TIPS Sale. Either Vendor or Reseller may report the sale pursuant to the terms herein. However, Vendor agrees that it is legally responsible for all reporting and fee payment as described herein for TIPS Sales made by Authorized Resellers. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. The Parties intend that Vendor shall be responsible and liable for TIPS Sales made by Vendor's Authorized Resellers. Vendor agrees that it is voluntarily authorizing this Authorized Reseller and in doing so, Vendor agrees that it is doing so at its own risk and agrees to protect, indemnify, and hold TIPS harmless in accordance with Sections 14-17 above related to Authorized Reseller TIPS Sales made pursuant to this Agreement or purporting to be made pursuant to this Agreement that may be asserted against Vendor whether rightfully brought or otherwise. The Parties further agree that it is no defense to Vendor's breach of this Agreement that an Authorized Reseller caused Vendor of breach this Agreement.

20. Circumvention of TIPS Sales. When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Any request for quote, customer communication, or customer purchase initiated through or referencing a TIPS Contract shall be completed through TIPS pursuant to this Agreement. Any encouragement or participation by Vendor in circumventing a TIPS sale being completed may result in immediate termination of Vendor's TIPS Contract(s) for cause as well as preclusion from future TIPS opportunities at TIPS sole discretion.

21. State of Texas Franchise Tax. By signature hereon, Vendor hereby certifies that Vendor is not currently delinquent in the payment of any franchise taxes owed to the State of Texas under Chapter 171 of the Texas Tax Code.

22. Termination.

- A) Termination for Convenience. TIPS may, by written notice to Vendor, terminate this Agreement for convenience, in whole or in part, at any time by giving thirty (30) days' written notice to Vendor of such termination, and specifying the effective date thereof.
- B) Termination for Cause. If Vendor fails to materially perform pursuant to the terms of this Agreement, TIPS shall provide written notice to Vendor specifying the default. If Vendor does not cure such default within thirty (30) days, TIPS may terminate this Agreement, in whole or in part, for cause. If TIPS terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
- C) Vendor's Termination. If TIPS fails to materially perform pursuant to the terms of this Agreement, Vendor shall provide written notice to TIPS specifying the default ("Notice of Default"). If TIPS does not cure such default within thirty (30) days, Vendor may terminate this Agreement, in whole or in part, for cause. If TIPS terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
- D) Upon termination, all TIPS Sale orders previously accepted by Vendor shall be fulfilled and Vendor shall be paid for all TIPS Sales executed pursuant to the applicable terms. All TIPS Sale orders presented to Vendor but not fulfilled by Vendor, prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. - E) Vendor hereby waives any and all claims for damages, including, but not limited, to consequential damages or lost profits, that might arise from TIPS' act of terminating this Agreement.

- 23. Vendor affirms that, to the best of Vendor's knowledge, this Agreement has been arrived at independently, and is awarded without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement. Vendor agrees that it has disclosed any necessary affiliations with Region 8 Education Service Center and the TIPS Department, if any, through the Conflict of Interest attachment provided in the solicitation resulting in this Agreement.
- 26. Volume of TIPS Sales.** Nothing in this Agreement or any TIPS communication may be construed as a guarantee that TIPS or TIPS Members will submit any TIPS orders to Vendor at any time.
- 27. Compliance with the Law.** The Parties agree to comply fully with all applicable federal, state, and local statutes, ordinances, rules, and regulations applicable to their entity in connection with the programs contemplated under this Agreement.
- 28. Severability.** If any term(s) or provision(s) of this Agreement are held by a court of competent jurisdiction to be invalid, void, or unenforceable, then such term(s) or provision(s) shall be deemed restated to reflect the original intention of the Parties as nearly as possible in accordance with applicable law and the remainder of this Agreement, and the remainder of the provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated, unless such holding causes the obligations of the Parties hereto to be impossible to perform or shall render the terms of this Agreement to be inconsistent with the intent of the Parties hereto.
- 29. Force Majeure.** If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement through no fault of its own then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon. Upon delivering such notice, the obligation of the affected party, so far as it is affected by such Force Majeure as described, shall be suspended during the continuance of the inability then claimed but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. This ECU together with the Order (as hereinafter defined) between Blackswan and Client referencing this ECU, together with any documents referenced in the Order and this ECU, constitute the agreement (the “Agreement”) between Blackswan and Client. The effective date (“Effective Date”) of the Agreement shall be the date of acceptance of the Order by Client.

By downloading, installing, registering, accessing, evaluating or otherwise using the Deliverables, Client acknowledges and agrees that it is bound to the Agreement. The Agreement governs Client’s use of the Deliverables however acquired including without limitation acquisition through an authorized distributor, reseller, online app store, or marketplace.

1. Definitions

- 1.1. “Affiliate(s)” means a corporation, partnership or other entity controlling, controlled by or under common control with such party, but only so long as such control continues to exist. For purposes of this definition, control means ownership, directly or indirectly, of greater than fifty percent (50%) of the voting rights in such entity (or, in the case of a noncorporate entity, equivalent rights).
- 1.2. “Client Content” means any data that is ingested by or on behalf of Client into a Deliverable from Client’s data sources.
- 1.3. “Client Data” means data that may be accessed or collected by the Deliverables in the form of logs, session data, telemetry, user data, usage data, threat intelligence data, threat detection information, copies of potentially malicious files detected, system stability data, user experience data, user interface data, and network traffic metadata. Client Data may include confidential data and personal data, such as source and destination IP addresses, active directory information, file applications, URLs, file names, and file content.
- 1.4. “Confidential Information” means all nonpublic information disclosed by a party to the other party, whether orally or in writing, that is designated as confidential or that, given the nature of the information or circumstances surrounding its disclosure, should reasonably be understood to be confidential. The terms of the Agreement are confidential to Blackswan and shall not be disclosed by Client to any third party. Notwithstanding the foregoing, Confidential Information does not include any information that: (i) is or becomes generally known to the public without breach of any obligation owed to the Disclosing Party, (ii) was known to the Receiving Party prior to its disclosure by the Disclosing Party without breach of any obligation owed to the Disclosing Party, (iii) is received from a third party without breach of any obligation owed to the Disclosing Party, or (iv) was independently developed by the Receiving Party.
- 1.5. “Deliverable(s)” means Software, Subscription Services and other goods or services specified in an Order.
- 1.6. “Deliverable Term” means each period of time specified in an Order whereby Blackswan agrees to provide a Deliverable to Client. The Agreement will automatically renew at the end of each initial Deliverable Term, and each subsequent Deliverable Term, for an additional period of time equal to the prior Deliverable Term unless either party has provided written notice of non-renewal at least fifteen (15) days prior to the end of the then-current Deliverable Term.

- 1.7. "Limits" means the maximum number of users, assets or data ingestion amounts specified in an Order.
- 1.8. "Order(s)" means a Blackswan quote or ordering document (including online order form) accepted by Client via execution by Client or Client's purchase order or other ordering document received and acknowledged by Blackswan (directly or indirectly through an authorized reseller) which references the Deliverables, capacity, pricing, Deliverable Term, and other applicable terms set forth in an applicable Blackswan quote or ordering document. Orders shall not include the terms of any preprinted terms on Client's purchase order or other terms on a purchase order that are additional or inconsistent with the terms of this ECU.
- 1.9. "Software" means the executable code version of software, and any updates thereto, specified in an Order.
- 1.10. "Subscription Services" means software-as-a-service and cloud-delivered security services provided by Blackswan specified in an Order.

2. Software Licenses and Subscription Services

- 2.1. Software License. Blackswan grants to Client a nonexclusive, nontransferable, limited license to use the Software specified in an Order: (i) solely for the internal use by Client or Client's Affiliates at Client's or Client Affiliate's facility specified in the Order or on Client's or Client Affiliate's internal computer or cloud-based systems, (ii) during the Deliverable Term specified in the Order, and (iii) up to the Limits specified in the Order.
- 2.2. Evaluation License. Software provided for evaluation or at no charge or for a nominal charge may only be used for evaluation during the evaluation period set forth in the Order, not to exceed thirty (30) days, unless otherwise specified and agreed by Blackswan in writing, solely for the purpose of consideration whether to enter into an Agreement and not for any other purpose or any productive use. Notwithstanding anything to the contrary in the Agreement, Blackswan shall have no obligation to provide maintenance, support, installation services, training services, warranties, or indemnification for evaluation licenses. Blackswan may, in its sole discretion, terminate an evaluation license at any time.
- 2.3. Subscription Services. Subject to the terms of the service level agreement, Blackswan shall provide Client access to the Subscription Services specified in an Order: (i) solely for the internal use by Client or Client's Affiliates, (ii) during the Deliverable Term specified in the Order, and (iii) up to the Limits specified in the Order.
- 2.4. Trial Subscription Services. Blackswan may provide Client trial access to the Subscription Services for evaluation or at no charge or for a nominal charge. Said trial access is for the evaluation period set forth in the Order, not to exceed thirty (30) days, unless otherwise specified and agreed by Blackswan in writing, solely for the purpose of consideration whether to enter into an Agreement and not for any other purpose or any productive use. Notwithstanding anything to the contrary in the Agreement, Blackswan shall have no obligation to provide maintenance, support, installation services, training services, warranties, or indemnification for Clients granted trial access. Blackswan may, in its sole discretion, discontinue trial access at any time.

3. Support / Service Level Agreement

- 3.1. Blackswan shall provide Client maintenance, support and training for the Software as specified in an Order and maintenance, support and training for the Subscription Services as specified in the Service Level Agreement found at Attachment A.

4. Fees and Payments

- 4.1. Fees. Client agrees to pay fees and charges specified in the Order, or if not specified in the Order, the fees and charges at Blackswan's then-current list price for the respective Deliverables. Fees may be modified by Blackswan for each Deliverable Term after the initial Deliverable Term by written notice to Client at least thirty (30) days prior to the end of the then current Deliverable Term.
- 4.2. Invoicing. All fees and charges shall be invoiced by Blackswan and payable by Client prior to receipt or use of the Deliverables at the start of the Deliverable Term specified in the Order or as otherwise specified in the Order.
- 4.3. Payments. All payments shall be due and payable within thirty (30) days after the date specified in Blackswan's invoice to Client unless otherwise specified on an Order. Without limiting other remedies, undisputed past due amounts shall be subject to a monthly charge of one percent (1%) per month of the unpaid balance or the maximum rate allowable by law, whichever is less.
- 4.4. Taxes. All fees and charges quoted are exclusive of applicable taxes and duties, including any applicable sales and use tax. Client is responsible to pay any taxes or similar government assessments (including, without limitation, value-added, sales, use or withholding taxes) or custom duties. For avoidance of doubt, Blackswan is responsible to pay taxes assessable based on Blackswan's net income, property and employees.
- 4.5. Audits. Client shall maintain records regarding Client's use of the Deliverables and shall make such information available to Blackswan upon written request with sixty (60) days advanced notice. Blackswan may monitor Client's use of the Deliverables and reserves the right to audit, at its expense, Client's deployment and use of the Deliverables for compliance with the terms of the Agreement. If Client's use of the Deliverables is found to be greater than the Limits specified in an Order or for purposes beyond the license granted for the Deliverables, Client will be invoiced for excess use at the greater of the fees specified in the Order or Blackswan's then-current list price for the respective Deliverables. If an audit by Blackswan, results in an adjustment to the fees owed by Client greater than ten percent (10%) of the fees paid by the Client under the Agreement, Client will pay the expenses associated with such audit.
- 4.6. Suspension. Blackswan reserves the right to suspend the Deliverables for failure to pay fees then due ten (10) days after delivery of written notice which may be by email.

5. Term and Termination

- 5.1. Term. The Agreement shall commence as of the Effective Date and shall continue for the Deliverable Term specified in each respective Order unless earlier terminated. Termination of a specified Order will not affect a termination of any other Order.
- 5.2. Termination. Either party may terminate the Agreement, or an Order, in the event of breach by the other party which is not cured within thirty (30) days after delivery of written notice or within ten (10) days after delivery of written notice for breach of payment or use restrictions. Either party may terminate the Agreement, or any Order, immediately upon a party becoming insolvent or generally failing to pay its debts as they become due, or commencing or becoming subject to reorganization, insolvency or liquidation proceedings or ceasing to conduct business in the ordinary course. Upon termination, all licenses and rights shall terminate and Client shall return and cease all use of the Deliverables. Notwithstanding any early termination above,

except for Client's termination for Blackswan's uncured material breach, Client shall continue to be required to pay all fees payable under an Order.

6. Use Restrictions

- 6.1. Client shall not, and shall not permit any third party, to: (i) copy, modify, translate, reverse engineer, decompile, disassemble or otherwise reduce the Deliverables to human perceivable form or attempt to discover underlying source code, algorithms, or techniques, except to the extent that such activities may not be prohibited under applicable law, (ii) provide, lease, use for timeshare or service bureau purposes, or lend or otherwise allow use of the Deliverables by or on behalf of any third party or at any location other than the Client location or systems specified in the Order, (iii) disclose any benchmarking, competitive analysis or other results obtained from the Deliverables to develop any similar item or any competitive products or services, (iv) attempt to disable or circumvent any license key, encryption or other security device or mechanism used in connection with the Deliverables, (v) remove or otherwise interfere with any portion of the Deliverables designed to monitor Client's compliance with the Agreement (vi) exceed the Limits specified in an Order, or (vii) use any Deliverable in violation of applicable laws and regulations. Client acknowledges the Deliverables may include license keys and other features that disable use at the end of the applicable license or once the Limits specified in the Order are met.

7. Ownership

- 7.1. Deliverables. Client acknowledges and agrees the Deliverables, including but not limited to the Software and Subscription Services, are licensed or provided, not sold. Subject to the rights granted in the Agreement, Blackswan shall retain all rights, title and interest in and to the Deliverables, including but not limited to the Software, the Subscription Services, and all intellectual property rights relating thereto.
- 7.2. Input. Any error reports, suggestions, recommendations, comments and other information provided by Client to Blackswan with respect to the Deliverables (collectively "Input") shall be owned by Client, however, Client grants to Blackswan a non-exclusive, transferable, irrevocable, worldwide, royalty-free license (with rights to sublicense) to make, use, sell, offer to sell, reproduce, modify, distribute, make available, publicly display and perform, disclose and otherwise commercially exploit the Input.
- 7.3. Client Data. Subject to the limited rights expressly granted hereunder, Client reserves all rights, title and interest in and to all Client Data, including all related intellectual property rights relating thereto. As between Client and Blackswan, Client shall retain ownership of all Client Data. No rights are granted to Blackswan under the Agreement other than the limited rights licenses expressly set forth in the Agreement. Client hereby grants to Blackswan and its authorized third party service providers the worldwide, nonexclusive, fully paid-up, royalty-free license to access, use, copy, distribute, perform, display and process Client Data to provide, maintain, and improve the Deliverables and perform its obligations under the Agreement. Client further authorizes Blackswan to make necessary adjustments and modifications to sensors in Client's systems to optimize the effectiveness of the Deliverables.

- 7.4. Use of Open Source Software. The Software may contain certain software, feeds, or portions provided under terms and conditions different from the Agreement (such as open source or community source), which may be identified in a text file or about box or in a file or files referenced thereby, or in a list provided to Client upon Client's written request. Any open source software that is delivered to Client as part of the Software, and which may not be taken out of the Software, or used separately from the Software, is covered by the warranty, support, and indemnification provisions applicable to the Software. Client acknowledges that specific terms required by the respective licensors of open source software may apply to its use, however, these terms will not: (a) impose any additional restrictions on Client's use of the Software, or (b) negate or amend Blackswan's responsibilities with respect to the Software.

8. Data Protection

- 8.1. Data Protection by Client. Client represents and warrants that Client's use of the Deliverables complies with all applicable laws, including those related to data protection and that Client has obtained any and all consents necessary for Blackswan to engage in data processing under the Agreement.

9. Confidentiality

- 9.1. Confidential Information. Each party will protect the Confidential Information of the other. Accordingly, a party receiving Confidential Information (a "Receiving Party") agrees to: (i) protect the Confidential Information of a party disclosing Confidential Information (a "Disclosing Party") using the same degree of care (but in no event less than reasonable care) that it uses to protect its own Confidential Information of a similar nature; (ii) limit use of Disclosing Party's Confidential Information for purposes consistent with the Agreement, and (iii) use commercially reasonable efforts to limit access to Disclosing Party's Confidential Information to its employees, contractors and agents or those of its Affiliates who have a bona fide need to access such Confidential Information for purposes consistent with the Agreement and who are subject to confidentiality obligations no less stringent than those herein.
- 9.2. Compelled Disclosure of Confidential Information. Notwithstanding the foregoing terms, the Receiving Party may disclose Confidential Information of the Disclosing Party if it is compelled by law enforcement agencies or regulators to do so, provided the Receiving Party gives the Disclosing Party prior notice of such compelled disclosure (to the extent legally permitted) and reasonable assistance, at the Disclosing Party's cost, if the Disclosing Party wishes to contest the disclosure. If the Receiving Party is compelled to disclose the Disclosing Party's Confidential Information as part of a civil proceeding to which the Disclosing Party is a Party, the Disclosing Party will reimburse the Receiving Party for its reasonable cost of compiling and providing secure access to such Confidential Information.

10. Indemnity

- 10.1. Indemnity by Blackswan. Blackswan will defend and indemnify Client, to the extent a claim, demand, suit or proceeding is made or brought against Client by a third party alleging the Deliverables infringes or misappropriates such third party's patent, copyright, trademark or trade secret. Notwithstanding the foregoing, in no event shall Blackswan have any obligations

or liability under this Section arising from: (i) use of any of the Deliverables in a manner not anticipated by the Agreement or in combination with materials not furnished by Blackswan; or (ii) any content, information or data provided by Client or other third parties. If the Deliverables may become subject to a claim of infringement or misappropriation, Blackswan will, at its sole option and expense, either: (i) obtain for the Client the right to continue using the Deliverables; (ii) replace or modify the Deliverables to be non-infringing and substantially equivalent to the infringing Deliverables; or (iii) if options (i) and (ii) above cannot be accomplished despite the reasonable efforts of Blackswan, then Blackswan may terminate Client's rights to use the infringing Deliverables and will refund pro-rata any prepaid fees for the infringing portion of the Deliverables. THE RIGHTS GRANTED TO CLIENT UNDER THIS SECTION SHALL BE CLIENT'S SOLE AND EXCLUSIVE REMEDY FOR ANY ALLEGED INFRINGEMENT BY THE DELIVERABLES OF ANY PATENT, COPYRIGHT, TRADEMARK OR TRADE SECRET.

- 10.2. Indemnity by Client. Client will defend and indemnify Blackswan to the extent a claim, demand, suit or proceeding is made or brought against Blackswan by a third party alleges any Client Content infringes or misappropriates such third party's patent, copyright, trademark or trade secret, or violates another right of a third party.
- 10.3. Process for Indemnification. The indemnification obligations above are subject to the party seeking indemnification to: (i) provide the other party with prompt written notice of the specific claim; (ii) give the indemnifying party sole control of the defense and settlement of the claim (except that the indemnifying party may not settle any claim that requires any action or forbearance on the indemnified party's part without their prior consent, which will not unreasonably withhold or delay); and (iii) gives the indemnifying party all reasonable assistance, at such party's expense.

11. Limited Warranty

- 11.1. Blackswan warrants that any Deliverables will substantially perform the material functions described in the applicable documentation. Blackswan does not warrant the Deliverables will meet Client's requirements or function uninterrupted or error free. EXCEPT AS EXPRESSLY SET FORTH ABOVE IN THIS SECTION, THE DELIVERABLES ARE PROVIDED AS IS AND WITHOUT WARRANTY OF ANY KIND, WHETHER EXPRESS OR IMPLIED, AND BLACKSWAN SPECIFICALLY DISCLAIMS ANY IMPLIED WARRANTIES NONINFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. BLACKSWAN DOES NOT WARRANT THAT USE OF DELIVERABLES WILL BE UNINTERRUPTED, ERROR FREE OR SECURE, OR THAT ALL DEFECTS WILL BE CORRECTED.

12. Limitation of Liability

- 12.1. Limitation on Types of Damages. IN NO EVENT SHALL EITHER PARTY BE LIABLE FOR PUNITIVE, EXEMPLARY, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES (INCLUDING COSTS OF PROCUREMENT OF SUBSTITUTE GOODS) ARISING OUT OF OR RELATING TO THE AGREEMENT OR ANY DELIVERABLE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 12.2. Limitation on Amount of Liability. IN NO EVENT SHALL A PARTY'S TOTAL LIABILITY ARISING OUT OF OR RELATING TO THE AGREEMENT OR THE DELIVERABLES EXCEED THE AMOUNT

DUE FROM OR PAID FOR THE DELIVERABLES IN THE TWELVE (12) MONTHS PRECEDING THE FIRST INCIDENT OUT OF WHICH THE LIABILITY AROSE, REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE OR OTHERWISE.

- 12.3. Exclusions. The limitation of liability herein will not apply to a breach of a party's confidentiality obligations, indemnification obligations, or the fraud, gross negligence or willful misconduct of a party. The foregoing limitations will also not apply to the extent prohibited by law.

13. Miscellaneous

- 13.1. Governing Law, Jurisdiction and Venue. The Agreement is governed by California law, excluding its choice of laws rule. The United Nations Convention on Contracts for the International Sale of Goods (1980) is specifically excluded and shall not apply. Any dispute or claim arising out of or related to the Agreement, or breach or termination thereof, shall be subject to exclusive jurisdiction and venue of the state and federal courts in Santa Clara County, California, and the parties agree and submit to the personal and exclusive jurisdiction of these courts.
- 13.2. Different Terms. Blackswan expressly rejects terms or conditions in any Client purchase order or other similar document which are different from or additional to the terms and conditions set forth in the Order or this ECU. Such different or additional terms and conditions will not become a part of an agreement between the parties notwithstanding any subsequent acknowledgement by Blackswan.
- 13.3. Export. The Deliverables may not be exported without prior written consent of Blackswan. Client warrants and hereby gives written assurance to Blackswan that Client will comply with all U.S. and foreign export and re-export restrictions applicable to the Deliverables. Client warrants that it shall comply with the Foreign Corrupt Practices Act (FCPA) in all dealings with, by, for or on behalf of Blackswan, and shall not offer, promise, give, demand, seek or accept, directly or indirectly, any gift or payment, consideration or benefit in kind that would or could be construed as an illegal or corrupt practice.
- 13.4. Assignment. Client may not assign its rights under the Agreement without the prior written consent of Blackswan.
- 13.5. Force Majeure. Neither party will be liable for any delay or failure to perform any obligation under the Agreement (except for the obligation to make any payments) where the delay or failure results from any cause beyond their reasonable control, including, without limitation, acts of God, labor disputes or other industrial disturbances, electrical, telecommunications, or other utility failures, earthquake, storms or other elements of nature, blockades, embargoes, riots, acts or orders of government, acts of terrorism, or war.
- 13.6. Independent Contractors; No Third-Party Beneficiaries. The parties to the Agreement are independent contractors. The Agreement does not create a partnership, franchise, joint venture, agency, fiduciary or employment relationship between the parties. There are no third-party beneficiaries of the Agreement. Neither party has the authority to bind or act on behalf of the other party in any capacity or circumstance whether by contract or otherwise.
- 13.7. Survival. The termination or expiration of the Agreement will not affect any provisions herein which by their nature survive termination or expiration, including the provisions that

deal with ownership of intellectual property, confidentiality, payment obligations, effect of termination, limitation of liability, privacy, and the Miscellaneous section in this ECU.

- 13.8. Integration; Entire Agreement. The Agreement along with any additional terms incorporated herein by reference, constitute the complete and exclusive understanding and agreement between the parties and supersedes any and all prior or contemporaneous agreements, communications and understandings, written or oral, relating to their subject matter. Except as otherwise expressly set forth herein, any waiver, modification or amendment of any provision of the Agreement will be effective only if in writing and signed by duly authorized representatives of both parties.

Attachment A- Service Level Agreement

This Service Level Agreement (“SLA”) defines the service levels provided to eligible Clients for Subscription Services provided by Blackswan Cybersecurity, LLC (“BlackSwan”). Capitalized terms not otherwise defined herein have the meaning ascribed to them in Blackswan’s End User Agreement. This SLA shall only apply to Clients who have purchased Subscription Services directly from, and who have entered into an agreement directly, with Blackswan or an authorized Blackswan reseller.

1. Technical Support

Blackswan will provide Clients with technical support to identify, analyze, and resolve challenges with the Subscription Services provided by Blackswan. All support shall be through Client’s authorized account administrators.

Upon contacting Blackswan support through the Blackswan Support Portal, Clients will be required to provide Clients’ account organization name and complete description of the problem including error messages, screenshots, and other troubleshooting information as requested by support personnel. Additionally, when reporting an issue, the severity of the issue should be classified based on the impact to the Client’s business operations in accordance with the severity classification table below. Blackswan support personnel will use reasonable efforts to respond to Client’s reported issues within the timeframe designated below.

Issue Severity	Description	Response Time
1 - Critical	Services are down, or unavailable. Business operations have been severely disrupted. No workaround is available.	1 hour
2 - High	Major functionality is impacted or significant performance degradation is experienced. Short-term workaround is available, not scalable.	4 hours
3 - Medium	Minimal impact to operations. Short or long-term workaround is available.	24 hours
4 - Low	General questions or feedback. No Impact on business operations.	48 hours

2. Maintenance

2.1. Scheduled Maintenance

To ensure optimal performance and security of the Subscription Services, Blackswan routinely performs maintenance on a regularly scheduled basis within its published maintenance windows. This may require specific services to be suspended during the maintenance period. Maintenance is typically performed during off-peak weekend hours. Subscription Services unavailability due to scheduled maintenance is excluded from availability calculations. Blackswan will endeavor to notify Clients in advance of any scheduled maintenance that may adversely affect the Subscription Services.

2.2. Emergency Proactive Maintenance

Under certain circumstances Blackswan may need to perform emergency maintenance, such as security patch installation or hardware replacement. Blackswan may not be able to provide Clients with advanced notice in case of emergency maintenance. Subscription Services unavailability due to emergency maintenance will be excluded from availability calculations.

3.Subscription Services Availability

Blackswan guarantees at least 99% Subscription Services availability (“Service Availability”) which is defined as a customer being able to log in and access data in the platform.

Service Availability excludes Excusable Unavailability (defined below in Section D).

4.Excusable Unavailability

Blackswan shall use commercially reasonable efforts to make the Subscription Services available to Clients at least 99% of the time subject to the following exceptions (“Excusable Unavailability”): (i) circumstances beyond Blackswan’s reasonable control, including, without limitation, unavailability of or interruption or delay in telecommunications or third party services, interruption in data center power, IP transit provider (backbone) or end user’s portion of the network (commonly known as “last mile”) failure, denial of service or similar attacks, mail bombs, DNS resolution, domain name expiration, Internet availability, SYN attacks, and other events, virus or hacker attacks, or failure of third party software; (ii) a failure of the Internet, public switched telephone network, or other communication circuits used to access the Subscription Services; (iii) Scheduled Maintenance as detailed in Section B1 of this SLA; (iv) Emergency Proactive Maintenance as detailed Section B2 of this SLA; (v) Clients’ acts or omissions (or acts or omissions of others engaged or authorized by Clients) including, without limitation, custom scripting or coding; (vi) Clients’ negligence, willful misconduct, or use of the services in breach of this SLA; and (vii) other outages on the Internet or otherwise that hinder access to the Subscription Services.

5.Service Availability Monitoring

Blackswan uses a combination of methods to monitor and validate Service Availability, including but not limited to independent monitoring services and internal reporting. These checks are run on predetermined intervals with specific failure thresholds with respect to the services provided. If two or more consecutive tests fail, the absence of Service Availability will be noted as the number of minutes between the first and the last failed tests. Any unavailability less than five minutes in duration will not be recorded.

6.Service Availability Credits

If Service Availability for the full month is below the following levels, Blackswan will credit the account of Clients according to the following schedule:

Service Availability	Amount of Credit as % of monthly fee
98% to 99%	5% of monthly fee credited
97% to 98%	10% of monthly fee credited
96 to 97%	15% of monthly fee credited
Less than 96%	25% of monthly fee credited

To receive a credit for service unavailability, Clients must (i) be in good financial standing with Blackswan, and (ii) send an email or written credit request to the Blackswan billing department within ten (10) business days after a service was unavailable.

Credit requests must include Clients' account username and the dates and times of service unavailability. Blackswan billing department will compare the service unavailability information provided by Clients to Service Availability monitoring data maintained by Blackswan. A credit shall be issued if Blackswan confirms the Clients report of service unavailability. This credit can be used towards future billing payments and cannot be used retroactively. Excusable Unavailability is excluded from Service Availability for purposes of calculating any credit.

Blackswan will calculate the credit based on the particular Subscription Services for which Service Availability was below the prescribed level, the fees for the particular Subscription Services and the percentage of overall services affected. For example, if the credit pertains to the Service Availability of four of 200 units provisioned in an agreement, the credit would be calculated as $2\% \times$ the monthly fee of the agreement \times the % of monthly fee credited. Notwithstanding anything set forth in this SLA or any other agreement, the credit described in this section shall be Clients' sole and exclusive remedy in connection with any outages or unavailability of the Subscription Services.

External Network Enumeration

Blackswan will create a complete profile or "footprint" of host addresses and other information on the Client's networks. This footprint details the systems available via the Internet. Specific systems will be identified by platform, operating system/version and application, where possible.

External Vulnerability Scanning

After verifying the results obtained in the Network Discovery and Enumeration phase with the Client management and receiving their approval, Blackswan will programmatically scan the host addresses using commercial and public domain tools, as well as proprietary scripts and techniques. Blackswan will assess intrusion detection tool(s) as part of our scanning activities for proactive monitoring of suspect network activity, issue alerts, and timely response during our scanning.

False Positive Analysis

Blackswan will work directly with the Client IT personnel to review all vulnerabilities identified as "High Risk" to assist in the elimination of false positives and to determine whether remediation is deemed necessary.

External Network Penetration Testing/Analysis

Utilizing the results from the external network vulnerability assessment, targeted penetration testing/analysis will be coordinated with the Client for those targets deemed viable for exploit attempts.

This testing incorporates both manual testing techniques and automated tools, like Metasploit or other exploit frameworks. Blackswan will review the list of exploit target with the Client for feedback and coordination of further testing. During exploit testing Blackswan will collaborate with the Client on the progression of testing, observations, and any applicable feedback.

Blackswan will capture, to the extent possible, screenshots and related data resulting from the progression of exploit testing. After verifying the results obtained in the Internal Network Discovery and Enumeration phase with Client management and receiving their approval, Blackswan will schedule time with one of the Client’s Domain Administrators to authenticate Blackswan’s vulnerability assessment tool to the domain. Blackswan will then programmatically scan the host addresses using commercial and public domain tools, as well as proprietary scripts and techniques. Blackswan will be assessing the Client’s intrusion detection tool(s) as part of our scanning activities for proactive monitoring of suspect network activity, issue alerts, and timely response during our scanning.

Manual Service, Configuration, and Patch Analysis

This phase involves in-depth analysis of critical hosts and services to reveal additional subtle, yet significant, configuration vulnerabilities, including missing patches. This phase also generates more information about the network such as trusted IP addresses from which services accept connections and which version of services are running; this also generates additional information about services such as which subsystems are implemented as part of the service (such as the use of Java or Perl to extend the functionality of a web server). As needed, testing is conducted to locate previously unknown vulnerabilities. Where necessary, this includes the use of application and protocol fuzzers which locate vulnerability vectors by providing random or semi-random data as inputs to programs and systems.

False Positive Analysis

Blackswan will work directly with the Client IT personnel to review all vulnerabilities identified as “High Risk” to assist in the elimination of false positives and to determine whether remediation is deemed necessary.

Remote Social Engineering w/User Awareness Training

Remote Social Engineering and spear phishing a few users, including fake website (webmail, etc.).

Web Application Security Testing
