Dear TIPS/TAPS Vendor,

We have updated our online database to allow individual vendor access to the TIPS/TAPS information. We no longer allow the generic login of WEBVENDOR. Here are the instructions for you to setup your login account: **(YOU MUST BE THE PRIMARY CONTACT TO SETUP THE ACCOUNT)**.

1. Go to www.tips-usa.com/admin/teamlogin.cfm
2. Click on TIPS ADMINISTRATIVE TEAM LOGIN.
3. Click on FORGOT YOUR PASSWORD?
4. Choose your company ~ Enter your name ~ Enter your email address (must be the primary contact email address).
5. An email will be sent to you with a temporary password. Login to: www.tips-usa.com/admin/teamlogin.cfm
Username: your email address; Password: enter temporary password.
6. After you login the first time, you can change your password. Click on MY ACCOUNT ~ CHANGE PASSWORD. Enter the temporary password ~ new password ~ verify new password ~ click on CHANGE IT.

You can setup additional accounts for other staff from your company. After you login go to MY ACCOUNT ~ click on AUTHORIZED USERS ~ click on ADD USERS ~ Fill in the required fields ~ click on ADD. These additional accounts have limited access capabilities; however, they will have access to the downloadable TIPS/TAPS Member Information.

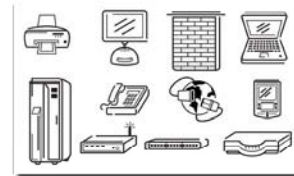
