# 'Locke' turns on Tom Hardy's brilliant minimalism

He's the only actor on screen, and it's great

The title of the year's most inventive film is a reference to the 17th-century philosopher John Locke, who believed reason can resolve most problems. But it also pertains to how the main character lyan Locke - strug-locke is a magnificent drama



Jocke is a magnificent drama that resounds with powerful, universal themes. The sole actor on screen, Tom Hardy, gives a tour-de-force performance. But the real innovation lies in the way writer/director Steven Knight chooses to tell the tale — in real time and in a tightly constrained space. The entire film consists of a man behind the wheel of a card that the distribution of the state of th

voices that we could swear we have actually laid eyes on them. We have not. The story is not assisted by flashbacks, voice-over

of passing cars and highway signs reflect on Locke's resolute face, intensifying the intimate setting and the audience's connection with him. A decent guy, he tries mightily to make amends for a bad decision.

While the film grapples with Locke's transgression, with strikingly eloquent dialogue, it also intriguingly explores the way telephones are used in contemporary society. It looks at human behavior when one is alone, talking on the phone and traveling in a transportation bubble. A person can say one thing, but his face can be telling a radically different story, the property of the property of

assisted by flashbacks, voice-over narration or cuts to anyone outside the car. Instead, the audience is privy only to the conversations occurring within the time Locke is on the road.

If this sounds claustrophobic, igminicky or dull, rest assured it is not. Rather, it's an edge-of-the-seat drama that is visually stunning, thoroughly captivating, even spellbinding.


