General Information

The Vendor Agreement ("Agreement") made and entered into by and between The Interlocal Purchasing System (hereinafter referred to as "TIPS" respectfully) a government cooperative purchasing program authorized by the Region 8 Education Service Center, having its principal place of business at 4845 US Hwy 271 North, Pittsburg, Texas 75686. This Agreement consists of the provisions set forth below, including provisions of all Attachments referenced herein. In the event of a conflict between the provisions set forth below and those contained in any Attachment, the provisions set forth shall control unless otherwise agreed by the parties in writing and by signature and date on the attachment.

The vendor Agreement shall include and incorporate by reference this Agreement, the terms and conditions, special terms and conditions, any agreed upon amendments, as well as all of the sections of the solicitation as posted, including any addenda and the awarded vendor's proposal. Once signed, if an awarded vendor's proposal varies or is unclear in any way from the TIPS Agreement, TIPS, at its sole discretion, will decide which provision will prevail unless otherwise specifically agreed in writing by the parties.

A Purchase Order, Agreement or Contract is the TIPS Member's approval providing the authority to proceed with the negotiated delivery order under the Agreement. Special terms and conditions as agreed to between the vendor and TIPS Member should be added as addendums to the Purchase Order, Agreement or Contract. Items such as certificate of insurance, bonding requirements, small or disadvantaged business goals are some of the addendums possible.

Terms and Conditions

Freight

All quotes to members shall provide a line item for cost for freight or shipping regardless if there is a charge or not. If no charge for freight or shipping, indicate by stating "No Charge" or "\$0", "included in price" or other similar indication. Otherwise, all shipping, freight or delivery changes shall be passed through to the TIPS Member at cost with no markup and said charges shall be agreed by the TIPS Member.

Warranty Conditions

All new supplies equipment and services shall include <u>manufacturer's minimum standard</u> <u>warranty</u> unless otherwise agreed to in writing. Vendor shall be legally permitted to sell all products offered for sale to TIPS Members. All goods proposed and sold shall be new unless clearly stated in writing.

Customer Support

The Vendor shall provide timely and accurate customer support for orders to TIPS Members as agreed by the Parties. Vendors shall respond to such requests within a commercially reasonable time after receipt of the request. If support and/or training is a line item sold or packaged with a sale, support shall be as agreed with the TIPS Member.

Agreements

Agreements for purchase will normally be put into effect by means of a purchase order(s) executed by authorized agents of the TIPS Member participating government entities, but other means of placing an order may be used at the Member's discretion.

Tax exempt status

Most TIPS Members are tax exempt and the related laws and/or regulations of the controlling jurisdiction(s) of the TIPS Member shall apply.

Assignments of Agreements

No assignment of Agreement may be made without the prior notification of TIPS. Written approval of TIPS shall not be unreasonably withheld. Payment for delivered goods and services can only be made to the awarded Vendor, Vendor designated reseller or vendor assigned company.

Disclosures

1. Vendor and TIPS affirms that he/she or any authorized employees or agents has not given, offered to give, nor intends to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor or service to a public servant in connection with this Agreement.

- 2. Vendor shall attach, in writing, a complete description of any and all relationships that might be considered a conflict of interest in doing business with the TIPS program.
- 3. The Vendor affirms that, to the best of his/her knowledge, the offer has been arrived at independently, and is submitted without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement.

Renewal of Agreements

The Agreement with TIPS is for one (1) year with an option for renewal for an additional one (1) consecutive year if both parties agree. TIPS may or may not exercise the one.year extension beyond the base one year term and whether or not to offer the extension is at the sole discretion of TIPS. The scheduled Agreement termination date shall be the last date of the month of the last month of the agreement's legal effect. **Example:** If the agreement is scheduled to end on May 23, the anniversary date of the award, it would actually be extended to May 31 in the last month of the last year the contract is active.

Automatic Renewal Clauses Incorporated in Awarded Vendor Agreements with TIPS Members Resulting from the Solicitation and with the Vendor Named in this Agreement. No Agreement for goods or services with a TIPS Member by the awarded vendor named in this Agreement that results from the solicitation award named in this Agreement, may incorporate an automatic renewal clause with which the TIPS Member must comply. All renewal terms incorporated in an Agreement by the vendor with the TIPS Member shall only be valid and enforceable when the vendor receives written confirmation by purchase order or executed Agreement issued by the TIPS Member for any renewal period. The purpose of this clause is to avoid a TIPS Member inadvertently renewing an Agreement during a period in which the governing body of the TIPS Member has not properly appropriated and budgeted the funds to satisfy the Agreement renewal. This term is not negotiable and any Agreement between a TIPS Member and a TIPS awarded vendor with an automatic renewal clause that conflicts with these terms is rendered void and unenforceable.

Shipments

The Vendor shall ship, deliver or provide ordered products or services within a commercially reasonable time after the receipt of the order from the TIPS Member. If a delay in said delivery is anticipated, the Vendor shall notify TIPS Member as to why delivery is delayed and shall provide an estimated time for completion of the order. TIPS or the requesting entity may cancel the order if estimated delivery time is not acceptable or not as agreed.

Invoices

The awarded vendor shall submit invoices or payment requests to the TIPS Member participating entity clearly stating "Per TIPS Agreement # xxxxxxx or similarly identifying the Agreement. Each invoice or pay request shall include the TIPS Member's purchase order number or other identifying designation as provided in the order by the TIPS Member. If applicable, the shipment tracking number or pertinent information for verification of TIPS Member receipt shall be made available upon request. Non- JOC Vendor Agreement

Payments

The TIPS Member will make payments directly to the Vendor or vendor assigned dealer after receiving invoice or in compliance with applicable statute, whichever is the greater time or as otherwise provided by an agreement of the parties.

Pricing

Price increases will be honored according to the terms of the solicitation. All pricing submitted to TIPS shall include the participation fee, as provided in the solicitation, to be remitted to TIPS by the Vendor. Vendor will not show adding the fee to the invoice presented to TIPS Member customer. Failure to render the participation fee to TIPS shall constitute a breach of this agreement and shall be grounds for termination of this agreement and any other agreement held with TIPS.

Participation Fees

The Participation Fee that was published as part of the Solicitation and the fee published is the legally effective fee, along with any Fee conditions stated in the RFP. Collection of the fees by TIPS is required under Texas Government Code §791.011 Et seq. Vendor or vendor assigned dealer Agreements to pay the participation fee for all Agreement sales to TIPS on a monthly scheduled report or as otherwise agreed by the parties. Vendor must login to the TIPS database and use the "Submission Report" section to report sales. The Vendor or vendor assigned dealers are responsible for keeping record of all sales that go through the TIPS Agreement and submitting same to TIPS.

Failure to pay the participation fee will result in termination of Agreement and possible legal action. Please contact TIPS at tips@tips-usa.com or call (866) 839-8477 if you have questions about paying fees.

Indemnity

The Vendor agrees to indemnify and hold harmless and defend TIPS, TIPS Member(s), officers and employees from and against all claims and suits by third parties for damages, injuries to persons (including death), property damages, losses, and expenses including court costs and reasonable attorney's fees, arising out of, or resulting from, Vendor's work under this Agreement, including all such causes of action based upon common, constitutional, or statutory law, or based in whole or in part, upon allegations of negligent or intentional acts on the part of the Vendor, its officers, employees, agents, subcontractors, licensees, or invitees. Parties found liable shall pay their proportionate share of damages as agreed by the parties or as ordered by a court of competent jurisdiction over the case. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED BY TIPS/ESC Region 8. Per Texas Education Code §44.032(f), and pursuant to its requirements only, reasonable Attorney's fees are recoverable by the prevailing party in any dispute resulting in litigation.

State of Texas Franchise Tax

By signature hereon, the bidder hereby certifies that he/she is not currently delinquent in the payment of any franchise taxes owed the State of Texas under Chapter 171, Tax Code.

Miscellaneous

The Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS sole discretion and that any Vendor may be removed from the participation in the Program at any time with or without cause. Nothing in the Agreement or in any other communication between TIPS and the Vendor may be construed as a guarantee that TIPS or TIPS Members will submit any orders at any time. TIPS reserves the right to request additional proposals for items or services already on Agreement at any time.

Purchase Order Pricing/Product Deviation

If a deviation of pricing/product on a purchase order or contract modification occurs, TIPS is to be notified within 48 hours of receipt of order.

Termination for Convenience

TIPS reserves the right to terminate this agreement for cause or no cause for convenience with a thirty-day written notice. Termination for convenience is required under Federal Regulations 2 CFR part 200. All purchase orders presented to the Vendor by a TIPS Member prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. The awarded vendor may terminate the agreement with ninety (90) days written notice to TIPS 4845 US Hwy North, Pittsburg, Texas 75686. The vendor will be paid for goods and services delivered prior to the termination provided that the goods and services were delivered in accordance with the terms and conditions of the terminated agreement.

TIPS Member Purchasing Procedures

Purchase orders or their equal are issued by participating TIPS Member to the awarded vendor and should indicate on the order that the purchase is per the applicable TIPS Agreement number. Orders are typically emailed to TIPS at tipspo@tips-usa.com.

- Awarded vendor delivers goods/services directly to the participating member.
- Awarded vendor invoices the participating TIPS Member directly.
- Awarded vendor receives payment directly from the participating member.
- Awarded vendor reports sales monthly to TIPS (unless prior arrangements have been made with TIPS for an alternative submission schedule).

Licenses

Awarded vendor shall maintain in current status all federal, state and local licenses, bonds and permits required for the operation of the business conducted by awarded vendor. Awarded vendor shall remain fully informed of and in compliance with all ordinances and regulations pertaining to the lawful provision of goods or services under the Agreement. TIPS and TIS Members reserves the right to stop work and/or cancel Agreement of any awarded vendor whose license(s) expire, lapse, are suspended or terminated subject to a 30-day cure period unless prohibited by applicable statue or regulation.

Novation

If awarded vendor sells or transfers all assets or the entire portion of the assets used to perform this Agreement, a successor in interest must guarantee to perform all obligations under this Agreement. A simple change of name agreement will not change the Agreement obligations of awarded vendor.

Site Requirements (only when applicable to service or job)

Cleanup: Awarded vendor shall clean up and remove all debris and rubbish resulting from their work as required or directed by TIPS Member. Upon completion of work, the premises shall be left in good repair and an orderly, neat, clean and unobstructed condition.

Preparation: Awarded vendor shall not begin a project for which TIPS Member has not prepared the site, unless awarded vendor does the preparation work at no cost, or until TIPS Member includes the cost of site preparation in a purchase order.

Site preparation includes, but is not limited to: moving furniture, installing wiring for networks or power, and similar pre-installation requirements.

Registered sex offender restrictions: For work to be performed at schools, awarded vendor agrees that no employee of a sub-contractor who has been adjudicated to be a registered sex offender will perform work at any time when students are, or reasonably expected to be, present. Awarded vendor agrees that a violation of this condition shall be considered a material breach and may result in the cancellation of the purchase order at the TIPS Member's discretion.

Awarded vendor must identify any additional costs associated with compliance of this term. If no costs are specified, compliance with this term will be provided at no additional charge. Safety measures: Awarded vendor shall take all reasonable precautions for the safety of employees on the worksite, and shall erect and properly maintain all necessary safeguards for protection of workers and the public. Awarded vendor shall post warning signs against all hazards created by the operation and work in progress. Proper precautions shall be taken pursuant to state law and standard practices to protect workers, general public and existing structures from injury or damage.

Smoking

Persons working under Agreement shall adhere to the TIPS Member's or local smoking statutes, codes or policies.

Marketing

Awarded vendor agrees to allow TIPS to use their name and logo within TIPS website, marketing materials and advertisement subject to any reasonable restrictions provided to TIPS in the Proposal to the Solicitation. The Vendor may submit an acceptable use directive for Vendor's names and logos whit which TIPS agrees to comply. Any use of TIPS name and logo or any form of publicity, inclusive of press release, regarding this Agreement by awarded vendor must have prior approval from TIPS which will not be unreasonably withheld. Supplemental agreements

The TIPS Member entity participating in the TIPS Agreement and awarded vendor may enter into a separate supplemental agreement or contract to further define the level of service requirements over and above the minimum defined in this Agreement i.e. invoice requirements, ordering requirements, specialized delivery, etc. Any supplemental agreement or contract developed as a result of this Agreement is exclusively between the participating entity and awarded vendor. TIPS, its agents, TIPS Members and employees shall not be made party to any claim for breach of such agreement unless named and agreed by the Party in question in writing in the agreement. If a vendor submitting a Proposal requires TIPS and/or TIPS Member to sign an additional agreement, those agreements shall comply with the award made by TIPS to the Vendor. Supplemental Vendor's Agreement documents may not become part of TIPS's Agreement with vendor unless and until an authorized representative of TIPS reviews and approves it. TIPS permits TIPS Members to negotiate additional terms and conditions with the Vendor for the provision of goods or services under the Vendor's TIPS Agreement.

Survival Clause

All applicable agreements, contracts, software license agreements, warranties or service agreements that were entered into between Vendor and TIPS or the TIPS Member Customer under the terms and conditions of this Agreement shall survive the expiration or termination of this Agreement. All Orders, Purchase Orders issued or contracts executed by TIPS or a TIPS Member and accepted by the Vendor prior to the expiration or termination of this agreement, shall survive expiration or termination of the Agreement, subject to previously agreed terms and conditions agreed by the parties or as otherwise specified herein relating to termination of this agreement.

Legal obligations

It is the responding vendor's responsibility to be aware of and comply with all local, state and federal laws governing the sale of products/services identified in this Solicitation and any awarded Agreement thereof. Applicable laws and regulations must be followed even if not specifically identified herein.

Audit rights

Due to transparency statutes and public accountability requirements of TIPS and TIPS Members', the awarded Vendor shall, at their sole expense, maintain appropriate due diligence of all purchases made by TIPS Member that utilizes this Agreement. TIPS and Region 8 ESC each reserve the right to audit the accounting of TIPS related purchases for a period of three (3) years from the time such purchases are made. This audit right shall survive termination of this Agreement for a period of one (1) year from the effective date of termination. In order to ensure and confirm compliance with this agreement, TIPS shall have authority to conduct audits of Awarded Vendor's pricing that is offered to TIPS Members with 30 days' notice unless the audit is ordered by a Court Order or by a Government Agency with authority to do so without notice. Notwithstanding the foregoing, in the event that TIPS is made aware of any pricing

being offered to eligible entities that is materially inconsistent with the pricing under this agreement, TIPS shall have the ability to conduct the audit internally or may engage a third-party auditing firm to investigate any possible non-complying conduct or may terminate the Agreement according to the terms of this Agreement. In the event of an audit, the requested materials shall be reasonably provided in the time, format and at the location acceptable to Region 8 ESC or TIPS.

Force Majeure

If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement then such party shall give notice and fully particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch.

Project Delivery Order Procedures

The TIPS Member having approved and signed an interlocal agreement, or other TIPS Membership document, may make a request of the awarded vendor under this Agreement when the TIPS Member desires goods or services awarded to the Vendor. Notification may occur via phone, the web, courier, email, fax, or in person. Upon notification of a pending request, the awarded vendor shall acknowledge the TIPS Member's request as soon as possible, but must make contact with the TIPS Member within two working days.

Status of TIPS Members as Related to This Agreement

TIPS Members stand in the place of TIPS as related to this agreement and have the same access to the proposal information and all related documents. TIPS Members have all the same rights under the awarded Agreement as TIPS.

Vendor's Resellers as Related to This Agreement

Vendor's Named Resellers under this Agreement shall comply with all terms and conditions of this agreement and all addenda or incorporated documents. All actions related to sales by Authorized Vendor's Resellers under this Agreement are the responsibility of the Awarded Vendor.

Support Requirements

If there is a dispute between the awarded vendor and TIPS Member, TIPS or its representatives will assist in conflict resolution or third party if requested by either party. TIPS, or its representatives, reserves the right to inspect any project and audit the awarded vendors TIPS project files, documentation and correspondence related to the requesting Member's order. If there are confidentiality requirements by either party, TIPS shall comply to the extent permitted by law.

Defined STEM Summary

Overview

Teachers are asked to have lessons that are engaging and relevant, cross-curricular, focus on 21st century skills, differentiate learning, incorporate non-fiction reading and writing and provide an authentic assessment of their students understanding. We see this as the core fundamental of what STEM education is all about and Defined STEM strives to bring this type of learning to each teacher and student in a school.

Defined STEM, a web-based, always available, PreK-12, project-based learning platform, combines a number of different content types that accentuate the educational strategies of STEM education. Real-World Videos set the stage for each lesson by showing the practical application of educational concepts within a company/industry. Performance Task built around the specific job/industry ask the students to apply the knowledge learned in a real world unpredictable situations. Literacy Tasks ask students to read, synthesize and write informative and/or position papers around the real world career based topic.

Defined STEM Video Resources

Defined STEM provides a wealth of video resources that provide relevance and contextual applications for content areas including science, technology, mathematics, engineering, social studies, health and the arts and humanities. The videos are designed to provide students with an opportunity to view careers based upon the content knowledge and skills necessary to succeed within the career.

The video resources are typically between two and eight minutes in length. Through the video, students are introduced to an individual and/or individuals sharing their activities on a daily basis and connecting these activities to the critical content and skills necessary to succeed. Students are able to view applications of content that often answer the question; "Why do I need to know this?"

Videos provide students with the environment in which the individual works and initiates a sensory experience that allows concepts to actually be "experienced" and come to life.

Each video has an associated Objective, which provides a learning objective based upon the content found within the video. Guiding Questions are present that can be utilized as part of whole group instruction to lead class discussion related to the content and concepts within the video. These questions also provide the opportunity for the educator to connect the video to the lesson plan being presented and the desired learning outcomes. Additionally, the guiding questions may be used as an individual assessment to measure student participation and understanding.

The objective and guiding questions allow the educator to focus the active viewing and give the students "look fors" to consider during the video. To enhance the experience, the educator may encourage students to work together and have them additionally consider ideas such as:

- o Gender, age and education of the individual;
- o Work environment:
- o Utilization of 21st Century Learning & Innovation Skills; and
- o Required content & conceptual knowledge

The video and these types of interaction can stimulate student interest and motivation. Accompanying the videos are associated Performance Tasks and Language Tasks.



Performance Task

Introduction - The performance task can serve as an authentic assessment that can be utilized by taking into consideration the many different ways that students learn. Each performance task provides many opportunities for students to demonstrate understanding. Since the "one size fits all" classroom minimizes student success, both the performance task and associated content have been designed to provide opportunities for all learners based upon the teacher's knowledge of his/her students. Supporting the performance task are videos, simulations, and learning connections meant to support mixed ability levels, interests, and foundational knowledge.

Structure - The performance task is based upon the G.R.A.S.P.S. template utilized as part of the "Understanding by Design" framework. The task can guide instruction and allow the educator to serve as facilitator or the task can serve an activity that allows students to demonstrate understandings through relevant utilization of standards-based content, concepts, and skills. Performance tasks are aligned with Guiding and Essential Questions and associated Big Ideas that consider student knowledge and understanding.

Each performance task begins with a Goal. The goal provides the student with the outcome of the learning experience and the contextual purpose of the experience and product creation.

The Role is meant to provide the student with the position or individual persona that they will become to accomplish the goal of the performance task. The majority of roles found within the tasks provide opportunities for students to complete real-world applications of standards-based content.

The role may be for one student or in many instances can serve as a small group experience. Students may work together or assume a part of the role based upon group dynamics. These roles will require student(s) to develop creative and innovative products demonstrating their understanding of the content through the application of the content and a variety of skills across disciplines.

The performance tasks contain an Audience component. The audience is the individual(s) who are interested in the findings and products that have been created. These people will make a decision based upon the products and presentations created by the individual(s) assuming the role within the task.

The Situation provides the participants with a contextual background for the task. Students will learn about the real-world application for the task. Additionally, this section builds connections with other sections of Defined STEM. This is the place that may invite students to consider various video resources, simulations, language tasks, and associated websites when appropriate.

This section of the performance task will help the students connect the authentic experience with content and concepts critical to understanding.

<u>Assessment</u> - The Products within each task are designed using the multiple intelligences. The products provide various opportunities for students to demonstrate understanding. Based upon each individual learner and/or individual class, the educator can make appropriate instructional decisions for product development.

These considerations may include:

- o having a student complete all products within a task;
- having students complete a number of products based upon content application and/or student interest;



- o having a student complete certain products based upon the educator's decision to maximize content, concept, and skill application;
- having student work as part of a cooperative group to complete a product or the products;
 and/or
- o having students complete products based upon the strength of their multiple intelligences.

Each task contains between four and six products for development consideration. The products are meant to provide students with experiences aligned with 21st Century Learning and Innovation Skills. Additionally, each task contains at least one product that requires the utilization of a technology-based experience. This provides the student with experiential learning opportunities based upon software and web resources and the application of these tools to demonstrate their knowledge and understanding. As well, there is at least one product per task that provides students the opportunity to connect non-fiction reading assignments and research-based writing assignments with the specified curriculum.

The products provided within each task are closely aligned with the multiple intelligences and the set of products within the task will help educators meet a number of multiple intelligences.

Rubrics and Exemplars are present for each of the products within the task. This can help the educator communicate what is to be created and a general sample of the product. All rubrics are designed on a 1-4 scale and exemplars are present at the 3 and 4 level.

The rubrics present are product rubrics. Educators can add appropriate traits related to standards-based content. Through the technology within Defined STEM, educators can manipulate each rubric as they desire.

Language Task

<u>Introduction</u> - The language tasks are designed to allow students to produce narrative writing pieces that are connected with content areas and relevant issues. The tasks provide online informational and argumentative resources for students to review prior to engaging in the writing process. All of the language tasks are designed using a similar template. Two types of language tasks are present. The tasks are either informational or argumentative. Each task contains a scoring guide aligned with the TEKS.

<u>Task Structure</u> - The language task begins by providing the student with a Background of the topic to be considered. The first paragraph is designed to set the stage with a brief description of the content and the ideas to be brought forth through the learning experience.

The second paragraph contains a number of questions based upon the provided resources. Each question asks the student to consider the information provided within the resources. Students can use these questions and the answers to the questions to help focus their writing. The questions provide the educator with a good measure to determine completion of the assigned reading and knowledge of student comprehension of what was read and the content within the reading.

The third paragraph reiterates the content and topic to be considered. It additionally provides the students with an idea to consider that extends the topic being discussed.

The Language Prompt contextualizes the writing to be completed. The student is asked to write a technical report (Informational) or a position paper (Argumentative) with the audience that the student is writing for provided.

The informational tasks ask the student to consider the evidence provided within the research and the implications that can be drawn from the findings. The completed product provides the student with



deeper knowledge of the content and real world applications for the content and concepts. The teacher can set the parameters for the writing based upon student knowledge, skills, writing ability, and grade level.

The argumentative tasks ask the students to consider a topic and determine their point of view. Most tasks ask the student to support or reject an idea or choose a side to a debate. The students are asked to use the research to support their discussion and point of view. They are also asked to consider the potential implications from their decision. The teacher can set the parameters for the writing based upon student knowledge, skills, writing ability, and grade level.

Each language task contains a number of resources that might include newspaper articles, scientific journals, magazine articles, periodicals, text-based web resources, and governmental products. Each task typically has between five and eight different resources. The resources are designed to provide a variety of depth and reading level to meet the needs of most learners. Educators may choose to use all of the resources provided or they can choose a number of resources that best meet the needs of the student. Questions within the background are designed to encourage the student to consider certain points and ideas within each resource.

Following the resources section are Tier Three Vocabulary words. These words are specific to each content area and are words that can be found within the provided resources. These words are best learned when a specific need arises and the provided vocabulary can assist the student with content-based comprehension.

<u>Task Assessment</u> - All language tasks are connected to one of two rubrics. The rubrics are Argumentative or Informational based upon the task being completed. The rubrics may be used as they stand or can be adapted through the technology available with the Defined STEM website. Weights and point totals can be added as needed. The students will become familiar with the rubrics as they complete more tasks. This familiarity should help the students become better writers while focusing on content-based reading and writing that deepens their content understanding.

Customization

Each performance task in Defined STEM is fully customizable to meet the needs of your classroom. Scale the task up or down to provide differentiated instruction. Modify the audience or situation to mirror a local real-world scenario. Add or remove products to match your available instruction time. Included rubrics can also be modified or create your own. After customizing, assign the task to your students by sharing a simple URL in the platform of your choice.

As well, using Defined STEM's "Portfolio & Project Manager Manager", a student can create a portfolio for the submission, assessment and tracking of student work. The work can be aligned to a district benchmarks or competency models. These models can be customized by a district or use existing frameworks; such as 21st century, career clusters and all state and national standards, including Texas.



Use in the Classroom

The following strategies are meant to provide educators with specific opportunities for utilizing Defined STEM within the classroom.

<u>Culminating Unit Activity</u> - The performance task presents a problem that is tied to a primary academic standard. The task connects with numerous other academic standards as well. The task contains a number of products that require the student to demonstrate understandings of the academic standard(s). Additionally, through the task the students are answering one or more essential questions that address a big idea. Rubrics are contained within the task to help the educator assess student understanding. The task can serve as the primary or supplementary assessment for student knowledge and skill development.

Interdisciplinary Unit/Cross-Curricular Teaching - The performance task and associated content provide opportunities for students to build their knowledge and skills and understand how the academic areas connect. The tasks provide great opportunities for team teaching and/or culminating activities that can be shared across subjects. Through product creation students will be required to utilize technology, the arts, and language arts to complete a majority of tasks with STEM as the central content. Through the application of 21st century learning and skills, students are engaging in a holistic learning experience designed to help them succeed beyond school.

Independent Learning - The performance task and associated products can be utilized based upon student learning level. The videos and learning connections can provide opportunities for students to link their learning with real-life applications and potential careers. The products within the tasks can be adapted based upon the multiple intelligences or the needs of the individual student. The tasks are strongly aligned with 21st century content and skill development and require the use of technology as part of the product development process. They can help provide motivation for student learning as well help students understand why they need to learn certain content and skills. The inclusion of simulations can help the student understand concepts in an independent environment. Educators may facilitate the learning experience, serve as a guide to student learning, or allow the students to work and complete the task independently.

Enrichment - Defined STEM and the associated learning resources can be utilized to extend learning for student enrichment by addressing content area learning while providing the ability for student autonomy. The videos and learning connections provide background information to help the student gain a foundational understanding of specific skills, content, and applications are to be addressed. The product development process aligns with numerous multiple intelligences and has the student working to demonstrate understanding. Additionally, many of the products created will require the utilization of technology and are closely aligned with 21st century content and skill development. The experiences can be created through classroom learning centers, through differentiated product and process strategies, and by extending the classroom walls.

Project Based Learning - Each performance task contains between three and six products that allow the student to demonstrate his/her understanding of content, concepts, and skills. Simulations in many of the tasks extend student learning and require students to solve problems. The tasks are aligned with academic standards and 21st century learning and innovation skills. The learning experience focuses on student-centered inquiry and group learning with the teacher acting as a facilitator. Many of the potential products require students to use technology as part of product creation. Students are required to create



their own artifacts, individually or as part of a group, as a representation of what they have learned through the teaching and learning process.

<u>Summative Assessment</u> - The performance task and connected content may serve as a summative assessment to monitor student understanding. The task would be best utilized as a culminating activity as part of a larger assessment process that includes formative assessment and more traditional summative assessments. As traditional testing methods measure content and concept knowledge, the performance task requires students to demonstrate understanding of content and concept relevance as part of a holistic learning application.

<u>Inverted Classroom</u> - As opposed to using the traditional strategy of using classroom time to provide lecture and foundational content experience followed by drill and practice as homework, students watch lectures at home through technological tools as well as gain foundational knowledge through textbook and associated resources. Class time is then utilized to work on projects, problems, and products through individualized and group work. This allows students to use class time actively and utilize the educator as a critical facilitator guiding learning and the application of new knowledge and skills.



Professional Development/ Training:

At Defined Learning, we recognized the importance of professional development to improve and advance the character of science, technology, engineering and mathematics (STEM) teaching for students of all grade levels. Defined Learning's Implementation and On-Site Professional Development (PD) team is dedicated to providing comprehensive training on Defined STEM and teaching strategies for project-based learning within the classroom. Implementation & On-going support

As an LTI tool provider, Defined STEM can be integrated with LMS LTI consumers. Many LMSs (for example Moodle, Canvas, Desire2Learn, OpenED, Blackboard, and Sakai) are LTI compliant. LTI (Learning Tools Interoperability™) is an initiative created by the IMS Global Learning Consortium using a standard protocol, which enables linkage of Defined STEM resources or assignments and an institution's LMS system. As well; Defined STEM supports Clever and Roster.

However, if district is not using a management system, then Defined Learning will set up building level access provided district delivers a roster in either a ".csv" or ".xls" format.
