TIPS VENDOR AGREEMENT

TIPS RFP 230703 Staffing Services

The following Vendor Agreement ("Agreement") creates a legal agreement between The Interlocal Purchasing System ("TIPS"), a government purchasing cooperative and Department of Texas Region 8 Education Service Center and (INSERT ENTITY NAME):

St. Vincent DePaul Rehabilitation Service of Texas, Inc.

(ENTER ENTITY NAME)

its owners, agents, subsidiaries, and affiliates (together, "Vendor") (individually, "Party", and collectively the "Parties") and this agreement shall exclusively govern the contractual relationship ("Agreement") between the Parties.

TIPS, a governmental entity and a national purchasing cooperative seeks to provide a valuable and necessary solution to public entities and qualifying non-profits by performing the public procurement solicitation process and awarding compliant contracts to qualified vendors. Then, where the law of a customer's jurisdiction allows, instead of public entities and qualifying non-profits expending time, money, and resources on the extensive public procurement process, the use of TIPS allows public entities to quickly select and purchase their preferred products or services from qualified, competitively evaluated vendors through cooperative purchasing.

- 1. Purpose. The purpose of this Agreement is to identify the terms and conditions of the relationship between TIPS and Vendor. Public entities and qualifying non-profits that properly join or utilize TIPS ("TIPS Members") may elect to "piggyback" off of TIPS' procurements and agreements where the laws of their jurisdiction allow. TIPS Members are not contractual parties to this Agreement although terms and conditions of this Agreement may ensure benefits to TIPS Members.
- 2. Authority. The Parties agree that the signatories below are individual authorized to enter into this Agreement on behalf of their entity and that they are acting under due and proper authority under applicable law.
- 3. Definitions.
 - a. **TIPS Pricing:** The specific pricing, discounts, and other pricing terms and incentives which Vendor submitted and TIPS approved for each respective TIPS Contract awarded to Vendor and all permissible, subsequent pricing updates submitted by Vendor and accepted by TIPS, if any.
 - b. **Authorized Reseller:** A reseller or dealer authorized and added by a Vendor through their online TIPS Vendor Portal to make TIPS sales according to the terms and conditions herein.
- 4. Entire Agreement. This Agreement resulted from TIPS posting a "TIPS Solicitation" (RFP, RCSP, RFQ, or other) and Vendor submitting a proposal in response to that posted TIPS Solicitation for evaluation and award. The Parties agree that this Agreement consists of the provisions set forth herein and: (1) The TIPS solicitation document resulting in this Agreement; (2) Any addenda or clarifications issued in relation to the TIPS solicitation; (3) All solicitation information provided to Vendor by TIPS through the TIPS eBid System; (3) Vendor's entire proposal response to the TIPS solicitation including all accepted required attachments, acknowledged notices and certifications, accepted negotiated terms, pricing, accepted responses to questions, and accepted written clarifications of Vendor's proposal, and; any properly included attachments to this Agreement. All documentation and information listed is hereby incorporated by reference as if set forth herein verbatim. In the event of conflict between the terms herein and one of the incorporated documents the terms and conditions herein shall control.
- 5. Vendor's Specific Warranties, Terms, and License Agreements. Because TIPS serves public entities and non-profits throughout the nation all of which are subject to specific laws and policies of their jurisdiction, as a matter of standard practice, TIPS does not typically accept a Vendor's specific "Sale Terms" (warranties, license agreements, master agreements, terms and conditions, etc.) on behalf of all TIPS Members. TIPS may permit Vendor to attach those to this Agreement to display to interested customers what terms may apply to their Supplemental Agreement with Vendor (if submitted by Vendor for that purpose). However, unless this term of the Agreement is negotiated and modified to state otherwise, those specific Sale Terms are not accepted by TIPS on behalf of all TIPS Members and each Member may choose whether to accept, negotiate, or reject those specific Sale Terms, which must be reflected in a separate agreement between Vendor and the Member in order to be effective.

- 6. Vendor Identity and Contact Information. It is Vendor's sole responsibility to ensure that all identifying vendor information (name, EIN, d/b/a's, etc.) and contact information is updated and current at all times within the TIPS eBid System and the TIPS Vendor Portal. It is Vendor's sole responsibility to confirm that all e-correspondence issued from tips-usa.com, ionwave.net, and tipsconstruction.com to Vendor's contacts are received and are not blocked by firewall or other technology security. Failure to permit receipt of correspondence from these domains and failure to keep vendor identity and contact information current at all times during the life of the contract may cause loss of TIPS Sales, accumulating TIPS fees, missed rebid opportunities, lapse of TIPS Contract(s), and unnecessary collection or legal actions against Vendor. It is no defense to any of the foregoing or any breach of this Agreement that Vendor was not receiving TIPS' electronic communications issued by TIPS to Vendor's listed contacts.
- 7. Initiation of TIPS Sales. When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Once verified, Vendor must include the TIPS Contract Number on all purchase communications and sales documents exchanged with the TIPS Member.
- 8. TIPS Sales and Supplemental Agreements. The terms of the specific TIPS order, including but not limited to: shipping, freight, insurance, delivery, fees, bonding, cost, delivery expectations and location, returns, refunds, terms, conditions, cancellations, order assistance, etc., shall be controlled by the purchase agreement (Purchase Order, Contract, Invoice, etc.) (hereinafter "Supplemental Agreement") entered into between the TIPS Member Customer and Vendor only. TIPS is not a party to any Supplemental Agreement. All Supplemental Agreements shall include Vendor's Name, as known to TIPS, and TIPS Contract Name and Number. Vendor accepts and understands that TIPS is not a legal party to TIPS Sales and Vendor is solely responsible for identifying fraud, mistakes, unacceptable terms, or misrepresentations for the specific order prior to accepting. Vendor agrees that any order issued from a customer to Vendor, even when processed through TIPS, constitutes a legal contract between the customer and Vendor only. When Vendor accepts or fulfills an order, even when processed through TIPS, Vendor is representing that Vendor has carefully reviewed the order for legality, authenticity, and accuracy and TIPS shall not be liable or responsible for the same. In the event of a conflict between the terms of this TIPS Vendor Agreement and those contained in any Supplemental Agreement, the provisions set forth herein shall control unless otherwise agreed to and authorized by the Parties in writing within the Supplemental Agreement.
- 9. **Right of Refusal.** Vendor has the right not to sell to a TIPS Member under the awarded agreement at Vendor's discretion unless otherwise required by law.
- 10. Reporting TIPS Sales. Vendor must report all TIPS Sales to TIPS. If a TIPS sale is initiated by Vendor receiving a TIPS Member's purchase order from TIPS directly, Vendor may consider that specific TIPS Sale reported. Otherwise, with the exception of TIPS Automated Vendors, who have signed an exclusive agreement with TIPS regarding reporting, all TIPS Sales must be reported to TIPS by either: (1) Emailing the purchase order or similar purchase document (with Vendor's Name, as known to TIPS, and the TIPS Contract Name and Number included) to TIPS at tipspo@tips-usa.com with "Confirmation Only" in the subject line of the email within three business days of Vendor's acceptance of the order, or; (2) Within 3 business days of the order being accepted by Vendor, Vendor must login to the TIPS Vendor Portal and successfully self-report all necessary sale information within the Vendor Portal and confirm that it shows up accurately on your current Vendor Portal statement. No other method of reporting is acceptable unless agreed to by the Parties in writing. Failure to report all sales pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion. Please refer to the TIPS Accounting FAQ's for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com.
- 11. TIPS Administration Fees. The collection of administrative fees by TIPS, a government entity, for performance of these procurement services is required pursuant to Texas Government Code Section 791.011 et. seq. The administration fee ("TIPS Administration Fee") is the amount legally owed by Vendor to TIPS for TIPS Sales made by Vendor. The TIPS Administration Fee amount is typically a set percentage of the amount paid by the TIPS Member for each TIPS Sale, less shipping cost, bond cost, and taxes if applicable and identifiable, which is legally due to TIPS, but the exact TIPS Administration Fee for this Contract is published in the corresponding solicitation and is incorporated herein by reference. TIPS Administration Fees are due to TIPS immediately upon Vendor's receipt of payment, including partial payment, for a TIPS Sale. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. Upon receipt of payment for a TIPS Sale, including partial payment (which renders TIPS Administration Fees immediately due), Vendor shall issue to TIPS the corresponding TIPS Administration Fee payment as soon as possible but not later than thirty-one calendar days following Vendor's receipt of payment. Vendor shall pay TIPS via check unless otherwise agreed to by the Parties in writing. Vendor shall include clear documentation with the issued payment dictating to which sale(s) the amount should be applied. Vendor may create a payment report within their TIPS Vendor Portal which is the preferred documentation dictating to which TIPS Sale(s) the amount should be applied. Failure to pay all TIPS Administration Fees pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion as well as the initiation of collection and legal actions by TIPS against Vendor to the extent permitted by law. Any overpayment of participation fees to TIPS by Vendor will be refunded to the Vendor

within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date that TIPS received the payment will render the overpayment non-refundable. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect TIPS Administration Fees due to TIPS pursuant to this Agreement.

12. Term of the Agreement. This Agreement with TIPS is for approximately three years with a one-year, consecutive option for renewal as described herein. Renewal options are not automatic and shall only be effective if offered by TIPS at its sole discretion. If TIPS offers a renewal option, the Vendor will be notified via email issued to Vendor's then-listed Primary Contact. The renewal option shall be deemed accepted by Vendor unless Vendor notifies TIPS of its objection to the renewal option in writing and confirms receipt by TIPS.

Actual Effective Date: Agreement is effective upon signature by authorized representatives of both Parties. The Effective Date does not affect the "Term Calculation Start Date."

Term Calculation Start Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, Vendor shall calculate the foregoing term as starting on the last day of the month that "Award Notifications" are anticipated as published in the Solicitation, regardless of the actual Effective Date.

Example of Term Calculation Start Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 in this example.

Contract Expiration Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, the term expiration date shall be three-years from the Term Calculation Start Date.

Example of Contract Expiration Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023, and the Contract Expiration Date of the resulting initial "three-year" term, (which is subject to an extension(s)) will be May 31, 2026 in this example.

Option(s) for Renewal: Any option(s) for renewal shall begin on the Contract Expiration Date, or the date of the expiration of the prior renewal term where applicable, and continue for the duration specified for the renewal option herein.

Example of Option(s) for Renewal: In this example, if TIPS offers a one-year renewal and the Contract Expiration Date is May 31, 2026, then the one-year renewal is effective from May 31, 2026, to May 31, 2027.

TIPS may offer to extend Vendor Agreements to the fullest extent the TIPS Solicitation resulting in this Agreement permits.

- 13. TIPS Pricing. Vendor agrees and understands that for each TIPS Contract that it holds, Vendor submitted, agreed to, and received TIPS' approval for specific pricing, discounts, and other pricing terms and incentives which make up Vendor's TIPS Pricing for that TIPS Contract ("TIPS Pricing"). Vendor confirms that Vendor will not add the TIPS Administration Fee as a charge or line-item in a TIPS Sale. Vendor hereby certifies that Vendor shall only offer goods and services through this TIPS Contract if those goods and services are included in or added to Vendor's TIPS Pricing and approved by TIPS. TIPS reserves the right to review Vendor's pricing update requests as specifically as line-item by line-item to determine compliance. However, Vendor contractually agrees that all submitted pricing updates shall be within the original terms of the Vendor's TIPS Pricing (scope, proposed discounts, price increase limitations, and other pricing terms and incentives originally proposed by Vendor) such that TIPS may accept Vendors price increase requests as submitted without additional vetting at TIPS discretion. Any pricing quoted by Vendor to a TIPS Member or on a TIPS Quote shall never exceed Vendor's TIPS Pricing for any good or service offered through TIPS. TIPS Pricing price increases and modifications, if permitted, will be honored according to the terms of the solicitation and Vendor's proposal, incorporated herein by reference.
- 14. Indemnification of TIPS. VENDOR AGREES TO INDEMNIFY, HOLD HARMLESS, AND DEFEND TIPS, TIPS MEMBERS, TIPS OFFICERS, TIPS EMPLOYEES, TIPS DIRECTORS, AND TIPS TRUSTEES (THE "TIPS INDEMNITEES") FROM AND AGAINST ALL CLAIMS AND SUITS BY THIRD-PARTIES FOR DAMAGES, INJURIES TO PERSONS (INCLUDING DEATH), PROPERTY DAMAGES, LOSSES, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES, ARISING OUT OF OR RELATING TO VENDOR'S PERFORMANCE UNDER THIS AGREEMENT (INCLUDING THE PERFORMANCE OF VENDOR'S OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES), REGARDLESS OF THE NATURE OF THE CAUSE OF ACTION, INCLUDING WITHOUT LIMITATION CAUSES OF ACTION BASED UPON COMMON, CONSTITUTIONAL, OR STATUTORY LAW OR BASED IN

WHOLE OR IN PART UPON ALLEGATIONS OF NEGLIGENT OR INTENTIONAL ACTS OR OMISSIONS ON THE PART OF VENDOR, ITS OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED TO BY TIPS. APART FROM THIS INDEMNIFICATION PROVISION REQUIRING INDEMNIFICATION OF THE TIPS INDEMNITEES' ATTORNEY'S FEES AS SET FORTH ABOVE, RECOVERY OF ATTORNEYS' FEES BY THE PREVAILING PARTY IS AUTHORIZED ONLY IF AUTHORIZED BY TEX. EDUC. CODE § 44.032(F).

- 15. Indemnification and Assumption of Risk Vendor Data. Vendor Agrees that it is voluntarily providing data (including but not limited to: Vendor information, Vendor documentation, Vendor's proposals, Vendor pricing submitted or provided to TIPS, TIPS contract documents, TIPS correspondence, Vendor logos and images, Vendor's contact information, Vendor's brochures and commercial information, Vendor's financial information, Vendor's certifications, and any other Vendor information or documentation, including without limitation software and source code utilized by Vendor, submitted to TIPS by Vendor and its agents) ("Vendor Data") to TIPS. For the sake of clarity, and without limiting the breadth of the indemnity obligations in Section 14 above, Vendor agrees to protect, indemnify, and hold the TIPS Indemnitees harmless from and against any and all losses, claims, actions, demands, allegations, suits, judgments, costs, expenses, fees, including court costs, attorney's fees, and expert fees and all other liability of any nature whatsoever arising out of or relating to: (i) Any unauthorized, negligent or wrongful use of, or cyber data breach incident and viruses or other corrupting agents involving, Vendor's Data, pricing, and information, computers, or other hardware or software systems, and; (ii) allegations or claims that any Vendor Data infringes on the intellectual property rights of a third-party or Vendor.
- 16. Procedures Related to Indemnification. In the event that an indemnity obligation arises, Vendor shall pay all amounts set forth in Section 14 and 15 above (including any settlements) and if it has accepted its indemnity obligation without qualification control the legal defense to such claim or cause of action, including without limitation attorney selection, strategy, discovery, trial, appeal, and settlement, and TIPS shall, at Vendor's cost and expense (with respect to reasonable out of pocket costs and expenses incurred by TIPS which shall be reimbursed to TIPS by Vendor), provide all commercially reasonable assistance requested by Vendor. In controlling any defense, Vendor shall ensure that all assertions of governmental immunity and all applicable pleas and defenses shall be promptly asserted.
- 17. Indemnity for Underlying Sales and Supplemental Agreements. Vendor shall be solely responsible for any customer claims or any disputes arising out of TIPS Sales or any Supplemental Agreement as if sold in the open-market. The Parties agree that TIPS shall not be liable for any claims arising out of Vendor's TIPS Sales or Supplemental Agreements, including but not limited to: allegations of product defect or insufficiency, allegations of service defect or insufficiency, allegations regarding delivery defect or insufficiency, allegations of fraud or misrepresentation, allegations regarding pricing or amounts owed for TIPS sales, and/or allegations regarding payment, over-payment, under-payment, or non-payment for TIPS Sales. Payment/Drafting, overpayment/over-drafting, under-payment/under-drafting, or non-payment for TIPS Sales between customer and Vendor and inspections, rejections, or acceptance of such purchases shall be the exclusive respective obligations of Vendor/Customer, and disputes shall be handled in accordance with the terms of the underlying Supplemental Agreement(s) entered into between Vendor and Customer. Vendor acknowledges that TIPS is not a dealer, subcontractor, agent, or reseller of Vendor's goods and services and shall not be responsible for any claims arising out of alleged insufficiencies or defects in Vendor's goods and services, should any arise.
- 18. Confidentiality of Vendor Data. Vendor understands and agrees that by signing this Agreement, all Vendor Data is hereby released to TIPS, TIPS Members, and TIPS third-party administrators to effectuate Vendor's TIPS Contract except as provided for herein. The Parties agree that Vendor Data is accessible by all TIPS Members as if submitted directly to that TIPS Member Customer for purchase consideration. If Vendor otherwise considers any portion of Vendor's Data to be confidential and not subject to public disclosure pursuant to Chapter 552 Texas Gov't Code (the "Public Information Act") or other law(s) and orders, Vendor must have identified the claimed confidential materials through proper execution of the Confidentiality Claim Form which is required to be submitted as part of Vendor's proposal resulting in this Agreement and incorporated by reference. The Confidentiality Claim Form included in Vendor's proposal and incorporated herein by reference is the sole indicator of whether Vendor considers any Vendor Data confidential in the event TIPS receives a Public Information Request. If TIPS receives a request, any responsive documentation not deemed confidential by you in this manner will be automatically released. For Vendor Data deemed confidential by you in this manner, TIPS will follow procedures of controlling statute(s) regarding any claim of confidentiality and shall not be liable for any release of information required by law, including Attorney General determination and opinion. In the event that TIPS receives a written request for information pursuant to the Public Information Act that affects Vendor's interest in any information or data furnished to TIPS by Vendor, and TIPS requests an opinion from the Attorney General, Vendor may, at its own option and expense, prepare comments and submit information directly to the Attorney General stating why the requested information is exempt from disclosure pursuant to the requirements of the Public Information Act. Vendor is solely responsible for submitting the memorandum brief and information to the Attorney General

within the time period prescribed by the Public Information Act. Notwithstanding any other information provided in this solicitation or Vendor designation of certain Vendor Data as confidential or proprietary, Vendor's acceptance of this TIPS Vendor Agreement constitutes Vendor's consent to the disclosure of Vendor's Data, including any information deemed confidential or proprietary, to TIPS Members or as ordered by a Court or government agency, including without limitation the Texas Attorney General. Vendor agrees that TIPS shall not be responsible or liable for any use or distribution of information or documentation by TIPS Members or as required by law.

- 19. Vendor's Authorized Resellers. TIPS recognizes that many vendors operate in the open market through the use of resellers or dealers. For that reason, TIPS permits Vendor to authorize Authorized Resellers within its Vendor Portal and make TIPS Sales through the Authorized Reseller(s). Once authorized by Vendor in the Vendor Portal, the Authorized Reseller(s) may make TIPS sales to TIPS Members. However, all purchase documents must include: (1) Authorized Reseller's Name; (2) Vendor's Name, as known to TIPS, and; (3) Vendor's TIPS Contract Name and Number under which it is making the TIPS Sale. Either Vendor or Reseller may report the sale pursuant to the terms herein. However, Vendor agrees that it is legally responsible for all reporting and fee payment as described herein for TIPS Sales made by Authorized Resellers. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. The Parties intend that Vendor shall be responsible and liable for TIPS Sales made by Vendor's Authorized Resellers. Vendor agrees that it is voluntarily authorizing this Authorized Reseller and in doing so, Vendor agrees that it is doing so at its own risk and agrees to protect, indemnify, and hold TIPS harmless in accordance with Sections 14-17 above related to Authorized Reseller TIPS Sales made pursuant to this Agreement or purporting to be made pursuant to this Agreement that may be asserted against Vendor whether rightfully brought or otherwise. The Parties further agree that it is no defense to Vendor's breach of this Agreement that an Authorized Reseller caused Vendor of breach this Agreement.
- 20. Circumvention of TIPS Sales. When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Any request for quote, customer communication, or customer purchase initiated through or referencing a TIPS Contract shall be completed through TIPS pursuant to this Agreement. Any encouragement or participation by Vendor in circumventing a TIPS sale being completed may result in immediate termination of Vendor's TIPS Contract(s) for cause as well as preclusion from future TIPS opportunities at TIPS sole discretion.
- 21. State of Texas Franchise Tax. By signature hereon, Vendor hereby certifies that Vendor is not currently delinquent in the payment of any franchise taxes owed to the State of Texas under Chapter 171 of the Texas Tax Code.

22. Termination.

- A) <u>Termination for Convenience</u>. TIPS may, by written notice to Vendor, terminate this Agreement for convenience, in whole or in part, at any time by giving thirty (30) days' written notice to Vendor of such termination, and specifying the effective date thereof.
- B) Termination for Cause. If Vendor fails to materially perform pursuant to the terms of this Agreement, TIPS shall provide written notice to Vendor specifying the default. If Vendor does not cure such default within thirty (30) days, TIPS may terminate this Agreement, in whole or in part, for cause. If TIPS terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
- C) <u>Vendor's Termination</u>. If TIPS fails to materially perform pursuant to the terms of this Agreement, Vendor shall provide written notice to TIPS specifying the default ('Notice of Default"). If TIPS does not cure such default within thirty (30) days, Vendor may terminate this Agreement, in whole or in part, for cause. If Vendor terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
- D) Upon termination, all TIPS Sale orders previously accepted by Vendor shall be fulfilled and Vendor shall be paid for all TIPS Sales executed pursuant to the applicable terms. All TIPS Sale orders presented to Vendor but not fulfilled by Vendor, prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. TIPS shall submit to Vendor an invoice for any outstanding TIPS Administration Fees and approved expenses and Vendor shall pay such fees and expenses within 30 calendar days of receipt of such valid TIPS invoice. Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS' sole discretion and that any Vendor may be removed from the TIPS program at any time with or without cause. This

- termination clause does not affect TIPS Sales Supplemental Agreements pursuant to this term regarding termination and the Survival Clause term.
- E) Vendor hereby waives any and all claims for damages, including, but not limited, to consequential damages or lost profits, that might arise from TIPS' act of terminating this Agreement.
- 23. Survival Clause. Vendor affirms that, to the best of Vendor's knowledge, this Agreement has been arrived at independently, and is awarded without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement. Vendor agrees that it has disclosed any necessary affiliations with Region 8 Education Service Center and the TIPS Department, if any, through the Conflict of Interest attachment provided in the solicitation resulting in this Agreement.
- **26. Volume of TIPS Sales.** Nothing in this Agreement or any TIPS communication may be construed as a guarantee that TIPS or TIPS Members will submit any TIPS orders to Vendor at any time.
- **27. Compliance with the Law.** The Parties agree to comply fully with all applicable federal, state, and local statutes, ordinances, rules, and regulations applicable to their entity in connection with the programs contemplated under this Agreement.
- 28. Severability. If any term(s) or provision(s) of this Agreement are held by a court of competent jurisdiction to be invalid, void, or unenforceable, then such term(s) or provision(s) shall be deemed restated to reflect the original intention of the Parties as nearly as possible in accordance with applicable law and the remainder of this Agreement, and the remainder of the provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated, unless such holding causes the obligations of the Parties hereto to be impossible to perform or shall render the terms of this Agreement to be inconsistent with the intent of the Parties hereto.
- 29. Force Majeure. If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement through no fault of its own then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon. Upon delivering such notice, the obligation of the affected party, so far as it is affected by such Force Majeure as described, shall be suspended during the continuance of the inability then claimed but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. Hours: Peak Performers mirrors the schedule of the state of Texas government agencies. Our normal hours of operation are 8:00 a.m. - 5:00 p.m., Monday - Friday, and we also observe state holidays.

Staff are available after hours on an emergency, as-needed basis in order to serve the needs of our customers. While the majority of our employees work similar hours to ours, Peak Performers is able to staff roles with different hourly requirements, including shift work.

Department of Public Safety

Roles Filled: Purchaser III (13 positions)

Project: Work involved purchasing and procuring commodities, equipment, and services using guidelines, rules, policies, and laws. Placed 13 purchasers at Department of Public Safety after leading a wide search effort leveraging online marketing and job fairs.

Texas Department of Transportation

Roles Filled: Contract Specialist V (4 positions)

Project: We got a call from a purchasing agent to service an area that was (at the time) outside of our normal business area (San Antonio). Consults with clients on communications needs and coordinates with related businesses on printing and supply needs. Presents and communicates design objectives, concepts and executions to partners and stakeholders across the agency. Ensures compliance with design, brand, legal, and/or accessibility standards/requirements, as required. This candidate was sourced through job boards. This role was a temp to hire position.

Texas Workforce Commission

Roles Filled: Attorneys and Hearings Officers (100+ positions)

Project: During the COVID-19 recession, the Texas Workforce Commission became inundated with job seekers. Over six months, Peak Performers partnered with TWC to recruit for over 100 remote attorneys and hearings officers to oversee escalated unemployment claims and make ruling decisions.

Department of State Health Services

Roles Filled: Customer Service/Administrative Assistants (50+ positions)

Project: As DSHS got overworked with their response to COVID-19, Peak Performers was tasked with finding administrative assistants to help out with maintaining normal agency obligations. Particularly, Peak staff was tasked with finding and updating birth and death certificates.

Overview of Services Offered

Peak Performers seeks to provide TIPS Customers with staffing services in order to augment their existing recruiting process and provide much needed human resources. Here is a breakdown of the services we provide to the customer, listed chronologically in the order they usually happen.

Note: This narrative is focused around temporary staffing, which is the bulk of our business and the primary listed need in this RFP. We also offer direct hire/permanent placement/executive search services and these rates are outlined in pricing document 2.

Advertising: If no one sees your job, it will never get filled. We help broadcast your role across a range of digital, physical, and in-person job marketing events. We post your job to dozens of job boards and then promote it using our vast referral network.

Recruiting: We find qualified people and sell them on the value of joining your organization. This step also involves screening candidates for the required hard and soft skills and making sure their interests align with the organization through an Ability, Willingness, and Want assessment. Then we interview to verify that the candidates are actually good fits for the organization. In the end, from hundreds of resumes you get only a carefully selected pool of candidates who are all qualified to do the work.

Candidate Management: Here, we manage the logistics of arranging interviews for you. Additionally, we field all candidate questions so they don't ask you. Then we help to remove barriers and start selected candidates. Additionally, we inform declined candidates that they were not selected for the role.

Onboarding: Candidates who are selected by the client are onboarded as soon as possible either in person, over the phone, over video chat, or in a pre-filmed video format sent as a link to the candidate. Orientation is conducted in order to finalize paperwork and prepare new starts for their role in the client's organization.

Employer of Record: Peak Performers is the employer of record for all employees. Peak Performers performs all post-offer necessary background checks, eligibility to work verifications, and drug testing (when requested). Peak is also responsible for all costs associated with compensation, health insurance, other benefits, unemployment claims (when applicable), and workers compensation claims (when applicable). Additionally, we provide employment verification services. Peak also deducts and manages all necessary taxes, social security benefits, and medical payments from pay.

Employee Management: Peak handles all hiring and firing for you. We handle providing feedback when employees do not fulfill expectations. When an employee is terminated for cause or there is no longer work, we take ending their assignment and backfilling if requested.

Records Management: Peak Performers handles all records—physical and digital—of employment paperwork, tax documents, timesheets, invoices, and more. We also provide the customer with any reporting requested.

Marketing and Advertising Summary

Peak Performers maintains a strong presence in Texas and has strong brand awareness among those who work in the public sector. In order to maintain this exposure and seek more public awareness, Peak Performers engages in the following marketing activities:

- Peak Performs attends one job seeker-oriented event each week. These vary on the size and number of job seekers but one of our most regularly attended events is the Workforce Solutions Marketplace Job Fair conducted every two weeks. These events see average attendance rates of 200-250 job seekers.
- Once a week we send out a email to our referral network alerting them to our top jobs. We also post our top jobs to social media in a video format for easy distribution.
- Peak Performers maintains a strong social media presence. We currently have nearly 550+ followers on Facebook and 5800+ followers on LinkedIn. We utilize social media marketing to promote our brand, promote disability inclusion, give free information to job seekers, develop client engagement, and to post available jobs.
- Peak Performers maintains a website, peakperformers.org, which is the starting point for many job seekers and the returning point for many customer and current employees. This month we've seen about 10,000 visitors
- To help drive the visitors to our website, Peak Performers utilizes Google AdWords pay-per-click campaigns. Our ads were exposed to about 13 thousand web searches in the last month. We will periodically build AdWords campaigns to attract job seekers for hard-to-find roles or volume orders requiring many qualified candidates.
- Peak Performers also posts our jobs to dozens of different job boards, including ZipRecruiter, Indeed, Monster, WorkinTexas.com, Glassdoor, Google Jobs, and Dice.
- Peak Performers is also extremely mindful of our reputation online and proactively drives towards positive reviews of our services by asking our new starts to rate us online. We listen to feedback and respond to comments both positive and negative.

All of these efforts lead to a healthy pipeline of new job seeking candidates. We recently estimated that we get 1,000+ new job applies and 3,000 job views every week.


Advertising Action Items: Upon receiving a new job, Peak Performers seeks to prepare and publish a job description the same day whenever possible. Job descriptions are distributed through dozens of job boards, including Indeed, ZipRecruiter, and LinkedIn. Recruiters then also contact referral sources who may know people looking for jobs. Finally, recruiters bring informational hand-outs to job fairs to generate interest when talking to job seekers. Further advertising efforts are arranged on a case-by-case basis by the staffing consultant after evaluating the candidate pool. Additional advertising may include physical hand outs and digital (social media or Google AdWords campaigns).

Note: All advertising costs are built into our bill rate. Peak Performers will not charge the agency for any costs in advertising a position.

Recruiting Process Detailed

Phase 1: Pre-recruitment A significant amount of preparatory work goes into being ready to start recruiting. Peak Performers has an expansive database system, Avionte, that allows us to easily track resumes and current employees. Additionally, we have features that allow us to track staffing requests before they are formalized—for example tracking the estimated number of workers to be requested and the required skills. This information is gathered during our periodic client visits and check in calls. Once we get a job order, we partner with the customer to clarify abilities required, write a job description, and commit to a timeline.

Phase 2: Recruitment First we post the job to multiple job boards including Indeed, WorkinTexas.com, Dice (for IT roles), ZipRecruiter, and others. We leverage our expansive referral network of job clubs, job seeking services, and employees past and present to seek out referrals. We then may use social media accounts to drum up more interest. We also review all known candidates to see if anyone might be a fit. When filling hard-to-find positions, our recruiters spend the majority of their time "sourcing" by looking at resumes of candidates on online job boards, leveraging LinkedIn, and using professional organizations and alumni networks to find candidates. This often involves



looking at hundreds of resumes or online profiles based off of keywords that would be specifically listed on target candidate resumes. From here, recruiters screen candidates for abilities and send over a select few to staffing consultants to interview.

Phase 3: Application Review and Referral Once decided, recruiters prepare a packet to send to the client, which often includes the candidates' resumes, a summary of our review of each candidate following their interviews, a questionnaire verifying the number of years of experience they have in each of the required and preferred job categories (for information technology roles), skills tests results (if applicable), and the candidate screening matrix to summarize their discoveries when multiple viable candidates exist.

Skills testing: Candidates may undergo a rigorous series of aptitude tests using our testing software, eskill.com. This software is designed to test over a wide range of skills including: data entry, Microsoft office proficiency (multiple skill levels and multiple software versions), customer service, payroll, programming, graphic design software, AutoCAD, court reporting, human resources, bookkeeping, and translation (over 800 skills-based tests available.)

Background and other checks: Peak Performers current policy is to run a 7-year historical pre-employment background check on all employees at the state and national levels. We also leverage E-Verify to ensure that employees are authorized to work in the United States. When a candidate does not pass the requisite checks, we will restart the recruiting process or present other candidates in the available pool. Upon request we can also conduct reference checks, experience validation checks, and other checks.

Phase 4: After the Referral Recruiters follow-up weekly after they submit candidates. Recruiters help coordinate interview times between the job seeker and client. Also, we will help coordinate any other logistics or communications necessary. From there we will assist with extending the offer, gaining acceptance, and setting a start date. Then we will conduct an orientation with the selected candidate to compliment the client's own onboarding process.

Background and Employment Eligibility Checks

Peak Performers current policy is to run a 7-year historical pre-employment background check on all employees at the state and national levels. We also leverage E-Verify to ensure that employees are authorized to work in the United States. All background checks use a social security number trace. We will also, upon request, conduct FBI fingerprint-based background checks and Department of Public Safety name-based searches (using IdentoGo).

Many of our current customers have specific pass/fail criteria for background checks. These are based on the agency's internal policies and procedures. We will customize our background screening for you around your particular needs and policies. We can customize screening criteria based off of role title, such as requesting special background checks for jobs that have financial responsibilities or cash handling duties. When a candidate does not pass the requisite checks (as specified by the client), we will restart the recruiting process or present other candidates in the available pool.



We take background checks very seriously. Since our current clients all require background checks, Peak Performers runs a post-offer background checks on all individuals being considered for temporary employment as part of our process of thoroughly vetting perspective employees.

Global Safety Network

Peak utilizes Global Safety Network as our vendor of choice for background checks. Global Safety Network has been a trusted vendor partner of ours for several years and boasts several key features that help us conduct background checks quickly and efficiently:

- They offer a 24/7 web accessible platform (GlobalTRAX) that is easy to use and maintains records of those who have been screened
- They offer customizable searches for various levels depending on the needs of the customer
- They boast some of the fastest turn-around times in the industry

Background Check Verification

While we cannot share the results of an individual's background test, we will verify whether an individual passed or failed. We can provide a formal letter or email verifying that a background check was conducted.

Other Checks

Reference and Past Experience Verification - To perform reference checks we call references and conduct internet research to verify experience represented on the resume is accurate. These checks are available upon request.

Drug Testing - Additionally, Peak Performers uses HireRight and Global Safety Network drug testing services which is available to the customer upon request. Through these services we are able to do 5 panel, 10 panel, 12 panel, DOT drug testing, and hair drug tests.

Employer of Record

Peak Performers is the employer of record for all employees. Peak is responsible for all costs associated with compensation, health insurance, other benefits, unemployment claims (when applicable), and workers compensation claims (when applicable). Additionally, we provide employment verification services. Peak also deducts and manages all necessary taxes, social security benefits, and medical payments from pay. Employees are paid weekly via direct deposit.

Benefits Offered

W2 Employees - Because all Peak Performers employees work on a W2 basis for us, Peak pays out unemployment claims to qualifying individuals who are between assignments. Peak Performers also pays accordingly for all workers compensation-related injuries incurred while on the job (which is extremely rare considering most of our employees work in an office at a desk.)

Insurance - Peak Performers offers group health, dental, and vision insurance to employees after 60 days of employment wherein the employee has worked 30 hours or more each week. Insurance enrollment is offered then at the first of the month to qualifying employees. Our group health insurance comes out to approximately \$29 per week for employees and covers medical and dental. We have an on-site benefits administrator to help with enrollment.

Retention Bonuses – Peak leverages retention bonuses to incentivize our employees to stay on their assignment for the duration of the project. For every 500 hours worked, an employee is eligible for an increasing bonus. These bonuses incentivize our workforce to remain in position through the end of their contract.

Retirement Plan – Peak offers a 403(b) retirement plan for tax advantaged savings. This program, administered through T. Rowe Price, is available to all employees starting day one.

Employee Assistance Program (EAP) Benefits - Peak Performers provides an EAP to help our employees with counseling, financial planning, wellness coaching and several other work-live-balance offerings that help the employee in both their work and personal life. Peak Performers covers the full cost of this program for the employee and their family.

Timecards and Compensation

Our timecard system works on all digital devices: computers, tablets, and phones. All timecards round times to the nearest quarter hour. Rejected timecards are automatically returned to employees with manager's comments, and our in-house payroll team can answer any questions. **Process** –

- Employees log in to <u>peakperformers.org</u> and enter the time they begin work, their lunch break start and end times, and the time work is ended.
- At the end of the week, employees "Save and Submit Timesheet" to be approved by their on-site managers. All timecards are due Monday at 10 AM in order to avoid delays in getting paid.
- On-site managers can approve timecards from the email that is automatically sent to them or by logging onto <u>peakperformers.org</u>.

By logging in online, they can see more details such as notes from employee, times logged, and an event audit log of that timecard.

Employee Management

Ongoing Management: Employees are required to submit all time away requests (including day-of sick time) to their Peak staff point of contact and their on-site manager at the client's site. Staff check in with their employees regularly to monitor progress and check for problems.

Corrective Action: Peak Performers periodically has to use corrective action with employees

who fail to meet expectations or whose behaviors are not in line with the expectations of the client. Our approach to managing employee performance and addressing issues is consistent. Peak establishes realistic performance and conduct expectations with our new hires, requires strict adherence to our employment policies, and, when appropriate, swiftly removes the employee.

Ending/Extending Assignment: Our assignments end in one of several ways:

- Assignment completes at the scheduled time and customer does not need to renew
- Assignment ends early due to workload
- Employee ends assignment early.
- Assignment ends due to dissatisfaction with employee.
- Employee is hired into a permanent role by the client
- Or assignment is renewed

When an assignment ends at the scheduled end date, we ask employees to leave their badge at the worksite. In instances where an assignment needs to be ended due to a performance issue or policy violation, a our staff will notify the employee after business hours once they have left the jobsite. This helps avoid any workplace disruption for our clients. Peak Performers then asks the employee to drop off their badge at our office, or, if they are not local, request that they send the badge to our office. We then ensure that it is returned to the client. If the employee is in possession of any other client's items, we seek to swiftly collect and return these items to the client and will address this on a case-by-case basis. Our employees, with very few exceptions, do not work from home for our clients, and we ask employees not to take home work items. During our employee orientations we encourage employees not to leave personal items at the workplace. **Backfilling:** When an assignment ends, and the work has not been completed, we prioritize backfilling the position to ensure minimal interruption to our clients' workflow. Additionally, we ask our employees who resign from a position to give us at least a week of advanced notice to provide adequate time to find a suitable replacement.
