TIPS VENDOR AGREEMENT

TIPS RFP 240301 Furniture, Furnishings, and Services

The following Vendor Agreement ("Agreement") creates a legal agreement between The Interlocal Purchasing System ("TIPS"), a government purchasing cooperative and Department of Texas Region 8 Education Service Center and (INSERT ENTITY NAME):

its owners, agents, subsidiaries, and affiliates (together, "Vendor") (individually, "Party", and collectively the "Parties") and this agreement shall exclusively govern the contractual relationship ("Agreement") between the Parties.

TIPS, a governmental entity and a national purchasing cooperative seeks to provide a valuable and necessary solution to public entities and qualifying non-profits by performing the public procurement solicitation process and awarding compliant contracts to qualified vendors. Then, where the law of a customer's jurisdiction allows, instead of public entities and qualifying non-profits expending time, money, and resources on the extensive public procurement process, the use of TIPS allows public entities to quickly select and purchase their preferred products or services from qualified, competitively evaluated vendors through cooperative purchasing.

- 1. Purpose. The purpose of this Agreement is to identify the terms and conditions of the relationship between TIPS and Vendor. Public entities and qualifying non-profits that properly join or utilize TIPS ("TIPS Members") may elect to "piggyback" off of TIPS' procurements and agreements where the laws of their jurisdiction allow. TIPS Members are not contractual parties to this Agreement although terms and conditions of this Agreement may ensure benefits to TIPS Members.
- 2. Authority. The Parties agree that the signatories below are individual authorized to enter into this Agreement on behalf of their entity and that they are acting under due and proper authority under applicable law.
- 3. Definitions.
 - a. **TIPS Pricing:** The specific pricing, discounts, and other pricing terms and incentives which Vendor submitted and TIPS approved for each respective TIPS Contract awarded to Vendor and all permissible, subsequent pricing updates submitted by Vendor and accepted by TIPS, if any.
 - b. **Authorized Reseller:** A reseller or dealer authorized and added by a Vendor through their online TIPS Vendor Portal to make TIPS sales according to the terms and conditions herein.
- 4. Entire Agreement. This Agreement resulted from TIPS posting a "TIPS Solicitation" (RFP, RCSP, RFQ, or other) and Vendor submitting a proposal in response to that posted TIPS Solicitation for evaluation and award. The Parties agree that this Agreement consists of the provisions set forth herein and: (1) The TIPS solicitation document resulting in this Agreement; (2) Any addenda or clarifications issued in relation to the TIPS solicitation; (3) All solicitation information provided to Vendor by TIPS through the TIPS eBid System; (3) Vendor's entire proposal response to the TIPS solicitation including all accepted required attachments, acknowledged notices and certifications, accepted negotiated terms, pricing, accepted responses to questions, and accepted written clarifications of Vendor's proposal, and; any properly included attachments to this Agreement. All documentation and information listed is hereby incorporated by reference as if set forth herein verbatim. In the event of conflict between the terms herein and one of the incorporated documents the terms and conditions herein shall control.
- 5. Vendor's Specific Warranties, Terms, and License Agreements. Because TIPS serves public entities and non-profits throughout the nation all of which are subject to specific laws and policies of their jurisdiction, as a matter of standard practice, TIPS does not typically accept a Vendor's specific "Sale Terms" (warranties, license agreements, master agreements, terms and conditions, etc.) on behalf of all TIPS Members. TIPS may permit Vendor to attach those to this Agreement to display to interested customers what terms may apply to their Supplemental Agreement with Vendor (if submitted by Vendor for that purpose). However, unless this term of the Agreement is negotiated and modified to state otherwise, those specific Sale Terms are not accepted by TIPS on behalf of all TIPS Members and each Member may choose whether to accept, negotiate, or reject those specific Sale Terms, which must be reflected in a separate agreement between Vendor and the Member in order to be effective.

- 6. Vendor Identity and Contact Information. It is Vendor's sole responsibility to ensure that all identifying vendor information (name, EIN, d/b/a's, etc.) and contact information is updated and current at all times within the TIPS eBid System and the TIPS Vendor Portal. It is Vendor's sole responsibility to confirm that all e-correspondence issued from tips-usa.com, ionwave.net, and tipsconstruction.com to Vendor's contacts are received and are not blocked by firewall or other technology security. Failure to permit receipt of correspondence from these domains and failure to keep vendor identity and contact information current at all times during the life of the contract may cause loss of TIPS Sales, accumulating TIPS fees, missed rebid opportunities, lapse of TIPS Contract(s), and unnecessary collection or legal actions against Vendor. It is no defense to any of the foregoing or any breach of this Agreement that Vendor was not receiving TIPS' electronic communications issued by TIPS to Vendor's listed contacts.
- 7. Initiation of TIPS Sales. When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Once verified, Vendor must include the TIPS Contract Number on all purchase communications and sales documents exchanged with the TIPS Member.
- 8. TIPS Sales and Supplemental Agreements. The terms of the specific TIPS order, including but not limited to: shipping, freight, insurance, delivery, fees, bonding, cost, delivery expectations and location, returns, refunds, terms, conditions, cancellations, order assistance, etc., shall be controlled by the purchase agreement (Purchase Order, Contract, Invoice, etc.) (hereinafter "Supplemental Agreement") entered into between the TIPS Member Customer and Vendor only. TIPS is not a party to any Supplemental Agreement. All Supplemental Agreements shall include Vendor's Name, as known to TIPS, and TIPS Contract Name and Number. Vendor accepts and understands that TIPS is not a legal party to TIPS Sales and Vendor is solely responsible for identifying fraud, mistakes, unacceptable terms, or misrepresentations for the specific order prior to accepting. Vendor agrees that any order issued from a customer to Vendor, even when processed through TIPS, constitutes a legal contract between the customer and Vendor only. When Vendor accepts or fulfills an order, even when processed through TIPS, Vendor is representing that Vendor has carefully reviewed the order for legality, authenticity, and accuracy and TIPS shall not be liable or responsible for the same. In the event of a conflict between the terms of this TIPS Vendor Agreement and those contained in any Supplemental Agreement, the provisions set forth herein shall control unless otherwise agreed to and authorized by the Parties in writing within the Supplemental Agreement.
- **9. Right of Refusal.** Vendor has the right not to sell to a TIPS Member under the awarded agreement at Vendor's discretion unless otherwise required by law.
- 10. Reporting TIPS Sales. Vendor must report all TIPS Sales to TIPS. If a TIPS sale is initiated by Vendor receiving a TIPS Member's purchase order from TIPS directly, Vendor may consider that specific TIPS Sale reported. Otherwise, with the exception of TIPS Automated Vendors, who have signed an exclusive agreement with TIPS regarding reporting, all TIPS Sales must be reported to TIPS by either: (1) Emailing the purchase order or similar purchase document (with Vendor's Name, as known to TIPS, and the TIPS Contract Name and Number included) to TIPS at tipspo@tips-usa.com with "Confirmation Only" in the subject line of the email within three business days of Vendor's acceptance of the order, or; (2) Within 3 business days of the order being accepted by Vendor, Vendor must login to the TIPS Vendor Portal and successfully self-report all necessary sale information within the Vendor Portal and confirm that it shows up accurately on your current Vendor Portal statement. No other method of reporting is acceptable unless agreed to by the Parties in writing. Failure to report all sales pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion. Please refer to the TIPS Accounting FAQ's for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com.
- 11. TIPS Administration Fees. The collection of administrative fees by TIPS, a government entity, for performance of these procurement services is required pursuant to Texas Government Code Section 791.011 et. seq. The administration fee ("TIPS Administration Fee") is the amount legally owed by Vendor to TIPS for TIPS Sales made by Vendor. The TIPS Administration Fee amount is typically a set percentage of the amount paid by the TIPS Member for each TIPS Sale, less shipping cost, bond cost, and taxes if applicable and identifiable, which is legally due to TIPS, but the exact TIPS Administration Fee for this Contract is published in the corresponding solicitation and is incorporated herein by reference. TIPS Administration Fees are due to TIPS immediately upon Vendor's receipt of payment, including partial payment, for a TIPS Sale. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. Upon receipt of payment for a TIPS Sale, including partial payment (which renders TIPS Administration Fees immediately due), Vendor shall issue to TIPS the corresponding TIPS Administration Fee payment as soon as possible but not later than thirty-one calendar days following Vendor's receipt of payment. Vendor shall pay TIPS via check unless otherwise agreed to by the Parties in writing. Vendor shall include clear documentation with the issued payment dictating to which sale(s) the amount should be applied. Vendor may create a payment report within their TIPS Vendor Portal which is the preferred documentation dictating to which TIPS Sale(s) the amount should be applied. Failure to pay all TIPS Administration Fees pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion as well as the initiation of collection and legal actions by TIPS against Vendor to the extent permitted by law. Any overpayment of participation fees to TIPS by Vendor will be refunded to the Vendor

within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date that TIPS received the payment will render the overpayment non-refundable. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect TIPS Administration Fees due to TIPS pursuant to this Agreement.

12. Term of the Agreement. This Agreement with TIPS is for approximately five years with a one-year, consecutive option for renewal as described herein. Renewal options are not automatic and shall only be effective if offered by TIPS at its sole discretion. If TIPS offers a renewal option, the Vendor will be notified via email issued to Vendor's then-listed Primary Contact. The renewal option shall be deemed accepted by Vendor unless Vendor notifies TIPS of its objection to the renewal option in writing and confirms receipt by TIPS.

Actual Effective Date: Agreement is effective upon signature by authorized representatives of both Parties. The Effective Date does not affect the "Term Calculation Start Date."

Term Calculation Start Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, Vendor shall calculate the foregoing term as starting on the last day of the month that "Award Notifications" are anticipated as published in the Solicitation, regardless of the actual Effective Date.

Example of Term Calculation Start Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023, in this example.

Contract Expiration Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, the term expiration date shall be five-years from the Term Calculation Start Date.

Example of Contract Expiration Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023, and the Contract Expiration Date of the resulting initial "five-year" term, (which is subject to an extension(s)) will be May 31, 2028 in this example.

Option(s) for Renewal: Any option(s) for renewal shall begin on the Contract Expiration Date, or the date of the expiration of the prior renewal term where applicable and continue for the duration specified for the renewal option herein.

Example of Option(s) for Renewal: In this example, if TIPS offers a one-year renewal and the Contract Expiration Date is May 31, 2028, then the one-year renewal is effective from May 31, 2028 to May 31, 2029.

TIPS may offer to extend Vendor Agreements to the fullest extent the TIPS Solicitation resulting in this Agreement permits.

- 13. TIPS Pricing. Vendor agrees and understands that for each TIPS Contract that it holds, Vendor submitted, agreed to, and received TIPS' approval for specific pricing, discounts, and other pricing terms and incentives which make up Vendor's TIPS Pricing for that TIPS Contract ("TIPS Pricing"). Vendor confirms that Vendor will not add the TIPS Administration Fee as a charge or line-item in a TIPS Sale. Vendor hereby certifies that Vendor shall only offer goods and services through this TIPS Contract if those goods and services are included in or added to Vendor's TIPS Pricing and approved by TIPS. TIPS reserves the right to review Vendor's pricing update requests as specifically as line-item by line-item to determine compliance. However, Vendor contractually agrees that all submitted pricing updates shall be within the original terms of the Vendor's TIPS Pricing (scope, proposed discounts, price increase limitations, and other pricing terms and incentives originally proposed by Vendor) such that TIPS may accept Vendors price increase requests as submitted without additional vetting at TIPS discretion. Any pricing quoted by Vendor to a TIPS Member or on a TIPS Quote shall never exceed Vendor's TIPS Pricing for any good or service offered through TIPS. TIPS Pricing price increases and modifications, if permitted, will be honored according to the terms of the solicitation and Vendor's proposal, incorporated herein by reference.
- 14. Indemnification of TIPS. VENDOR AGREES TO INDEMNIFY, HOLD HARMLESS, AND DEFEND TIPS, TIPS MEMBERS, TIPS OFFICERS, TIPS EMPLOYEES, TIPS DIRECTORS, AND TIPS TRUSTEES (THE "TIPS INDEMNITEES") FROM AND AGAINST ALL CLAIMS AND SUITS BY THIRD-PARTIES FOR DAMAGES, INJURIES TO PERSONS (INCLUDING DEATH), PROPERTY DAMAGES, LOSSES, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES, ARISING OUT OF OR RELATING TO VENDOR'S PERFORMANCE UNDER THIS AGREEMENT (INCLUDING THE PERFORMANCE OF VENDOR'S OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES), REGARDLESS OF THE NATURE OF THE CAUSE OF ACTION, INCLUDING WITHOUT LIMITATION CAUSES OF ACTION BASED UPON COMMON, CONSTITUTIONAL, OR STATUTORY LAW OR BASED IN

WHOLE OR IN PART UPON ALLEGATIONS OF NEGLIGENT OR INTENTIONAL ACTS OR OMISSIONS ON THE PART OF VENDOR, ITS OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED TO BY TIPS. APART FROM THIS INDEMNIFICATION PROVISION REQUIRING INDEMNIFICATION OF THE TIPS INDEMNITEES' ATTORNEY'S FEES AS SET FORTH ABOVE, RECOVERY OF ATTORNEYS' FEES BY THE PREVAILING PARTY IS AUTHORIZED ONLY IF AUTHORIZED BY TEX. EDUC. CODE § 44.032(F).

- 15. Indemnification and Assumption of Risk Vendor Data. Vendor agrees that it is voluntarily providing data (including but not limited to: Vendor information, Vendor documentation, Vendor's proposals, Vendor pricing submitted or provided to TIPS, TIPS contract documents, TIPS correspondence, Vendor logos and images, Vendor's contact information, Vendor's brochures and commercial information, Vendor's financial information, Vendor's certifications, and any other Vendor information or documentation, including without limitation software and source code utilized by Vendor, submitted to TIPS by Vendor and its agents) ("Vendor Data") to TIPS. For the sake of clarity, and without limiting the breadth of the indemnity obligations in Section 14 above, Vendor agrees to protect, indemnify, and hold the TIPS Indemnites harmless from and against any and all losses, claims, actions, demands, allegations, suits, judgments, costs, expenses, fees, including court costs, attorney's fees, and expert fees and all other liability of any nature whatsoever arising out of or relating to: (i) Any unauthorized, negligent or wrongful use of, or cyber data breach incident and viruses or other corrupting agents involving, Vendor's Data, pricing, and information, computers, or other hardware or software systems, and; (ii) allegations or claims that any Vendor Data infringes on the intellectual property rights of a third-party or Vendor.
- 16. Procedures Related to Indemnification. In the event that an indemnity obligation arises, Vendor shall pay all amounts set forth in Section 14 and 15 above (including any settlements) and if it has accepted its indemnity obligation without qualification control the legal defense to such claim or cause of action, including without limitation attorney selection, strategy, discovery, trial, appeal, and settlement, and TIPS shall, at Vendor's cost and expense (with respect to reasonable out of pocket costs and expenses incurred by TIPS which shall be reimbursed to TIPS by Vendor), provide all commercially reasonable assistance requested by Vendor. In controlling any defense, Vendor shall ensure that all assertions of governmental immunity and all applicable pleas and defenses shall be promptly asserted.
- 17. Indemnity for Underlying Sales and Supplemental Agreements. Vendor shall be solely responsible for any customer claims or any disputes arising out of TIPS Sales or any Supplemental Agreement as if sold in the open-market. The Parties agree that TIPS shall not be liable for any claims arising out of Vendor's TIPS Sales or Supplemental Agreements, including but not limited to: allegations of product defect or insufficiency, allegations of service defect or insufficiency, allegations regarding delivery defect or insufficiency, allegations of fraud or misrepresentation, allegations regarding pricing or amounts owed for TIPS sales, and/or allegations regarding payment, over-payment, under-payment, or non-payment for TIPS Sales. Payment/Drafting, overpayment/over-drafting, under-payment/under-drafting, or non-payment for TIPS Sales between customer and Vendor and inspections, rejections, or acceptance of such purchases shall be the exclusive respective obligations of Vendor/Customer, and disputes shall be handled in accordance with the terms of the underlying Supplemental Agreement(s) entered into between Vendor and Customer. Vendor acknowledges that TIPS is not a dealer, subcontractor, agent, or reseller of Vendor's goods and services and shall not be responsible for any claims arising out of alleged insufficiencies or defects in Vendor's goods and services, should any arise.
- 18. Confidentiality of Vendor Data. Vendor understands and agrees that by signing this Agreement, all Vendor Data is hereby released to TIPS, TIPS Members, and TIPS third-party administrators to effectuate Vendor's TIPS Contract except as provided for herein. The Parties agree that Vendor Data is accessible by all TIPS Members as if submitted directly to that TIPS Member Customer for purchase consideration. If Vendor otherwise considers any portion of Vendor's Data to be confidential and not subject to public disclosure pursuant to Chapter 552 Texas Gov't Code (the "Public Information Act") or other law(s) and orders, Vendor must have identified the claimed confidential materials through proper execution of the Confidentiality Claim Form which is required to be submitted as part of Vendor's proposal resulting in this Agreement and incorporated by reference. The Confidentiality Claim Form included in Vendor's proposal and incorporated herein by reference is the sole indicator of whether Vendor considers any Vendor Data confidential in the event TIPS receives a Public Information Request. If TIPS receives a request, any responsive documentation not deemed confidential by you in this manner will be automatically released. For Vendor Data deemed confidential by you in this manner, TIPS will follow procedures of controlling statute(s) regarding any claim of confidentiality and shall not be liable for any release of information required by law, including Attorney General determination and opinion. In the event that TIPS receives a written request for information pursuant to the Public Information Act that affects Vendor's interest in any information or data furnished to TIPS by Vendor, and TIPS requests an opinion from the Attorney General, Vendor may, at its own option and expense, prepare comments and submit information directly to the Attorney General stating why the requested information is exempt from disclosure pursuant to the requirements of the Public Information Act. Vendor is solely responsible for submitting the memorandum brief and information to the Attornev General

within the time period prescribed by the Public Information Act. Notwithstanding any other information provided in this solicitation or Vendor designation of certain Vendor Data as confidential or proprietary, Vendor's acceptance of this TIPS Vendor Agreement constitutes Vendor's consent to the disclosure of Vendor's Data, including any information deemed confidential or proprietary, to TIPS Members or as ordered by a Court or government agency, including without limitation the Texas Attorney General. Vendor agrees that TIPS shall not be responsible or liable for any use or distribution of information or documentation by TIPS Members or as required by law.

- 19. Vendor's Authorized Resellers. TIPS recognizes that many vendors operate in the open market through the use of resellers or dealers. For that reason, TIPS permits Vendor to authorize Authorized Resellers within its Vendor Portal and make TIPS Sales through the Authorized Reseller(s). Once authorized by Vendor in the Vendor Portal, the Authorized Reseller(s) may make TIPS sales to TIPS Members. However, all purchase documents must include: (1) Authorized Reseller's Name; (2) Vendor's Name, as known to TIPS, and; (3) Vendor's TIPS Contract Name and Number under which it is making the TIPS Sale. Either Vendor or Reseller may report the sale pursuant to the terms herein. However, Vendor agrees that it is legally responsible for all reporting and fee payment as described herein for TIPS Sales made by Authorized Resellers. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. The Parties intend that Vendor shall be responsible and liable for TIPS Sales made by Vendor's Authorized Resellers. Vendor agrees that it is voluntarily authorizing this Authorized Reseller and in doing so, Vendor agrees that it is doing so at its own risk and agrees to protect, indemnify, and hold TIPS harmless in accordance with Sections 14-17 above related to Authorized Reseller TIPS Sales made pursuant to this Agreement or purporting to be made pursuant to this Agreement that may be asserted against Vendor whether rightfully brought or otherwise. The Parties further agree that it is no defense to Vendor's breach of this Agreement that an Authorized Reseller caused Vendor of breach this Agreement.
- 20. Circumvention of TIPS Sales. When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Any request for quote, customer communication, or customer purchase initiated through or referencing a TIPS Contract shall be completed through TIPS pursuant to this Agreement. Any encouragement or participation by Vendor in circumventing a TIPS sale being completed may result in immediate termination of Vendor's TIPS Contract(s) for cause as well as preclusion from future TIPS opportunities at TIPS sole discretion.
- 21. State of Texas Franchise Tax. By signature hereon, Vendor hereby certifies that Vendor is not currently delinquent in the payment of any franchise taxes owed to the State of Texas under Chapter 171 of the Texas Tax Code.

22. Termination.

- A) <u>Termination for Convenience</u>. TIPS may, by written notice to Vendor, terminate this Agreement for convenience, in whole or in part, at any time by giving thirty (30) days' written notice to Vendor of such termination, and specifying the effective date thereof.
- B) Termination for Cause. If Vendor fails to materially perform pursuant to the terms of this Agreement, TIPS shall provide written notice to Vendor specifying the default. If Vendor does not cure such default within thirty (30) days, TIPS may terminate this Agreement, in whole or in part, for cause. If TIPS terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
- C) <u>Vendor's Termination</u>. If TIPS fails to materially perform pursuant to the terms of this Agreement, Vendor shall provide written notice to TIPS specifying the default ('Notice of Default''). If TIPS does not cure such default within thirty (30) days, Vendor may terminate this Agreement, in whole or in part, for cause. If Vendor terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
- D) Upon termination, all TIPS Sale orders previously accepted by Vendor shall be fulfilled and Vendor shall be paid for all TIPS Sales executed pursuant to the applicable terms. All TIPS Sale orders presented to Vendor but not fulfilled by Vendor, prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. TIPS shall submit to Vendor an invoice for any outstanding TIPS Administration Fees and approved expenses and Vendor shall pay such fees and expenses within 30 calendar days of receipt of such valid TIPS invoice. Vendor acknowledges and agrees that continued participation in TIPS is subject to TIPS' sole discretion and that any Vendor may be removed from the TIPS program at any time with or without cause. This

- termination clause does not affect TIPS Sales Supplemental Agreements pursuant to this term regarding termination and the Survival Clause term.
- E) Vendor hereby waives any and all claims for damages, including, but not limited, to consequential damages or lost profits, that might arise from TIPS' act of terminating this Agreement.
- 23. Survival Clause. It is the intent of the Parties that this Agreement and procurement method applies to any TIPS Sale made during the life of this Agreement even if made on or near the Contract Expiration Date as defined herein. Thus, all TIPS Sales, including but not limited to: leases, service agreements, license agreements, open purchase orders, warranties, and contracts, even if they extend months or years past the TIPS Contract Expiration Date, shall survive the expiration or termination of this Agreement subject to the terms and conditions of the Supplemental Agreement between Customer and Vendor or unless otherwise specified herein.
- 24. Audit Rights. Due to transparency statutes and public accountability requirements of TIPS and TIPS Members, Vendor shall at their sole expense, maintain documentation of all TIPS Sales for a period of three years from the time of the TIPS Sale. In order to ensure and confirm compliance with this agreement, TIPS shall have authority to conduct audits of Vendor's TIPS Pricing or TIPS Sales with thirty-days' notice unless the audit is ordered by a Court Order or by a Government Agency with authority to do so without said notice. These audit rights shall survive termination of this Agreement for a period of one (1) year from the effective date of termination.
- 25. Conflicts of Interest. The Parties confirm that they have not offered, given, or accepted, nor intend to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor, service to the other in connection with this Agreement. Vendor affirms that, to the best of Vendor's knowledge, this Agreement has been arrived at independently, and is awarded without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement. Vendor agrees that it has disclosed any necessary affiliations with Region 8 Education Service Center and the TIPS Department, if any, through the Conflict of Interest attachment provided in the solicitation resulting in this Agreement.
- **26.** Volume of TIPS Sales. Nothing in this Agreement or any TIPS communication may be construed as a guarantee that TIPS or TIPS Members will submit any TIPS orders to Vendor at any time.
- **27. Compliance with the Law.** The Parties agree to comply fully with all applicable federal, state, and local statutes, ordinances, rules, and regulations applicable to their entity in connection with the programs contemplated under this Agreement.
- 28. Severability. If any term(s) or provision(s) of this Agreement are held by a court of competent jurisdiction to be invalid, void, or unenforceable, then such term(s) or provision(s) shall be deemed restated to reflect the original intention of the Parties as nearly as possible in accordance with applicable law and the remainder of this Agreement, and the remainder of the provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated, unless such holding causes the obligations of the Parties hereto to be impossible to perform or shall render the terms of this Agreement to be inconsistent with the intent of the Parties hereto.
- 29. Force Majeure. If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement through no fault of its own then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon. Upon delivering such notice, the obligation of the affected party, so far as it is affected by such Force Majeure as described, shall be suspended during the continuance of the inability then claimed but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. In the event that Vendor's obligations are suspended by reason of Force Majeure, all TIPS Sales accepted prior to the Force Majeure event shall be the legal responsibility of Vendor and the terms of the TIPS Sale Supplemental Agreement shall control Vendor's failure to fulfill for a Force Majeure event.
- **30. Vendor's required minimum coverage shall not be suspended, voided, cancelled, non-renewed or reduced in coverage or in limits unless replaced by a policy that provides the minimum required coverage except after thirty (30) days prior written notice by certified mail, return receipt requested has been given to TIPS or the TIPS Member if a project or pending delivery of an order is ongoing. Upon request, certified copies of all insurance policies shall be furnished to the TIPS or the TIPS Member. Vendor agrees that when Vendor or its subcontractors are liable for any damages or claims, Vendor's policy, shall be primary over any other valid and collectible insurance carried by the Member or TIPS.

- **42. Warranty

DISCLAIMER

Nevers Industries, Inc. (Nevers) reserves the right to change prices, specifications, dimensions, and finishes at any time without prior notice. This right to change also applies to discontinue models at any time, as well as catalog and price list contents.

GENERAL INFORMATION

Nevers Industries, Maple Grove, MN warrants its products to be free from defects in material and workmanship for 10 years from the date of shipment to the customer.

Our warranty covers Nevers' products used in non-residential locations and assumes typical single-shift workday use with nominal care by the end customer. Our warranty only applies to new products sold through Nevers' authorized extended sales distribution network in North America. Our warranty is non-transferable from the original purchasing entity or individual owner.

Product options, supported installed features, and any other ancillary systems and parts, whether provided by Nevers or supplied by the customer, carry their own manufacturer's or distributor's warranties. The following components not manufactured by Nevers have the following warranties:

- **High wear components** such as casters, glides, drawer slides, seating foam, fabric, PVC edges and wood edges are warranted for five years after date of shipment to original owner and shall not include replacement labor.
- **HPL self-edges** are warranted for one year after date of shipment to original owner and shall not include replacement labor.
- Metal bases are warranted for five years after date of shipment to original owner and shall not include replacement labor.
- **Electrical components** such as refrigerators, power units, wireless charging units, audio systems, microphones, lighting systems are warranted for one year after date of shipment to original owner and shall not include replacement labor.
- **Height adjustable bases** are warranted for three years on electronics, five years on components, and ten years on structural components after date of shipment to original owner and shall not include replacement labor.
- Custom products not described in Nevers' price lists are warranted for one year after date of shipment to original owner and shall not include replacement labor.



This warranty does not cover:

- Normal wear and tear.
- Damage caused by a freight carrier during shipping.
- Damage caused during installation.
- Damage caused from user modification, misuse, abuse, accident, or negligence.
- Natural variances in wood grain or texture, finish hue, or color.
- The color fastness or texture of any laminate, wood, or fabric, as such colors can fade or darken with normal use and as a result of exposure to light, including day light.
- Customer's Own Materials (COM) specified by the customer that is not a standard product offering.
- Damage caused by placing anything other than hanging files in file drawers.
- Damage caused to any products by improper use of cleaning fluids.
- Rental furniture.
- Replacement labor and service charges.

In the event of making a warranty claim, it is up to the customer to notify Nevers as soon as possible. Nevers reserves the right to examine the warranty claim and provide an appropriate response. Nevers will then, as our sole obligation, either repair or replace parts, materials, components, or other directly associated systems provided by Nevers and any other approved incurred expenses due to the warranty issue. In the case of irreplaceable custom materials, unique processes, or vendor-supplied components no longer supported, we will provide an alternate, yet equal, solution.

Any structural modification, dismantling and reinstalling, or improper use or storage of our products will void the warranty. Similarly, failure to control the expressed limits of temperature and humidity as documented by AWI (Architectural Woodwork Institute) standard 3.2.4 Environmental Controls (https://awinet.org/standards/care-and-storage/care-storage-material/), or ambient lighting exposure throughout the life of Nevers products may influence any potential indemnity and/or void our warranty.

Nevers herein extends no other warranties, expressed, depicted, or implied, including a warranty of merchantability or fitness for a particular purpose. Nevers shall not be liable for loss of time, inconvenience, commercial loss, or incidental or consequential damages. No warranties other than those contained herein will be implied and Nevers does not authorize any person to create any warranties other than those contained herein.



Freight Inspection:

At Nevers Industries we take pride in our quality packaging, but despite our best efforts, freight damage still occurs from time to time. As a consignee receiving product via common carrier it is critical that you are aware of the correct protocol for receiving a shipment. **Inspection is your responsibility.** and can have a significant impact on the outcome of a claim when one needs to be filed. Here are some basic guidelines and things to know when receiving our product, or product from any manufacturer, via common carrier.

- Inspect all cartons for visible damage and count the number of pieces you received.
- Note any damages or discrepancies on the carrier's delivery receipt (POD)
- If there is any visible damage, or you discover any concealed damage that you did not notice upon delivery, **DO NOT move the merchandise**
- Do not discard of crate/skid/packing material(s) and any damaged product Keep all packaging materials for inspection (do not destroy). Failure to do so may impair or cancel the ability to make a successful claim.
- You are liable for damage under the Interstate Commerce Act if the above points are not followed.
- All freight should be opened and inspected in a timely manner. You are liable for damage that is
 not reported to the carrier within 5 days of receipt. Caution: When a clear receipt is obtained by
 a carrier, the carrier is no longer responsible for damages or shortages. Damaged freight cannot
 be refused by the consignee (buyer). Processing claims for damages and shortages are the
 responsibility of Nevers Industries. At no time can claims be deducted from our invoices.
- Whenever any damage is discovered, take lots of pictures (including the crate/skid(s))
- Do not install damaged product. Nevers is not responsible for install/reinstall/disposal charges.
- All Nevers Industries products are made to order. Therefore, merchandise may not be returned without specific consent from Nevers Industries. Unauthorized returns will be refused by the shipping department.



Furniture Care, Cleaning & Maintenance:

NOTICE: AFFECTS OF CDC COVID-19 DISINFECTION RECOMMENDATIONS (04-24-20)

Many essential workplace disinfection chemicals are known to have the potential to adversely affect the finish quality of some wood veneer and laminates. Given the seriousness of the covid-19 pandemic, Nevers advises furniture owners to continue to comply with the CDC disinfection guidelines during these unprecedented times. It is our hope that the temporary nature of stringent disinfection can be tolerated by modern commercial finishes. You should consider the care and cleaning advice offered below this notice to be used under more "typical" times.

Proper care, cleaning and maintenance of your fine furniture will help preserve it for generations to come.

How to Protect Fine Furniture

Control the climate. For best performance, maintain temperatures between 60° and 80° Fahrenheit and humidity levels between 40% and 50%.

Use coasters and desk pads. This will protect the finish against damage from moisture and heat.

Use felt pads on the bottom of equipment and electronics. The compounds in rubber and vinyl pads often supplied on equipment can damage wood finishes.

Lift objects instead of sliding them. Sliding objects across the surface of all fine furniture can scratch the finishes.

Periodically move accessories around on surfaces to prevent inconsistent aging. Some wood species and finishes will change over time and with exposure to light. Periodically move objects on or against the furniture to help ensure even aging.

Avoid direct sunlight. If possible, avoid direct sunlight on the furniture to preserve the furniture's original beauty.

How to Clean Fine Wood Furniture

Accidental spills. Spilled liquids should be wiped up immediately with a soft, clean absorbent cloth.

Periodic dusting. Clean with a slightly damp cloth, using another soft cloth to dry. Always wipe in the direction of the wood grain. Oil, ammonia, and silicon products should never be used on wood furniture.

Regularly/monthly cleaning. Lightly soiled areas may be cleaned with Guardsman Wood Cleaner products, following the cleaner's directions. Surfaces should be cleaned with a soft, clean cloth, wiping in the same direction as the wood grain and dried with a different soft, clean cloth. Oil, ammonia, and silicon products should never be used on wood furniture.

Polishing wood furniture. We do not recommend the use of commercial wax or polish as it may leave undesirable residues. If polishing is desired, use a polish that is silicone-free such as Guardsman Wood Polish. Oil, ammonia, and silicon products should never be used on wood furniture.

How to Clean Porcelain Writing Surfaces (White Boards)

Daily cleaning. Writing from dry erase markers can easily be removed with a felt eraser or tissue.

Weekly/regularly cleaning. For best results, clean the porcelain surface as needed with a porcelain writing board cleaner, such as Expo Porcelain Board Cleaner and a soft, clean cloth.

Removing permanent ink. Permanent ink marking can be removed from the porcelain writing surface with a regular ammonia-based solvent cleaner and a soft, clean cloth.

Replace the felt eraser. After considerable usage, the felt eraser may become saturated with ink. When this happens, the eraser will no longer erase properly and will leave a marker film on the porcelain. Replace the eraser as needed.

Do not use detergent-based cleaners or furniture polish on the porcelain. Detergents and polishes will leave an undesirable film on the porcelain that may create a "ghosting" problem when it comes time to erase the board.

Cleaning Laminate Surfaces

Periodic dusting. Clean laminate with a slightly damp, soft, clean cloth. Use another soft, clean cloth to polish it dry.

Regularly/monthly cleaning. Lightly soiled areas may be cleaned with a soft, clean cloth and mild liquid detergent. For stubborn stains, use a non-abrasive, ammonia-based household cleaner. Be sure not to get this cleaner directly on any wood parts; oil, ammonia and silicon products should never be used on wood or wood trim surfaces.

Polishing laminate furniture. We do not recommend the use of commercial wax or polish as it may leave undesirable residues and possible streaking. If polishing is desired, use a laminate-specific polish. Be sure not to get this polish directly on any wood parts - oil, ammonia and silicon products should never be used on wood or wood trim surfaces.

Cleaning Metal and Painted Metal Surfaces

Regular/monthly cleaning. Lightly soiled areas may be cleaned with a soft cloth and a mild detergent.

Terms & Conditions

DISCLAIMER

Nevers Industries, Inc. (Nevers) reserves the right to change prices, specifications, dimensions, and finishes at any time without prior notice. This right to change also applies to discontinue models at any time, as well as catalog and price list contents.

CREDIT AND PAYMENT TERMS

Our preferred payment method is ACH transfer, but we also accept company checks and credit cards.

NOTE: Nevers charges a transaction fee for all orders paid by credit card.

Nevers does not allow for automatic open account terms for new customers, current customers whose accounts are in arrears, or for individuals, or non-commercial purposes. A credit application will be sent to each new customer. New customers are encouraged to submit a credit application to Nevers before placing an order.

New customers require a 50% deposit payment with the remaining 50% before outbound shipment. Our customers are responsible for providing the necessary current and accurate information. *Orders for approved customers are subject to the terms 50% due upon receipt and 50% net 30*. Nevers will apply a 1-1/2% per month service charge to all accounts 45 days past due. Accounts that are 90 days past due will be subject to collection proceedings without any additional notice. If legal action is necessary to settle collection proceedings, the purchaser agrees to pay Nevers' incurred legal representation fees and/or court costs.

Orders will not be processed for past-due accounts until the amount due, including any service charges, is paid in full. Orders will not be scheduled for production until the deposit is received. A bank letter of credit may be required for any order over \$50,000 net.

PRICES

Our published prices are list price and are subject to changes without notice. Quoted prices must be accepted within 30 days or re-quoted. Freight is prepaid and allowed for normal ground transportation within the 48 contiguous states and must ship to a dock location. Will calls qualify for a 5% discount. Prices do not include installation, storage, or sales tax.

PACKAGING

Nevers' pricing includes packing for North American shipments. Only environmentally safe packing materials are used. Large furniture pieces will be packed with wood reinforcements for added protection. For special packaging, crating, or overseas shipment, please contact Nevers for a quote. Nevers is not responsible for the disposal of packaging before, during, or after installation. Will calls must be blanket wrapped for transport and loaded onto customer supplied vehicles by the customer. Blankets are not



provided by Nevers.

DELIVERY

Nevers will select the method of shipment, carrier, and routing. Carrier selection is solicited to provide the best service to each customer in their location. All shipments are either sent from Maple Grove, Minnesota or drop shipped from manufacturer's location. Nevers' liability ends when the carrier issues a receipt to Nevers. This is the acknowledgment by the transportation company that the shipment has been received by the freight company in good condition and the title of the goods and risk of loss transfers to the buyer.

Prepaid freight does not change the F.O.B. status of the product and the risks involved. Items on backorder will be invoiced individually and be due for payment net 30. Requests for partial shipments may incur additional charges. Invoices relevant to the partial shipments are payable as they fall due.

FREIGHT TERMS

All orders under \$3,000 net are subject to a minimum order charge of \$325. Nevers also reserves the right to establish a surcharge fee. This surcharge will be established at the time of quoting. All orders under \$3,000 net are subject to additional freight charges.

LEAD TIMES

The lead time on an order begins when Nevers receives the deposit, signed drawings and all required information. Customer requirements for products to be delivered outside of Nevers' stated nominal lead times are subject to additional fees.

All acknowledgments will contain the estimated shipping date. We are not responsible for delays in scheduling or failure to make scheduled shipping dates due to strikes, lockouts or other labor complications, war, riots, Acts of God, fires, accidents, restraints affecting shipment or credit, reduced supply, or excessive cost of fuel or raw material, delays from suppliers, compliance with Government regulations, or other unforeseen contingencies.

When delays in final product delivery dates are caused on the part of the purchaser, we reserve the right to invoice up to 100% of the remaining contract amount and, in addition, to charge the purchaser any costs associated with delivery delays. Once an order is received, Nevers' products must be shipped within 6 months or be subject to price increases.

ORDER ACKNOWLEDGEMENT

All orders are subject to final acceptance by Nevers. Receipt of our acknowledgment indicates acceptance of your order subject to our terms and conditions. If pricing on the purchase order is different than the acknowledged pricing, the acknowledgment will take precedence over the purchase order. In the event of any discrepancy, please notify Nevers immediately. Failure by either party to provide notification of a discrepancy within 2 business days will constitute acceptance of the order as acknowledged. Any



discrepancies on the part of the customer will incur additional fees to be paid by the customer.

All orders are subject to credit approval at any time. After order acknowledgment, Nevers reserves the right to refuse changes to the shipment date.

CHANGE ORDERS

Nevers makes every attempt to honor any reasonable engineering, production, or shipping change request. Change orders will be accepted only if the request is made in writing and received in time to comply with established delivery dates. Nevers reserves the right to increase our acknowledged price and adjust lead times to make change requests. Nevers will assess charges to the customer for change orders, cancellations, and delivery deferments as stipulated in the following:

Change Requests After PO

- Changes received after a PO but before production will incur fees associated with any work done by Nevers plus up to a \$500 maximum net charge order fee. Any changes after the PO is received are subject to fees associated with any work required.
- Nevers reserves the right to allow up to two (2) minor revisions after the approval drawings are received by the customer. Changes requested may be subject to additional fees.
- All additional revisions will incur additional fees. After an order is acknowledged with a scheduled shipping date, no changes will be permitted.

Order Cancellations

 Nevers products are made-to-order. Cancellations are subject to approval by Nevers. Cancellations after receipt of the purchase order will be assessed a 25% cancellation charge plus the total accumulated costs of the project. Cancellation charges will be a minimum of \$750.

Deferred Shipments/Storage by Nevers and/or Vendors

- All merchandise will ship upon completion of production. If the customer is unable to take delivery of merchandise when ready for shipment, all costs and product liability for storage and freight will be at the customer's expense. Transfer to storage will be considered delivered for all purposes including invoicing and payment.
- The customer must acknowledge the title of the goods stored and the risk of loss transfers to the customer. Customers will bear the risk of loss or damage during storage.
- Deferred shipment charges will be assessed from the completion date. Storage is subject to a minimum of \$85.00 net /day storage fee.



SHIPMENT CLAIMS

The legal title of merchandise passes to the buyer upon acceptance by the carrier. The buyer must inspect all cartons on arrival for visible or concealed damage. In the event of visible freight damage, the buyer must make a notation on the freight bill, and immediately notify Nevers for an inspection. Do not sign the receipt until the visual inspection is complete at the time of delivery.

If the concealed damage is discovered, Nevers must be notified within 5 days. Keep all packaging materials for inspection (do not destroy them). Failure to do so may impair or cancel the ability to make a successful claim. Do not install the damaged product. CAUTION: When a clear receipt is obtained by a carrier, the carrier is no longer responsible for damages or shortages. Damaged freight cannot be refused by the consignee (buyer). Processing claims for damages and shortages are the responsibility of Nevers. At no time can claims be deducted from our invoices.

RETURNS

All Nevers products are made to order. Therefore, merchandise may not be returned without specific consent from Nevers. Unauthorized returns will be refused by the shipping department.

MISCELLANEOUS

All merchandise shown in our catalog is the property of Nevers. We reserve the sole right to manufacture and distribute it. All patterns, tools, and designs developed for the production of any product will remain the property of Nevers. All published dimensions are nominal and if the exact sizes are critical, we suggest that you request actual measurements.

Price list data supersedes all other specifications, whether verbal or written, and may not be altered without the written consent of an officer of Nevers. Typing and clerical errors on any agreement, publication, correspondence, price list, or product literature pieces are subject to correction at any time without notice. Due to variations beyond our control, all wood and upholstery products are subject to slight variations in color, texture, and grain.
