

TIPS VENDOR AGREEMENT

TIPS RFP 240501 MRO (MAINTENANCE, REPAIR, AND OPERATIONS OF FACILITIES AND GROUNDS) SUPPLIES, EQUIPMENT, TOOL RENTAL, SALES AND SERVICES

The following Vendor Agreement (“Agreement”) creates a legal agreement between The Interlocal Purchasing System (“TIPS”), a government purchasing cooperative and Department of Texas Region 8 Education Service Center and (INSERT ENTITY NAME):

Resource Synergy, LLC

(ENTER ENTITY NAME]

its owners, agents, subsidiaries, and affiliates (together, “Vendor”) (individually, “Party”, and collectively the “Parties”) and this agreement shall exclusively govern the contractual relationship (“Agreement”) between the Parties.

TIPS, a governmental entity and a national purchasing cooperative seeks to provide a valuable and necessary solution to public entities and qualifying non-profits by performing the public procurement solicitation process and awarding compliant contracts to qualified vendors. Then, where the law of a customer’s jurisdiction allows, instead of public entities and qualifying non-profits expending time, money, and resources on the extensive public procurement process, the use of TIPS allows public entities to quickly select and purchase their preferred products or services from qualified, competitively evaluated vendors through cooperative purchasing.

1. **Purpose.** The purpose of this Agreement is to identify the terms and conditions of the relationship between TIPS and Vendor. Public entities and qualifying non-profits that properly join or utilize TIPS (“TIPS Members”) may elect to “piggyback” off of TIPS’ procurements and agreements where the laws of their jurisdiction allow. TIPS Members are not contractual parties to this Agreement although terms and conditions of this Agreement may ensure benefits to TIPS Members.
2. **Authority.** The Parties agree that the signatories below are individual authorized to enter into this Agreement on behalf of their entity and that they are acting under due and proper authority under applicable law.
3. **Definitions.**
 - a. **TIPS Pricing:** The specific pricing, discounts, and other pricing terms and incentives which Vendor submitted and TIPS approved for each respective TIPS Contract awarded to Vendor and all permissible, subsequent pricing updates submitted by Vendor and accepted by TIPS, if any.
 - b. **Authorized Reseller:** A reseller or dealer authorized and added by a Vendor through their online TIPS Vendor Portal to make TIPS sales according to the terms and conditions herein.
4. **Entire Agreement.** This Agreement resulted from TIPS posting a “TIPS Solicitation” (RFP, RCSP, RFQ, or other) and Vendor submitting a proposal in response to that posted TIPS Solicitation for evaluation and award. The Parties agree that this Agreement consists of the provisions set forth herein and: (1) The TIPS solicitation document resulting in this Agreement; (2) Any addenda or clarifications issued in relation to the TIPS solicitation; (3) All solicitation information provided to Vendor by TIPS through the TIPS eBid System; (3) Vendor’s entire proposal response to the TIPS solicitation including all accepted required attachments, acknowledged notices and certifications, accepted negotiated terms, pricing, accepted responses to questions, and accepted written clarifications of Vendor’s proposal, and; any properly included attachments to this Agreement. All documentation and information listed is hereby incorporated by reference as if set forth herein verbatim. In the event of conflict between the terms herein and one of the incorporated documents the terms and conditions herein shall control.
5. **Vendor’s Specific Warranties, Terms, and License Agreements.** Because TIPS serves public entities and non-profits throughout the nation all of which are subject to specific laws and policies of their jurisdiction, as a matter of standard practice, TIPS does not typically accept a Vendor’s specific “Sale Terms” (warranties, license agreements, master agreements, terms and conditions, etc.) on behalf of all TIPS Members. TIPS may permit Vendor to attach those to this Agreement to display to interested customers what terms may apply to their Supplemental Agreement with Vendor (if submitted by Vendor for that purpose). However, unless this term of the Agreement is negotiated and modified to state otherwise, those specific Sale Terms are not accepted by TIPS on behalf of all TIPS Members and each Member may choose whether to accept, negotiate, or reject those specific Sale Terms, which must be reflected in a separate agreement between Vendor and the Member in order to be effective.

- 6. Vendor Identity and Contact Information.** It is Vendor's sole responsibility to ensure that all identifying vendor information (name, EIN, d/b/a's, etc.) and contact information is updated and current at all times within the TIPS eBid System and the TIPS Vendor Portal. It is Vendor's sole responsibility to confirm that all e-correspondence issued from tips-usa.com, ionwave.net, and tipsconstruction.com to Vendor's contacts are received and are not blocked by firewall or other technology security. Failure to permit receipt of correspondence from these domains and failure to keep vendor identity and contact information current at all times during the life of the contract may cause loss of TIPS Sales, accumulating TIPS fees, missed rebid opportunities, lapse of TIPS Contract(s), and unnecessary collection or legal actions against Vendor. It is no defense to any of the foregoing or any breach of this Agreement that Vendor was not receiving TIPS' electronic communications issued by TIPS to Vendor's listed contacts.
- 7. Initiation of TIPS Sales.** When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Once verified, Vendor must include the TIPS Contract Number on all purchase communications and sales documents exchanged with the TIPS Member.
- 8. TIPS Sales and Supplemental Agreements.** The terms of the specific TIPS order, including but not limited to: shipping, freight, insurance, delivery, fees, bonding, cost, delivery expectations and location, returns, refunds, terms, conditions, cancellations, order assistance, etc., shall be controlled by the purchase agreement (Purchase Order, Contract, Invoice, etc.) (hereinafter "Supplemental Agreement") entered into between the TIPS Member Customer and Vendor only. TIPS is not a party to any Supplemental Agreement. All Supplemental Agreements shall include Vendor's Name, as known to TIPS, and TIPS Contract Name and Number. Vendor accepts and understands that TIPS is not a legal party to TIPS Sales and Vendor is solely responsible for identifying fraud, mistakes, unacceptable terms, or misrepresentations for the specific order prior to accepting. Vendor agrees that any order issued from a customer to Vendor, even when processed through TIPS, constitutes a legal contract between the customer and Vendor only. When Vendor accepts or fulfills an order, even when processed through TIPS, Vendor is representing that Vendor has carefully reviewed the order for legality, authenticity, and accuracy and TIPS shall not be liable or responsible for the same. In the event of a conflict between the terms of this TIPS Vendor Agreement and those contained in any Supplemental Agreement, the provisions set forth herein shall control unless otherwise agreed to and authorized by the Parties in writing within the Supplemental Agreement.
- 9. Right of Refusal.** Vendor has the right not to sell to a TIPS Member under the awarded agreement at Vendor's discretion unless otherwise required by law.
- 10. Reporting TIPS Sales.** Vendor must report all TIPS Sales to TIPS. If a TIPS sale is initiated by Vendor receiving a TIPS Member's purchase order from TIPS directly, Vendor may consider that specific TIPS Sale reported. Otherwise, with the exception of TIPS Automated Vendors, who have signed an exclusive agreement with TIPS regarding reporting, all TIPS Sales must be reported to TIPS by either: (1) Emailing the purchase order or similar purchase document (with Vendor's Name, as known to TIPS, and the TIPS Contract Name and Number included) to TIPS at tipspo@tips-usa.com with "Confirmation Only" in the subject line of the email within three business days of Vendor's acceptance of the order, or; (2) Within 3 business days of the order being accepted by Vendor, Vendor must login to the TIPS Vendor Portal and successfully self-report all necessary sale information within the Vendor Portal and confirm that it shows up accurately on your current Vendor Portal statement. No other method of reporting is acceptable unless agreed to by the Parties in writing. Failure to report all sales pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion. Please refer to the TIPS [Accounting FAQ's](#) for more information about reporting sales and if you have further questions, contact the Accounting Team at accounting@tips-usa.com.
- 11. TIPS Administration Fees.** The collection of administrative fees by TIPS, a government entity, for performance of these procurement services is required pursuant to Texas Government Code Section 791.011 et. seq. The administration fee ("TIPS Administration Fee") is the amount legally owed by Vendor to TIPS for TIPS Sales made by Vendor. The TIPS Administration Fee amount is typically a set percentage of the amount paid by the TIPS Member for each TIPS Sale, less shipping cost, bond cost, and taxes if applicable and identifiable, which is legally due to TIPS, but the exact TIPS Administration Fee for this Contract is published in the corresponding solicitation and is incorporated herein by reference. TIPS Administration Fees are due to TIPS immediately upon Vendor's receipt of payment, including partial payment, for a TIPS Sale. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. Upon receipt of payment for a TIPS Sale, including partial payment (which renders TIPS Administration Fees immediately due), Vendor shall issue to TIPS the corresponding TIPS Administration Fee payment as soon as possible but not later than thirty-one calendar days following Vendor's receipt of payment. Vendor shall pay TIPS via check unless otherwise agreed to by the Parties in writing. Vendor shall include clear documentation with the issued payment dictating to which sale(s) the amount should be applied. Vendor may create a payment report within their TIPS Vendor Portal which is the preferred documentation dictating to which TIPS Sale(s) the amount should be applied. Failure to pay all TIPS Administration Fees pursuant to this provision may result in immediate cancellation of Vendor's TIPS Contract(s) for cause at TIPS' sole discretion as well as the initiation of collection and legal actions by TIPS against Vendor to the extent permitted by law. Any overpayment of participation fees to TIPS by Vendor will be refunded to the Vendor

within ninety (90) days of receipt of notification if TIPS receives written notification of the overpayment not later than the expiration of six (6) months from the date of overpayment and TIPS determines that the amount was not legally due to TIPS pursuant to this agreement and applicable law. Any notification of overpayment received by TIPS after the expiration of six (6) months from the date that TIPS received the payment will render the overpayment non-refundable. Region 8 ESC and TIPS reserve the right to extend the six (6) month deadline if approved by the Region 8 ESC Board of Directors. TIPS reserves all rights under the law to collect TIPS Administration Fees due to TIPS pursuant to this Agreement.

- 12. Term of the Agreement.** This Agreement with TIPS is for approximately five years with a one-year, consecutive option for renewal as described herein. Renewal options are not automatic and shall only be effective if offered by TIPS at its sole discretion. If TIPS offers a renewal option, the Vendor will be notified via email issued to Vendor's then-listed Primary Contact. The renewal option shall be deemed accepted by Vendor unless Vendor notifies TIPS of its objection to the renewal option in writing and confirms receipt by TIPS.

Actual Effective Date: Agreement is effective upon signature by authorized representatives of both Parties. The Effective Date does not affect the "Term Calculation Start Date."

Term Calculation Start Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, Vendor shall calculate the foregoing term as starting on the last day of the month that "Award Notifications" are anticipated as published in the Solicitation, regardless of the actual Effective Date.

Example of Term Calculation Start Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 in this example.

Contract Expiration Date: To keep the contract term consistent for all vendors awarded under a single TIPS contract, the term expiration date shall be five-years from the Term Calculation Start Date.

Example of Contract Expiration Date: If the anticipated "Award Date" published in the Solicitation is May 22, 2023, but extended negotiations delay award until June 27, 2023 (Actual Effective Date), the Term Calculation Start Date shall be May 31, 2023 and the Contract Expiration Date of the resulting initial "five-year" term, (which is subject to an extension(s)) will be May 31, 2028 in this example.

Option(s) for Renewal: Any option(s) for renewal shall begin on the Contract Expiration Date, or the date of the expiration of the prior renewal term where applicable, and continue for the duration specified for the renewal option herein.

Example of Option(s) for Renewal: In this example, if TIPS offers a one-year renewal and the Contract Expiration Date is May 31, 2026, then the one-year renewal is effective from May 31, 2026 to May 31, 2027.

TIPS may offer to extend Vendor Agreements to the fullest extent the TIPS Solicitation resulting in this Agreement permits.

- 13. TIPS Pricing.** Vendor agrees and understands that for each TIPS Contract that it holds, Vendor submitted, agreed to, and received TIPS' approval for specific pricing, discounts, and other pricing terms and incentives which make up Vendor's TIPS Pricing for that TIPS Contract ("TIPS Pricing"). Vendor confirms that Vendor will not add the TIPS Administration Fee as a charge or line-item in a TIPS Sale. Vendor hereby certifies that Vendor shall only offer goods and services through this TIPS Contract if those goods and services are included in or added to Vendor's TIPS Pricing and approved by TIPS. TIPS reserves the right to review Vendor's pricing update requests as specifically as line-item by line-item to determine compliance. However, Vendor contractually agrees that all submitted pricing updates shall be within the original terms of the Vendor's TIPS Pricing (scope, proposed discounts, price increase limitations, and other pricing terms and incentives originally proposed by Vendor) such that TIPS may accept Vendors price increase requests as submitted without additional vetting at TIPS discretion. Any pricing quoted by Vendor to a TIPS Member or on a TIPS Quote shall never exceed Vendor's TIPS Pricing for any good or service offered through TIPS. TIPS Pricing price increases and modifications, if permitted, will be honored according to the terms of the solicitation and Vendor's proposal, incorporated herein by reference.

- 14. Indemnification of TIPS.** VENDOR AGREES TO INDEMNIFY, HOLD HARMLESS, AND DEFEND TIPS, TIPS MEMBERS, TIPS OFFICERS, TIPS EMPLOYEES, TIPS DIRECTORS, AND TIPS TRUSTEES (THE "TIPS INDEMNITEES") FROM AND AGAINST ALL CLAIMS AND SUITS BY THIRD-PARTIES FOR DAMAGES, INJURIES TO PERSONS (INCLUDING DEATH), PROPERTY DAMAGES, LOSSES, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES, ARISING OUT OF OR RELATING TO VENDOR'S PERFORMANCE UNDER THIS AGREEMENT (INCLUDING THE PERFORMANCE OF VENDOR'S OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES), REGARDLESS OF THE NATURE OF THE CAUSE OF ACTION, INCLUDING WITHOUT LIMITATION CAUSES OF ACTION BASED UPON COMMON, CONSTITUTIONAL, OR STATUTORY LAW OR BASED IN

WHOLE OR IN PART UPON ALLEGATIONS OF NEGLIGENT OR INTENTIONAL ACTS OR OMISSIONS ON THE PART OF VENDOR, ITS OFFICERS, EMPLOYEES, AGENTS, AUTHORIZED RESELLERS, SUBCONTRACTORS, LICENSEES, OR INVITEES. NO LIMITATION OF LIABILITY FOR DAMAGES FOR PERSONAL INJURY OR PROPERTY DAMAGE ARE PERMITTED OR AGREED TO BY TIPS. APART FROM THIS INDEMNIFICATION PROVISION REQUIRING INDEMNIFICATION OF THE TIPS INDEMNITEES' ATTORNEY'S FEES AS SET FORTH ABOVE, RECOVERY OF ATTORNEYS' FEES BY THE PREVAILING PARTY IS AUTHORIZED ONLY IF AUTHORIZED BY TEX. EDUC. CODE § 44.032(F).

15. **Indemnification and Assumption of Risk – Vendor Data.** VENDOR AGREES THAT IT IS VOLUNTARILY PROVIDING DATA (INCLUDING BUT NOT LIMITED TO: VENDOR INFORMATION, VENDOR DOCUMENTATION, VENDOR'S PROPOSALS, VENDOR PRICING SUBMITTED OR PROVIDED TO TIPS, TIPS CONTRACT DOCUMENTS, TIPS CORRESPONDENCE, VENDOR LOGOS AND IMAGES, VENDOR'S CONTACT INFORMATION, VENDOR'S BROCHURES AND COMMERCIAL INFORMATION, VENDOR'S FINANCIAL INFORMATION, VENDOR'S CERTIFICATIONS, AND ANY OTHER VENDOR INFORMATION OR DOCUMENTATION, INCLUDING WITHOUT LIMITATION SOFTWARE AND SOURCE CODE UTILIZED BY VENDOR, SUBMITTED TO TIPS BY VENDOR AND ITS AGENTS) ("VENDOR DATA") TO TIPS. FOR THE SAKE OF CLARITY, AND WITHOUT LIMITING THE BREADTH OF THE INDEMNITY OBLIGATIONS IN SECTION 14 ABOVE, VENDOR AGREES TO PROTECT, INDEMNIFY, AND HOLD THE TIPS INDEMNITEES HARMLESS FROM AND AGAINST ANY AND ALL LOSSES, CLAIMS, ACTIONS, DEMANDS, ALLEGATIONS, SUITS, JUDGMENTS, COSTS, EXPENSES, FEES, INCLUDING COURT COSTS, ATTORNEY'S FEES, AND EXPERT FEES AND ALL OTHER LIABILITY OF ANY NATURE WHATSOEVER ARISING OUT OF OR RELATING TO: (I) ANY UNAUTHORIZED, NEGLIGENT OR WRONGFUL USE OF, OR CYBER DATA BREACH INCIDENT AND VIRUSES OR OTHER CORRUPTING AGENTS INVOLVING, VENDOR'S DATA, PRICING, AND INFORMATION, COMPUTERS, OR OTHER HARDWARE OR SOFTWARE SYSTEMS, AND; (II) ALLEGATIONS OR CLAIMS THAT ANY VENDOR DATA INFRINGES ON THE INTELLECTUAL PROPERTY RIGHTS OF A THIRD-PARTY OR VENDOR.
16. **Procedures Related to Indemnification.** In the event that an indemnity obligation arises, Vendor shall pay all amounts set forth in Section 14 and 15 above (including any settlements) and – if it has accepted its indemnity obligation without qualification – control the legal defense to such claim or cause of action, including without limitation attorney selection, strategy, discovery, trial, appeal, and settlement, and TIPS shall, at Vendor's cost and expense (with respect to reasonable out of pocket costs and expenses incurred by TIPS which shall be reimbursed to TIPS by Vendor), provide all commercially reasonable assistance requested by Vendor. In controlling any defense, Vendor shall ensure that all assertions of governmental immunity and all applicable pleas and defenses shall be promptly asserted.
17. **Indemnity for Underlying Sales and Supplemental Agreements.** Vendor shall be solely responsible for any customer claims or any disputes arising out of TIPS Sales or any Supplemental Agreement as if sold in the open-market. The Parties agree that TIPS shall not be liable for any claims arising out of Vendor's TIPS Sales or Supplemental Agreements, including but not limited to: allegations of product defect or insufficiency, allegations of service defect or insufficiency, allegations regarding delivery defect or insufficiency, allegations of fraud or misrepresentation, allegations regarding pricing or amounts owed for TIPS sales, and/or allegations regarding payment, over-payment, under-payment, or non-payment for TIPS Sales. Payment/Drafting, overpayment/over-drafting, under-payment/under-drafting, or non-payment for TIPS Sales between customer and Vendor and inspections, rejections, or acceptance of such purchases shall be the exclusive respective obligations of Vendor/Customer, and disputes shall be handled in accordance with the terms of the underlying Supplemental Agreement(s) entered into between Vendor and Customer. Vendor acknowledges that TIPS is not a dealer, subcontractor, agent, or reseller of Vendor's goods and services and shall not be responsible for any claims arising out of alleged insufficiencies or defects in Vendor's goods and services, should any arise.
18. **Confidentiality of Vendor Data.** Vendor understands and agrees that by signing this Agreement, all Vendor Data is hereby released to TIPS, TIPS Members, and TIPS third-party administrators to effectuate Vendor's TIPS Contract except as provided for herein. The Parties agree that Vendor Data is accessible by all TIPS Members as if submitted directly to that TIPS Member Customer for purchase consideration. If Vendor otherwise considers any portion of Vendor's Data to be confidential and not subject to public disclosure pursuant to Chapter 552 Texas Gov't Code (the "Public Information Act") or other law(s) and orders, Vendor must have identified the claimed confidential materials through proper execution of the Confidentiality Claim Form which is required to be submitted as part of Vendor's proposal resulting in this Agreement and incorporated by reference. The Confidentiality Claim Form included in Vendor's proposal and incorporated herein by reference is the sole indicator of whether Vendor considers any Vendor Data confidential in the event TIPS receives a Public Information Request. If TIPS receives a request, any responsive documentation not deemed confidential by you in this manner will be automatically released. For Vendor Data deemed confidential by you in this manner, TIPS will follow procedures of controlling statute(s) regarding any claim of confidentiality and shall not be liable for any release of information required by law, including Attorney General determination and opinion. In the event that TIPS receives a written request for information pursuant to the Public Information Act that affects Vendor's interest in any information or data furnished to TIPS by Vendor, and TIPS requests an opinion from the Attorney General, Vendor may, at its own option and expense, prepare comments and submit information directly to the Attorney General stating why the requested information is exempt from disclosure pursuant to the requirements of the Public Information Act. Vendor is solely responsible for submitting the memorandum brief and information to the Attorney General

within the time period prescribed by the Public Information Act. Notwithstanding any other information provided in this solicitation or Vendor designation of certain Vendor Data as confidential or proprietary, Vendor's acceptance of this TIPS Vendor Agreement constitutes Vendor's consent to the disclosure of Vendor's Data, including any information deemed confidential or proprietary, to TIPS Members or as ordered by a Court or government agency, including without limitation the Texas Attorney General. Vendor agrees that TIPS shall not be responsible or liable for any use or distribution of information or documentation by TIPS Members or as required by law.

- 19. Vendor's Authorized Resellers.** TIPS recognizes that many vendors operate in the open market through the use of resellers or dealers. For that reason, TIPS permits Vendor to authorize Authorized Resellers within its Vendor Portal and make TIPS Sales through the Authorized Reseller(s). Once authorized by Vendor in the Vendor Portal, the Authorized Reseller(s) may make TIPS sales to TIPS Members. However, all purchase documents must include: (1) Authorized Reseller's Name; (2) Vendor's Name, as known to TIPS, and; (3) Vendor's TIPS Contract Name and Number under which it is making the TIPS Sale. Either Vendor or Reseller may report the sale pursuant to the terms herein. However, Vendor agrees that it is legally responsible for all reporting and fee payment as described herein for TIPS Sales made by Authorized Resellers. The TIPS Administration Fee is assessed on the amount paid by the TIPS Member, not on the Vendor's cost or on the amount for which the Vendor sold the item to a dealer or Authorized Reseller. The Parties intend that Vendor shall be responsible and liable for TIPS Sales made by Vendor's Authorized Resellers. Vendor agrees that it is voluntarily authorizing this Authorized Reseller and in doing so, Vendor agrees that it is doing so at its own risk and agrees to protect, indemnify, and hold TIPS harmless in accordance with Sections 14-17 above related to Authorized Reseller TIPS Sales made pursuant to this Agreement or purporting to be made pursuant to this Agreement that may be asserted against Vendor whether rightfully brought or otherwise. The Parties further agree that it is no defense to Vendor's breach of this Agreement that an Authorized Reseller caused Vendor of breach this Agreement.
- 20. Circumvention of TIPS Sales.** When a public entity initiates a purchase with Vendor, if the Member inquires verbally or in writing whether Vendor holds a TIPS Contract, it is the duty of the Vendor to verify whether the Member is seeking a TIPS purchase. Any request for quote, customer communication, or customer purchase initiated through or referencing a TIPS Contract shall be completed through TIPS pursuant to this Agreement. Any encouragement or participation by Vendor in circumventing a TIPS sale being completed may result in immediate termination of Vendor's TIPS Contract(s) for cause as well as preclusion from future TIPS opportunities at TIPS sole discretion.
- 21. State of Texas Franchise Tax.** By signature hereon, Vendor hereby certifies that Vendor is not currently delinquent in the payment of any franchise taxes owed to the State of Texas under Chapter 171 of the Texas Tax Code.
- 22. Termination.**
- A) Termination for Convenience. TIPS may, by written notice to Vendor, terminate this Agreement for convenience, in whole or in part, at any time by giving thirty (30) days' written notice to Vendor of such termination, and specifying the effective date thereof.
 - B) Termination for Cause. If Vendor fails to materially perform pursuant to the terms of this Agreement, TIPS shall provide written notice to Vendor specifying the default. If Vendor does not cure such default within thirty (30) days, TIPS may terminate this Agreement, in whole or in part, for cause. If TIPS terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
 - C) Vendor's Termination. If TIPS fails to materially perform pursuant to the terms of this Agreement, Vendor shall provide written notice to TIPS specifying the default ("Notice of Default"). If TIPS does not cure such default within thirty (30) days, Vendor may terminate this Agreement, in whole or in part, for cause. If Vendor terminates this Agreement for cause, and it is later determined that the termination for cause was wrongful, the termination shall automatically be converted to and treated as a termination for convenience.
 - D) Upon termination, all TIPS Sale orders previously accepted by Vendor shall be fulfilled and Vendor shall be paid for all TIPS Sales executed pursuant to the applicable terms. All TIPS Sale orders presented to Vendor but not fulfilled by Vendor, prior to the actual termination of this agreement shall be honored at the option of the TIPS Member. TIPS shall submit to Vendor an invoice for any outstanding TIPS Administration Fees and approved expenses and Vendor shall pay such fees and expenses within 30 calendar days of receipt of such valid TIPS invoice. Vendor affirms that, to the best of Vendor's knowledge, this Agreement has been arrived at independently, and is awarded without collusion with anyone to obtain information or gain any favoritism that would in any way limit competition or give an unfair advantage over other vendors in the award of this Agreement. Vendor agrees that it has disclosed any necessary affiliations with Region 8 Education Service Center and the TIPS Department, if any, through the Conflict of Interest attachment provided in the solicitation resulting in this Agreement.
- 26. Volume of TIPS Sales.** Nothing in this Agreement or any TIPS communication may be construed as a guarantee that TIPS or TIPS Members will submit any TIPS orders to Vendor at any time.
- 27. Compliance with the Law.** The Parties agree to comply fully with all applicable federal, state, and local statutes, ordinances, rules, and regulations applicable to their entity in connection with the programs contemplated under this Agreement.
- 28. Severability.** If any term(s) or provision(s) of this Agreement are held by a court of competent jurisdiction to be invalid, void, or unenforceable, then such term(s) or provision(s) shall be deemed restated to reflect the original intention of the Parties as nearly as possible in accordance with applicable law and the remainder of this Agreement, and the remainder of the provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated, unless such holding causes the obligations of the Parties hereto to be impossible to perform or shall render the terms of this Agreement to be inconsistent with the intent of the Parties hereto.
- 29. Force Majeure.** If by reason of Force Majeure, either party hereto shall be rendered unable wholly or in part to carry out its obligations under this Agreement through no fault of its own then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon. Upon delivering such notice, the obligation of the affected party, so far as it is affected by such Force Majeure as described, shall be suspended during the continuance of the inability then claimed but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. Terms and Conditions

- 1.0 **Services.** Resource Synergy and Client each agree to perform its respective obligations as set forth in the Service Agreement.
- 2.0 **Definitions.** The following defined terms govern this Service Agreement:
- 2.1 **“Affiliate”** is defined as any entity that directly or indirectly controls, is controlled by or is under common control with a party to this Agreement, with “control” meaning ownership of 51% or more of the voting equity interests, or the power to otherwise direct the affairs of the applicable entity.
 - 2.2 **“Agreement”** is defined as this Service Agreement.
 - 2.3 **“Business Day”** is defined as all weekdays, but specifically excludes Saturday, Sunday, the day after Thanksgiving and recognized federal holidays.
 - 2.4 **“Content”** is defined as all contents of marketing materials and client deliverables, such as text, graphics, images, information provided under license from third parties, and other material provided. All Content is protected by copyright under both United States and foreign laws. All marks and logos appearing on the materials are registered and common-law trademarks or service marks of Resource Synergy, its licensors, or other third parties.
 - 2.5 **“Excluded Waste”** is defined as hazardous, radioactive, volatile, corrosive, highly flammable, explosive, biomedical, infectious, biohazardous, toxic or listed or characteristic hazardous waste as defined by applicable law or any otherwise regulated waste, and waste that includes any information protected under federal or state privacy or security laws and regulations (“Excluded Waste”). Hazardous Waste shall include, but not be limited to, any amount of waste listed or characterized as hazardous by the United States Environmental Protection Agency or any state agency pursuant to the Resource Conservation and Recovery Act of 1976, as amended, and including future amendments thereto, and any other applicable federal or state law.
 - 2.6 **“Hauler”** is defined as a waste hauler contracted with Client to provide waste hauling services to Client. Client agrees to provide Resource Synergy with current contact information for each Hauler throughout the Term.
 - 2.7 **“Recyclable Material.”** is defined as of any material or substance at Client’s Location(s) that can be put to beneficial re-use or sold in recognized markets for purposes other than disposal, including, but not limited to, uncontaminated non-hazardous corrugated cardboard, yard and food waste, white paper and newsprint; plastics and plastic film; ferrous and non-ferrous metals; and glass. Recyclable Material must not contain any hazardous waste materials.
 - 2.8 **“Savings”** is defined in Section 10.
 - 2.9 **“Site”** is defined as a physical building owned or operated by Client
 - 2.10 **“Solid Waste”** is defined as all nonhazardous solid waste, including, but limited to organic waste, dry waste and wood waste generated at Client Locations that is not excluded by the provisions of this Agreement. Solid Waste shall not include any Excluded Waste.
 - 2.11 **“Special Waste”** is defined as polychlorinated biphenyl wastes, industrial process wastes, asbestos containing material, petroleum contaminated soils, treated/de-characterized wastes, incinerator ash, medical wastes, demolition debris and other materials requiring special handling in accordance with any applicable law or regulations.
 - 2.12 **“Transaction Taxes”** is defined as any taxes, federal, state or otherwise, or duties, fees or charges, however designated, that are levied or imposed by any governmental authority by reason of Resource Synergy’s sale or license to Client of any services or other goods and products covered by this Agreement, or Client’s use of the Services, except for taxes levied on the income or gross revenue of Resource Synergy payable by Resource Synergy.
 - 2.13 **“Waste Material”** is defined as all nonhazardous Solid Waste and, if designated in this Agreement, nonhazardous Special Waste and/or Recyclable Material that are not excluded by this Agreement. Waste Material does not include any Excluded Waste (defined above).
- 3.0 **Service Fees and Payment Terms:** Client will pay Resource Synergy for the Services described in the Agreement as provided for herein.
- 3.1 **Payment Terms.** All fees are quoted in U.S. monies. All Service Fees are due upon invoice. Client agrees to pay simple interest at the highest rate allowed by law or 12% per annum, whichever is less, on all sums thirty (30) days past due to Resource Synergy under this Agreement. All fees are exclusive of applicable Transaction Taxes, and Client agrees to pay all Transaction Taxes that may now or hereafter apply to Client’s use of the Services.
 - 3.2 **Monthly Service Fees.** Monthly service fees, if any, shall commence on the Effective Date and are payable by the tenth (10th) day of each month, unless otherwise described in the Term Summary.
 - 3.3 **Shared Savings.** Client agrees permit Resource Synergy to contact its Hauler to request copies of all invoices, receipts, or bills during the term of this Agreement and consents to the release of any invoice, receipt or bill from Hauler. In the event Client does not permit Resource Synergy to contact the Hauler, Client agrees to provide Resource Synergy with a copy of any invoice, receipt or bill from Hauler detailing the cost per haul, price per container, or tonnage of waste hauled, as applicable, within ten (10) days of the date of receipt. Client agrees to pay Resource Synergy its percentage of the Shared Savings or any portion thereof upon invoice by Resource Synergy. All other terms regarding payment are applicable to the payment of Shared Savings.
- 4.0 **Term.** This Agreement is binding on the parties when signed by both parties. The Agreement shall remain in force for the duration of time specified as Term in the Term Summary above and shall automatically renew for successive One (1) year terms (each a “Renewal Term”), unless either party gives contrary notice at least ninety (90) days, but not more than one hundred twenty (120) days prior to the end of the then current term. Each Renewal Term shall be subject to the terms of this Agreement. Notwithstanding the foregoing, this Agreement will remain in effect with respect to any Service already issued prior to expiration of this Agreement until such Service expires or is terminated pursuant to this Agreement.
- 5.0 **Termination.**
- 5.1 **Termination.** Either party may terminate this Agreement upon the default of the other party. Default includes (i) failure of Client to pay any sum under this Agreement when due; or (ii) the failure of either party to cure the breach of any material term of this Agreement within thirty (30) calendar days, unless a longer cure period is agreed upon by the parties in writing, after the defaulting party receives written notice of such breach from the other party.
 - 5.2 **Early Termination:** In the event that the Agreement is terminated as provided for in Section 5.1 by Resource Synergy, Resource Synergy may accelerate all sums due hereunder, without further notice or demand, and declare the entire remaining service fees then unpaid immediately due and payable by Client.
 - 5.3 **Sale of Site:** In the event that Client sells a contracted Site, Client will make a reasonable attempt to assign Resource Synergy agreement to the new owner. If agreement is not assigned by the closing date of Site sale, Resource Synergy may accelerate all sums due hereunder, without further notice or demand, and declare the entire remaining service fees then unpaid, and the depreciated value of equipment installed, immediately due and payable by Client.
- 6.0 **Representations and Warranties; Disclaimer.**
- 6.1 **Client.** Client represents and warrants to Resource Synergy that: (i) Client has full power and authority to execute, deliver and perform its obligations under this Agreement; and (ii) this Agreement will be the legal, valid and binding obligation of Client; and (iii) in the performance of its obligations under this Agreement it will comply with all federal, state and local laws and regulations.
 - 6.2 **Materials to be Serviced.** Client represents and warrants that the Waste Material is and will be non-hazardous and that none of the Waste Materials consist of Excluded Waste. Client acknowledges that Resource Synergy does not deal in the handling of Excluded Waste or any other form of waste requiring

special handling. Resource Synergy reserves the right to decline to perform Waste Services, which in its judgment; it cannot perform in a lawful manner or without risk of harm to human health, safety, or the environment.

- 6.3 **Equipment.** Any equipment furnished by Resource Synergy shall remain the property of Resource Synergy. Client shall use the equipment only for its proper and intended purpose and shall not overload (by weight or volume), or alter the equipment. Client will be responsible for any loss or damage resulting from the Client's possession or handling of the equipment, except for normal wear and tear. Unless otherwise agreed in writing, Client shall purchase all equipment not returned to Resource Synergy in like-new condition upon termination of Agreement.
- 6.4 **Resource Synergy.** Resource Synergy represents and warrants to Client that: (i) it has full power and authority to enter into this Agreement; (ii) this Agreement will be the legal, valid and binding obligation of Resource Synergy enforceable according to its terms; and (iii) in the performance of its obligations under this Agreement it will comply with all federal, state and local laws and regulations.
- 6.5 **DISCLAIMER. RESOURCE SYNERGY MAKES NO OTHER REPRESENTATIONS OR WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO THE SERVICES PROVIDED UNDER THIS AGREEMENT.**

7.0 Indemnity; Client's Remedies; Limitation of Liability; Exclusion of Certain Damages.

- 7.1 **Indemnity.** Each party agrees to indemnify, defend and hold harmless the other party from and against any and all third party claims, losses, liabilities, damages and expenses, including attorney's fees, resulting from a party's negligent act or omission under or related to this Agreement; provided that such third party claim does not result from the negligent act or omission of the party seeking indemnity. Resource Synergy will not be held liable for damage caused by performance of services described in Exhibit 1 – Scope of Work. Damage may include, but is not limited to soiling of pavement and other surfaces caused by sorting waste on-site and scratches incurred while installing bins. Resource Synergy will take reasonable steps to avoid such damage.
- 7.2 **LIMITATION OF LIABILITY. EXCEPT FOR THE PAYMENT OF SERVICE FEES, WILLFUL MISCONDUCT, GROSS NEGLIGENCE OR OBLIGATIONS IN SECTIONS 6, 7 AND 8 (IN WHICH CASE LIABILITY SHALL BE LIMITED TO ACTUAL DAMAGES SUSTAINED BY THE DAMAGED PARTY PLUS ANY REASONABLE ATTORNEY'S FEES AND COSTS AS SET FORTH HEREIN), A RESOURCE SYNERGY'S CUMULATIVE LIABILITY FOR ANY LOSS OR DAMAGE IN ANY CALENDAR YEAR, FOR ANY CAUSE ARISING OUT OF OR RELATED TO THIS AGREEMENT, SHALL NOT EXCEED THE AMOUNT OF THE SERVICE FEES PAID BY CLIENT TO RESOURCE SYNERGY PURSUANT TO THIS AGREEMENT IN THE IMMEDIATELY PRECEDING SIX (6) CALENDAR MONTHS. IN THE EVENT THIS AGREEMENT HAS BEEN IN EFFECT FOR LESS THAN SIX (6) MONTHS AT THE TIME OF SUCH LOSS OR DAMAGE, THE AVERAGE MONTHLY AMOUNT OF SERVICE FEES PAID BY CLIENT SHALL BE MULTIPLIED BY THE NUMBER OF MONTHS REMAINING TO EQUAL SIX (6) MONTHS OF SERVICE FEES FOR PURPOSES OF CALCULATING A PARTY'S MAXIMUM LIABILITY UNDER THIS AGREEMENT. THE PARTIES UNDERSTAND THIS LIMITATION ON LIABILITY TO BE A REASONABLE ALLOCATION OF RISK AND EXPRESSLY AGREE AND CONSENT TO SUCH ALLOCATION OF RISK.**
- 7.3 **Exclusion of Certain Damages.** To the fullest extent permitted by applicable law, in no event shall either party be liable for any special, incidental, indirect, punitive, exemplary, or consequential damages arising out of or in any way related to this Agreement, even if Resource Synergy or Client, as the case may be, has been advised of the foreseeability of such damages.

8.0 Confidentiality; Proprietary Rights; License.

- 8.1 **Confidentiality.** This Section 8 describes the parties' obligations of confidentiality under this Agreement.
 - 8.1.1 In connection with this Agreement, each party has disclosed and may continue to disclose to the other party information that relates to the disclosing party's business operations, financial condition, customers, products, services or technical knowledge. Except as may otherwise be specifically agreed in writing by the parties, Resource Synergy and Client each agree that (i) all information communicated to it by the other and identified as confidential or proprietary, whether before or after the Effective Date; (ii) all information identified as confidential or proprietary to which it has access in connection with the Services, whether before or after the Effective Date; (iii) all information communicated to it that should have been understood by the receiving party, because of confidentiality or similar legends, the circumstances of disclosure or the nature of the information itself, to be proprietary and confidential to the disclosing party; and (iv) the terms and conditions of this Agreement (collectively, the "Confidential Information" and separately "Resource Synergy Information" or "Client Information"), shall be and shall be deemed to have been received in confidence and shall be used only for purposes of this Agreement in compliance with applicable law.
 - 8.1.2 Each party's Confidential Information shall remain the property of that party except as may otherwise be expressly provided in this Agreement. Each party shall use at least the same degree of care it uses to protect its own Confidential Information in order to safeguard and prevent disclosing to third parties the Confidential Information of the other party and, in any event, no less than reasonable care. Each party shall not (i) make any use or copies of the Confidential Information of the other party except as contemplated by this Agreement; (ii) acquire any right in or assert any lien against the Confidential Information of the other; or (iii) sell, assign, lease or otherwise commercially exploit the Confidential Information or any derivative works of the other party. Neither party may withhold the Confidential Information of the other party or refuse for any reason, including due to the other party's actual or alleged breach of this Agreement, to promptly return to the other party its Confidential Information, including copies, if requested to do so. Upon expiration or any termination of this Agreement and completion of a party's obligations under this Agreement, each party shall, except as otherwise provided in this Agreement return or destroy, as the owner may direct, all documentation in any medium that contains or refers to the other party's Confidential Information, and retain no copies, except for archival purposes and to evidence compliance with this Section 8.
 - 8.1.3 This Section 8 shall not apply to any particular information that either party can demonstrate (i) was, at the time of disclosure to it, in the public domain; (ii) was, after disclosure to it, published or otherwise becomes part of the public domain through no fault of the receiving party; (iii) was in the possession of the receiving party at the time of disclosure to it and was not the subject of a pre-existing confidentiality obligation; (iv) was received after disclosure to it from a third party who had a lawful right to disclose such information to it; (v) was independently developed by the receiving party without use of the Confidential Information of the disclosing party as evidenced by the receiving party's own records; or (vi) was required to satisfy any legal requirement of a competent governmental authority; provided that such party promptly, upon receiving any such request and prior to making the disclosure, advised the other party and took action to ensure confidential treatment of the Confidential Information.
 - 8.1.4 Nothing contained in this Section 8 shall be construed as obligating a party to disclose its Confidential Information to the other party, or as granting to or conferring on a party, expressly or impliedly, any rights or license to the Confidential Information of the other party. In any event, Client agrees that the general fact that it is receiving Services from Resource Synergy and the general nature of the Services performed for Client by Resource Synergy are not Confidential Information.
- 8.2 **Proprietary Rights.**
 - 8.2.1 **Resource Synergy Information.** Client acknowledges the methods, procedures, programs, content, documentation, reports, performance results and know-how that Resource Synergy employs to deliver the Services are confidential and proprietary to Resource Synergy and provide it with a

commercial advantage in the performance of services and shall remain the sole and exclusive property of Resource Synergy. Client shall not use or disclose information regarding the Services except as permitted in this Agreement.

8.2.2 **Client Information.** All Client Information is confidential and shall remain the sole and exclusive property of Client; provided that Resource Synergy may retain and use statistical, aggregated Client Information to incrementally improve and develop the Services and to create statistical marketing studies, research, products or strategic planning regarding the Services; provided that such studies, research, products or plans do not specifically identify Client.

9.0 **Notice.** All notices that either party may desire or be required to give to the other shall be in writing and shall be delivered to the address set forth herein and shall be deemed to be delivered three (3) days after deposit in the United States Mail.

10.0 **Savings.** For the purposes of shared savings and savings guarantees, Savings will be calculated utilizing the following methods based upon the type of waste services provided by Hauler:

- 10.1 **Baseline:** Client and Resource Synergy will agree to a baseline, specified in Site Service agreement, and/or amending documents. The baseline will be used for the duration of the agreement to calculate savings as follows: $\text{baseline cost} - \text{current cost} = \text{savings}$
- 10.2 **Adjustments to Baseline:** The baseline will be adjusted if a change occurs in (i) the municipal waste hauling rates impacting the site, (ii) there is an increase or decrease in the occupancy rate, business volume, or available square footage of the property, or (iii) the property is deemed to be a different occupancy classification. In any of the above instances, the baseline will be adjusted proportionally. Additionally, the cost associated with any new services requested by Client or required by law, not present during the baseline period, will be added to the baseline cost.
- 10.3 **Savings Guarantee:** Unless specified in the Term Summary, Resource Synergy makes no representation or warranty regarding Savings for Services.
- 10.4 **Recycling Rebates:** Adjustments to recycling rebates will qualify as Savings. If a rebate was not provided prior to program initiation, Savings will include the entirety of recycling rebate received. If a rebate was paid prior to program, Savings will be calculated by subtracting the average price per ton in the 12 months preceding the term from the current price per ton.
- 10.5 **Savings Disputes:** Failure to dispute Savings claimed in writing, within 14 days, shall be considered acceptance of the Savings calculation

11.0 General.

- 11.1 **Assignment.** Neither party may assign this Agreement without the prior written consent of the other party, unless to a successor which acquires all or substantially all of the assets and liabilities of the assignor and assumes in writing the obligations of this Agreement.
- 11.2 **Resource Synergy Affiliates.** Resource Synergy may share Confidential Information with its Affiliates in order to develop value-added services, for Client; provided that Resource Synergy shall not be relieved of its duty to perform any of its obligations under this Agreement, and each Affiliate with access to Confidential Information shall be bound by the confidentiality obligations described in Section 8 of this Agreement.
- 11.3 **Publicity.** The parties agree to do an initial press release (the "Release") if requested by either party. In the Release, Resource Synergy may use Client's name, logos, marks and information specific to Client and the Services. Resource Synergy will draft the Release and provide to Client for review and comment. During the Term, Resource Synergy may, through any media, use Client's name, logos, marks and other relevant information specific to Client and the Services in press releases, promotional materials, case studies or lists (the "Publicity"); provided that Resource Synergy shall include protective legends necessary to protect Client's rights in and to its trademarks, service marks or copyrighted materials. Resource Synergy will draft the Publicity and provide to Client for its prior written approval, which will not be unreasonably withheld.
- 11.4 **Delegation.** Resource Synergy may retain third parties to provide goods or services in connection with the performance of the Services and may share Confidential Information with such third parties; provided that such delegation shall not relieve Resource Synergy of its duty to perform any of its obligations under this Agreement, and any such third party with access to Confidential Information shall be made to enter into a confidentiality and non-disclosure agreement with obligations that are no less restrictive than those obligations described in Section 8 of this Agreement.
- 11.5 **Dispute Resolution/Waiver of Jury Trial.** The parties will make good faith efforts to resolve any dispute under this Agreement before pursuing arbitration or litigation. All negotiations under this Agreement are confidential and will be treated as compromise and settlement negotiations for purposes of evidentiary rules. In the event of any legal proceeding arising out of or relating to this Agreement, the prevailing party shall be entitled to recover its reasonable legal fees and costs, including reasonable expert fees and costs. If the prevailing party rejected a written settlement offer that exceeds its recovery, the offering party will be entitled to its reasonable legal fees and costs.
- 11.6 **Governing Law; Venue.** This Agreement shall be governed by the law of the State of Washington without reference to its rules relating to choice of law. Venue shall be in Spokane County.
- 11.7 **Severability.** If any provision of this Agreement is held invalid for any reason, the remaining provisions of this Agreement shall remain valid and enforceable, and the parties shall substitute a valid provision for the invalid provision, which most closely approximates the intent and economic effect of the invalid provision.
- 11.8 **Modification; Waiver.** No amendment or modification of this Agreement shall be effective unless made in writing, signed by the authorized representative of each party, and delivered to each party at the address provided for notice. The failure of either party to require performance of any provision of this Agreement shall not affect the right to require the performance at a subsequent time. The waiver by either party of a breach of any provision of this Agreement shall not be taken as a waiver of such provision. This Agreement shall not be amended or limited by any course of performance.
- 11.9 **Independent Contractors.** The parties to this Agreement are independent contractors, and do not intend by this Agreement to create a relationship of partners, joint ventures, or any other association for profit between them. Except as expressly provided for in this Agreement, each party shall bear its own costs and expenses associated with performing its obligations.
- 11.10 **Force Majeure.** Except for the payment of monies when due and owing, for the period and to the extent that a party is unable to perform, in whole or in part, its obligations under this Agreement, where such inability arises by reason of any court order, law, regulation or agency rule or other governmental action or inaction, war, terrorism, riot, strike, lockout, labor dispute, explosion, fire, storm, wind, drought, flood, earthquake, volcanic eruption or other natural catastrophe or act of God (a "Force Majeure Event"), such party shall be temporarily excused from its obligations that are so prevented until the abatement of such Force Majeure Event; provided that such party uses its best efforts to promptly overcome or mitigate the delay or inability to perform. The term of this Agreement shall not be extended by the period of duration of such Force Majeure Event. Notice of any such inability and abatement shall be promptly given to the other party.
- 11.11 **Entire Agreement.** The above Service Agreement and these attached Terms and Conditions constitute the entire agreement of the parties and supersede all prior written or oral agreements or understandings between the parties with respect to the subject matter of this Agreement.
- 11.12 **Title.** Client acknowledges that Resource Synergy will never be considered an owner, bailee or hauler of the Waste Material and no point shall Resource Synergy assume title to the Waste Material. Notwithstanding anything to the contrary set forth in this Services Agreement or otherwise, title to and liability for any Excluded Waste shall remain with Client and shall at no time pass to Resource Synergy.

Exhibit 1: Scope of Work

1. Waste Characterization
 - 1.1. Resource Synergy will design and deploy a process to sort and categorize Waste and Recycling materials.
 - 1.2. Resource Synergy will sort materials into up to 12 categories.
 - 1.3. Resource Synergy will capture weight and volume measurements for each material category.
 - 1.4. Resource Synergy may select a representative sample if volume available is greater than 8 cubic yards.
 - 1.5. Sorting may occur at the Client's site
 - 1.6. If sorting occurs off-site, Resource Synergy will arrange for a sorting site and facilitate container transport.
 - 1.7. Resource Synergy will present results in a MS PowerPoint presentation utilizing graphs, charts, and pictures.
 - 1.8. Resource Synergy will present recommendations for materials to target.

2. Recycling Program Implementation
 - 2.1. Resource Synergy will design and implement a comprehensive recycling program intended to maximize waste diversion and minimize contamination. This includes:
 - 2.1.1. Bin selection
 - 2.1.2. Janitorial procedures
 - 2.1.3. Signage
 - 2.1.4. Training (see Staff Training and Education)
 - 2.2. Resource Synergy will support the program through the duration of this agreement. This includes:
 - 2.2.1. Program modifications for tenant move-in/move-out
 - 2.2.2. Monitoring monthly bills for extra charges
 - 2.2.3. Addressing and resolving questions from tenants, janitorial, and haulers

3. Equipment Rental
 - 3.1. Resource Synergy will furnish equipment and containers denoted above as Equipment Provided.
 - 3.2. Resource Synergy will maintain a database all equipment provided and Original Retail List Price.
 - 3.3. Client will pay rental fees denoted in equipment table.
 - 3.3.1. At any point during the Agreement Term, Client may purchase equipment from Resource Synergy for a price calculated as follows:
Purchase Price = (100- months installed)/100 * Original Retail List Price

4. Service Optimization
 - 4.1. Resource Synergy will identify opportunities to implement:
 - 4.1.1. New hauling services to capture Recyclable Materials
 - 4.1.2. By-product synergy relationships, directing waste materials to another business as a feedstock
 - 4.1.3. Service reductions based on diverted materials or existing over-serviced containers
 - 4.1.4. Hauling pricing changes including but not limited to base service fees, incremental charges, environmental/regulatory/fuel recovery fees
 - 4.1.5. Hauler changes to obtain better rates or service
 - 4.2. Resource Synergy will notify Client of any intended changes, and will address any Client concerns
 - 4.3. Resource Synergy will implement changes directly with Hauler or other vendor

5. Waste Prevention
 - 5.1. Resource Synergy will identify opportunities to prevent waste from occurring through purchasing and operational changes
 - 5.2. Resource Synergy will notify Client of any intended changes, and will address any Client concerns
